Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the GrapeTree/annLeo 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Basis for Opinion

As further discussed in Note 4 to the financial statements, the Plan Administrator of the GrapeTree/annLeo 401(k) Retirement Savings Plan elected on July 14, 2024 to terminate and liquidate the plan. As a result, the GrapeTree/annLeo 401(k) Retirement Savings Plan changed its basis of accounting from the ongoing basis of accounting to the liquidation basis of accounting used in presenting the 2024 and 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the GrapeTree/annLeo 401(k) Retirement Savings Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the GrapeTree/annLeo 401(k) Retirement Savings Plan (the “Plan”) is provided for general information purposes only. More complete information regarding the Plan’s provisions may be found in the Plan document.

General

The Plan is a defined contribution plan established by GrapeTree Medical Staffing, LLC, (the “Company”) under the provision of Section 401(a) of the Internal Revenue Code (“IRC”), which includes a qualified cash or deferred arrangement as described in section 401(k) of the IRC, for the benefit of eligible employees of the Company. All employees not classified by the Company as a highly compensated employee or a field staff employee, as defined, are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan was originally adopted November 15, 2017, but has been amended subsequent to that date.

Participant Accounts

Individual accounts are maintained for each of the Plan’s participants to reflect the participant’s contributions, employer matching contributions and related allocation of profit-sharing contributions, forfeitures of terminated participants non-vested accounts, charged with an allocation of administrative expenses and debited with withdrawals, as well as the participant’s share of the Plan’s income and any related administrative expenses. Allocations of income and expenses are based on the proportion that each participant’s account balance bears to the total of all participant account balances.

Contributions

Prior to the Plan’s termination, eligible employees could contribute in any amount up to the maximum percentage of compensation and dollar amount as defined by the Plan, subject to certain limitations under the IRC. The Company provided an employer matching contribution equal to 50 percent of each participant’s contribution up to a maximum of 8 percent of the participant’s compensation and an additional profit-sharing contribution, which could be made on a discretionary basis, which is dependent on the Company’s operating results. The participant contributions and the Company employer matching and profit-sharing contributions could be allocated to the investment alternatives made available by the Company, as defined, as the participant directs.

Vesting

Prior to the Plan’s termination, participants were immediately vested in their contributions and the earnings thereon. Vesting in employer contributions and the earnings thereon was based on years of service. A participant was 100% vested after 3 years of credited service.

As a result of the termination, all employer contributions are automatically vested.

NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

Payment of Benefits

On retirement, death, disability, or termination of service, a participant (or participant's beneficiary in the event of death) may elect to receive a lump-sum distribution equal to the participant's vested account balance or a joint and survivor annuity. A participant with a vested account balance of \$999 or less will receive a lump-sum distribution equal to the vested value of their account as soon as administratively feasible following the participant's employment termination date without the participant's consent.

Notes Receivable – Participant Loans

Prior to the Plan's termination, participants could borrow from their fund accounts up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The minimum amount that could be borrowed was \$1,000. The loans were secured by the account balance. Repayments of the loans were made in substantially equal payroll deductions amortized over the life of the loan.

Forfeited Accounts

Forfeitures of non-vested Company employer matching contributions were used for the reduction of future Company employer matching contributions, as defined by the Plan. There was no balance of forfeited non-vested accounts at July 14, 2024.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

As a result of the decision to terminate the Plan effective July 14, 2024, and in accordance with U.S. generally accepted accounting principles ("U.S. GAAP"), the Plan's financial statements as of July 14, 2024 and December 31, 2023 and for the period of January 1, 2024 through July 14, 2024, are presented using the liquidation basis of accounting. For periods prior to the decision to terminate the Plan, the financial statements were prepared using the ongoing basis of accounting.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

Under the liquidation basis of accounting, assets are stated at their estimated net realizable cash value and liabilities are stated at their anticipated settlement amounts. There are no material changes to the 2024 or 2023 financial statements as a result of the change under the liquidation basis of accounting.

Investment Valuation and Income Recognition (continued)

All investments of the Plan are stated at fair value (the estimated net realizable cash value for investments as of July 14, 2024 and December 31, 2023 are equivalent to fair value), except for the fixed annuity contract, which is valued at contract value. Contract value is the relevant measure for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transaction under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes both realized and unrealized gains and losses on investments.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable – Participant Loans

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying statement of changes in net assets available. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3 – FAIR VALUE MEASUREMENTS

ASC topic *Fair Value Measurements and Disclosures* provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

NOTE 3 – FAIR VALUE MEASUREMENTS (CONTINUED)

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to valuation methodology are unobservable and significant to the fair value measurement. Valuation is generated from model-based techniques that use significant assumptions not observable in the market. These unobservable assumptions would reflect our own estimates of assumptions that market participants would use in pricing the asset or liability. Such valuation techniques include the use of option pricing models, discounted cash flow models and similar techniques.

The asset or liability's fair value measurement level within the hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at July 14, 2024 or December 31, 2023.

Fixed Income Funds: The fair value of fixed income funds is based on the quoted net asset values of the shares held by the Plan at year-end.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – PLAN TERMINATION

Effective July 14, 2024 the Plan Administrator elected to terminate the plan and liquidated the Plan. Effective with the Plan's termination, all participants with an account balance remaining in the Plan became fully vested in all contribution sources, regardless of status or years of vested service. The Plan's termination also ceased employee and employer contributions into the Plan and ceased new participant notes receivable from the Plan.

NOTE 5 – TAX STATUS

The plan sponsor adopted a Prototype Non-standardized Safe Harbor Profit Sharing Plan, for which a letter from the Internal Revenue Service has been received indicating that an employer who adopts this prototype plan will be considered to have a plan qualified under applicable sections of the Internal Revenue Code (IRC). The plan sponsor has elected not to request a separate determination letter for the Plan. The plan sponsor and the plan's administrator believe that the Plan is currently designed and being operated in compliance with applicable requirements of the IRC. Therefore, they believe the Plan was qualified as of the financial statement date.

NOTE 5 – TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of July 14, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 – RELATED PARTY TRANSACTIONS

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses. Investment related expenses are included in net appreciation of the fair value of investments. The Plan Sponsor provides certain accounting, recordkeeping, and administrative services to the Plan, for which it received no compensation. Certain Plan investments are shares of fixed income funds managed by Empower Investments, an affiliate of the Plan's trustee, and the Plan makes loans to participants and charges the participants a fee for each loan. These transactions qualify as party-in-interest transactions. The Trustee and affiliates of Empower Investments maintain and manage the fixed income funds in the Plan for which they receive management fees. These management fees are part of the annual operating expenses of each fund and result in a reduction of earnings from investments.

NOTE 7 – INFORMATION CERTIFIED BY THE PLAN'S TRUSTEES (UNAUDITED)

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, the Trustees have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.
