Management has obtained certifications from qualified institutions as of and for the year ended December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. DESCRIPTION OF THE PLAN

The following description of The Pines at Davidson, Inc. 403(b) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan maintained under Section 403(b) of the Internal Revenue Code (IRC) and covers substantially all salaried and hourly employees of The Pines at Davidson, Inc. (the "Company"). The Plan was established effective June 1990.

The Board of Directors of the Company controls and manages the operation and administration of the Plan. Charles Schwab Trust Company, a division of Charles Schwab Bank, ("Charles Schwab") serves as the asset custodian of the Plan. All but three of the approximately 240 Plan participants who participated in the Plan since its inception have maintained annuity contracts with The Variable Annuity Life Insurance Company (VALIC) for contributions made to the Plan prior to 2009. Three Plan participants have elected to maintain 403(b) accounts with Vanguard Fiduciary Trust Company ("Vanguard") for contributions made to the Plan from June 30, 1993, through October 2008. Effective October 2008, additional contributions cannot be made to VALIC and Vanguard. Effective November 8, 2017, Vanguard outsourced the remaining participants' accounts to the Newport Trust Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility – Employees are eligible to begin participating in the Plan on their date of hire for purposes of making elective compensation deferrals into the Plan. Employees are eligible to participate in the Plan for the purpose of sharing in Employer Discretionary Contributions after completion of one year of service. A year of service is defined by the Plan as working at least 1,000 hours in a twelve-month period.

Contributions – Employees become eligible to make elective deferrals into the Plan upon their employment and may contribute each year up to 100% of their pretax compensation, as defined in the Plan, and subject to certain IRC limitations. Employees who are at least age 50 by the end of a Plan year are also eligible to make additional elective deferrals as catch-up contributions that year from their compensation, subject to IRC limitations. The Company may also make discretionary employer contributions to the Plan. The Company made discretionary employer contributions of \$244,388 for the year ended December 31, 2024. The Company did not begin making discretionary employer contributions to the Plan participants until the Plan year ended December 31, 1993, but has made such discretionary employer contributions each year since such time. Notwithstanding this past experience of having made discretionary employer contributions to the Plan each year since 1993, there is no guarantee that the Company will elect to make such discretionary employer contributions in the future, and if it does elect to make discretionary employer contributions, such discretionary employer contributions may be in amounts reduced from prior-year contributions. Employees are eligible to participate in the Plan for the purposes of sharing in discretionary employer contributions after completing one year of service, as defined in the Plan. After meeting that eligibility requirement, a participant is eligible to share in a discretionary employer contribution for a Plan year if the participant had at least 1,000 hours of service during the year and was employed by the Company on the last day of the Plan year. Participants may make certain rollover contributions to the Plan from other retirement plans or individual retirement accounts. Participants may also contribute amounts representing distributions from another qualified defined benefit or defined contribution plans.

Participant Direction of Investments – Participants may direct the investment of their account balances under the Plan. The Custodians will invest the participant's account balance under the Plan in accordance with their direction. Participants may modify their investment options daily.

Participant Accounts – Each participant's account is credited with the participant's contribution and related Company matching contribution, and plan earnings. Participant accounts are also charged with an allocation

of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service.

Notes Receivable from Participants – Effective October 31, 2008, participants could not originate loans. As of December 31, 2024 and 2023, loans outstanding which were initiated prior to October 31, 2008, totaled \$0 and \$4,556, respectively. The loans are secured by the balance in the participants' accounts and bear interest at rates commensurate with the local prevailing rates at the time the funds were borrowed.

Payment of Benefits – Upon death, retirement, disability, financial hardship or termination of employment, a participant or his or her beneficiary may elect to receive a lump sum payment, partial payments, installment payments, annuity contract, or may elect to rollover the asset balance directly into an IRA or into another qualified Plan sponsored by an employer.

Administrative Expenses – The Company pays certain expenses of the Plan, including legal, accounting and administrative fees. Fees resulting from individual participant transactions, such as loan origination and benefit payments, or certain investment elections, are paid by the participant and are included in the fee amount on the statement of changes in net assets available for benefits.

Termination of the Plan – Although the Company has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan should be terminated, participants' account would become fully vested, and all remaining Plan assets would be allocated to the participants as described in the full text of the Plan.

Forfeited Accounts – Forfeitures occur upon termination of employment by a participant who is not fully vested in the Plan. Forfeiture amounts are used to reduce administrative expenses. As of December 31, 2024 and 2023, forfeited accounts totaled \$0.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Presentation – The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodians. See Note 3 for discussion of fair value measurements.

Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the

amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants is measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan documents.

Contributions – Contributions are reported in the year services are rendered to the Company by the Plan participants.

Payment of Benefits – Benefits are recorded upon distribution.

Administrative Expenses – The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions are charged directly to the participant's account.

Date of Management's Review – Subsequent events have been evaluated through April 23, 2025, which is the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds – Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

Money market funds – The Plan invests in certain money market funds for which quoted prices are not available in active markets for identical instruments. The Plan utilizes the NAV of units, as determined by Charles Schwab Trust Company and Newport Trust Company, custodians, as the estimated fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan holds guaranteed investment contracts with the Variable Annuity Life Insurance Company, a custodian of the Plan. These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for a fully benefit-responsive investment contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The following represents the disaggregation of contract value between types of investment contracts held by the Plan.

The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The contracts added interest at rates of 2.75% and 3.25% as of December 31, 2024 and 2023, respectively.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include the following: (1) amendments to the plan document (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) premature termination of the contracts, (4) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (5) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material

obligation under the contract, (3) a material representation or (4) a material amendment to the agreements without the consent of the issuer.

5. INFORMATION CERTIFIED BY CUSTODIANS

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Company, The Variable Annuity Life Insurance Company, Vanguard Fiduciary Trust Company and Newport Trust Company, the custodians of the Plan, have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investments, at fair value
- Net appreciation in fair value of investments
- Interest and dividend income
- Schedule of Assets (Held at End of Year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

6. RELATED PARTIES

The Plan invests in funds managed by the Plan's custodians. The income from the Plan is derived from these funds; therefore, these transactions qualify as party-in-interest transactions.

7. TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the IRC. The terms of the Plan have been prepared to conform to the sample language provided by the Internal Revenue Service (IRS) in Revenue Procedure 2007-71. The Plan administrator intends to apply for a determination letter on the Plan once the IRS opens such a program. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for Plan participants under Section 403(b). The Plan administrator believes that the Plan is currently designed and operating in accordance with the applicable requirements of Section 403(b) of the IRC and, therefore, believes the Plan is qualified and the related custodial accounts are tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan Management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan Management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
