### Note A – Description of Plan

The following description of the Carrollwood Day School 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution savings plan covering substantially all employees of Carrollwood Day School (the “Organization” or the “Employer”). The Plan was established March 1, 1999 and most recently restated effective August 1, 2022, to bring the Plan into compliance with Internal Revenue Service (“IRS”) Notice 2017-37. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Employees who have attained age 21 are eligible to participate in the Plan. Excluded employees not eligible to participate in the Plan are union employees, nonresident aliens and part-time, temporary, and seasonal employees. Part-time, temporary, and seasonal employees who entered the Plan prior to February 1, 2018 are not considered excluded employees. Eligible employees may enter the Plan the first day of each month upon satisfaction of eligibility requirements.

#### Administration of the Plan

The accounting records are maintained by a third party administrator hired by the Organization. The Plan’s assets were held and managed by Principal Trust Company (the “Custodian”) for the periods ended July 31, 2024 and 2023. Contributions were held by the Custodian for the above noted period, who invest cash received, interest and dividend income, as directed by the participant, and makes distributions to participants.

#### Contributions

Participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, subject to Internal Revenue Code (IRC) limitations. The maximum participant deferral for July 31, 2024, was \$22,500. A participant who has attained the age of 50 may also make catch up contributions, subject to IRS limitations of \$7,500 for July 31, 2024. Participants may also contribute amounts representing distributions from other qualified plans as well as after-tax Roth contributions.

The Organization may make matching contributions at its discretion as a percentage of the participant’s elective deferrals to the Plan. For the period ended July 31, 2024, the Organization matched contributions depends on the years of service as follows:

Years of Services	Percentage of Compensation
Less than 5	5%
5-10	5.5%
More than 10	6%

Participants direct the investment of their contributions and Employer contributions into various investment options offered by the Plan.

#### Participant Accounts

Each participant’s account is credited with the participant’s contribution and the Organization’s matching contribution and performance sharing amounts, if applicable. Each participant’s account shall be allocated earnings, gains, expenses, and losses based on participant earnings or account balances, as defined in the Plan agreement.

### Note A – Description of Plan (continued)

#### Vesting

Participants are fully vested in their elective contributions, as well as any rollover contributions plus or minus any earnings or losses thereon. Participants are immediately vested 100% in any Employer contributions.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant notes receivable. Generally, the term of notes receivable from participants may not exceed five (5) years. However, if the loan is for the purchase of a principal residence, the Administrator may permit a longer repayment term. These loans are collateralized by the balance in the participant's account and bear interest at prevailing rates as determined by the Plan Administrator. Principal and interest are paid by payroll deduction in substantially equal payments over the life of the loan.

The Plan Administrator shall consider a loan in default if any scheduled repayment remains unpaid as of the last business day of the calendar quarter following the calendar quarter in which a loan is initially considered past due. If participants become entitled to a distribution from the Plan, their loan becomes due and payable in full immediately. Participants may repay the entire outstanding balance of the loan (including any accrued interest). If participants do not repay the entire outstanding loan balance, their vested account balance will be reduced by the remaining outstanding balance of the loan. In some cases, participants may request a direct rollover of the loan note to another qualified retirement plan.

#### Distribution of Benefits

Upon termination of service due to death, disability, retirement or termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or installments paid over various periods, as defined in the Plan agreement, less any applicable taxes. Participants with less than \$5,000 in their account are automatically distributed upon termination. Participants may request an in-service distribution upon attaining age 59 ½ or as a qualified reservist. Benefits may be received when a participant demonstrates a situation of financial hardship as defined by the IRC.

#### Forfeitures

Forfeited balances of non-vested accounts may be used to pay administrative expenses of the Plan. Forfeitures of matching contributions that are not used to pay Plan expenses are used to reduce future Employer contributions. During 2024, no forfeitures were used to reduce the employer contributions and Plan expenses from forfeited non-vested accounts. As of July 31, 2024 and 2023, there was no outstanding balance that could be used to pay administrative expenses or offset future Organization contributions.

#### Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, each participant's account will become fully vested and non-forfeitable. All appropriate accounting provisions of the Plan will continue to apply until the accounts of all participants have been distributed.

### Note B – Summary of Significant Accounting Policies

#### Basis of Presentation

The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“US GAAP”).

#### Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and the changes in net assets available for benefits and disclosure of contingent assets and liabilities during the reporting period. Actual results could differ from these estimates.

#### Valuation of Investments

The Plan’s investments are stated at fair value, except for the fully benefit-responsive investment contracts, which are reported at contract value as described in Note G. Fair value is based on quoted market prices at year-end as reported by the Custodian. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### Fair Value Measurements

The FASB has established a framework for measuring fair value in ASC 820 *Fair Value Measurements*. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described below:

#### Fair Value Measurements (continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at July 31, 2024 and 2023.

*Common/collective trusts:* Valued at net asset value (“NAV”) provided by the record keeper. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the trust, minus its liabilities, divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There were no unfunded commitments to purchase investments at July 31, 2024 and 2023, respectively. Participant-directed redemptions have no restrictions and are recorded at the end of every business day. These investments are direct filing entities.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Valued at NAV provided by the custodian. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the trust, minus its liabilities, divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There were no unfunded commitments to purchase investments at July 31, 2024 and 2023. Participant-directed redemptions have no restrictions and are recorded at the end of every business day.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note C – Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including total investments and notes receivable from participants held at July 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended July 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate the Custodian, a qualified institution. As of July 31, 2024 and 2023, and for the year ended July 31, 2024, the Plan Administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by the Custodian, except for comparing such information to the related information included in the financial statements, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### Note D – Income Tax Status

The Plan has received a determination letter from the Internal Revenue Service dated June 30, 2020 for its prototype plan stating that the Plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is exempt from taxation. Subsequent to the issuance of the determination letter, the Plan was amended and the Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC. The Plan Administrator evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements. The Plan is no longer subject to examination by taxing authorities for years prior to 2021.

### Note E – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Note F – Party-In-Interest Transactions

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. Certain Plan investments managed by the Custodian are pooled separate accounts, common collective trusts and a guaranteed interested contract. Transactions related to these investments qualify as party-in-interest transactions. Fees paid to parties-in-interest by the Plan for services amounted to approximately \$66,000 during the year ended July 31, 2024.

### Note G – Fully Benefit-Responsive Investment Contracts

The Plan is invested in a fully benefit-responsive investment group fixed income annuity contract (the “Fund”). The Fund is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. As described in Note B, because the fixed income annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the fixed income annuity contract. The investments are included in the financial statements at contract value as reported to the Plan by the Fund. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The fixed income annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan,) (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures of spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transactions exempt under ERISA. The Plan Administrator does not believe that any events which would limit the Plan’s ability to transact at contract value with participants are probable of occurring. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

### Note H – Subsequent Events

Subsequent events have been evaluated through May 7, 2025, which is the date the financial statements were available to be issued.
