Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in my judgement, there are conditions of events, considered in the aggregate, that raise substantial doubt about A-Del Construction Company, Inc 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

My audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

I am required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control – related matters that I identified during the audit.



(1) Plan Description

The following description of the A-Del Construction Company, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

(a) General

The Plan is a participant-directed, defined contribution plan established by A-Del Construction Company, Inc, Colonial Trucking, Inc. and Middletown Materials, LLC (the Companies or Plan Sponsor) effective August 1, 1985 who are not covered by a collective bargaining agreement. Who have reached the age of twenty-one and have completed twelve months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The general administration of the Plan and the responsibility for carrying out the provisions of the Plan are maintained by a committee (the Committee) appointed by the Company. In accordance with the provisions of the Plan, the Newport Management Trust Company is acting as the Trustee and Plan Administrator. The Administrator maintains participant account records and executes transactions such as benefit payments to participants. The Trustee holds the assets of the Plan and executes transactions at the direction of the Plan Committee. The Trustee also reports to the Plan's management regarding investments and changes in these investments.

(b) Employee Contributions

Each year participants may contribute up to 100% of pretax annual compensation as defined in the plan, subject to the limitations under applicable provisions of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). The Companies make safe harbor matching contributions based upon a percentage of participant deferrals and their compensation. The Companies may also make discretionary profit-sharing contributions. For the year ended July 31, 2024, the employer safe harbor matching contributions totaled \$347,624 and there were no discretionary profit-sharing contributions. Participants direct the investment of their contributions into various investment options offered by the plan.

(c) *Participants' Accounts*

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution, allocations of investment income or loss and forfeitures of terminated participants' nonvested accounts and charged with an allocation of administrative expenses. Allocations are based on participant earnings or accounts balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their account balances into various investment options offered by the Plan.

(d) *Vesting*

Participants are immediately vested in their voluntary contribution plus actual earnings or losses thereon. Vesting in the Company's matching contribution and profit sharing portion of their accounts plus actual earnings or losses thereon is based on years of continuous service. A participant is 20% vested after two years and vests 20% per year thereafter, and thus, is 100% vested after six years of service, as defined.

(e) *Payment of Benefits*

Upon reaching normal retirement (age 65 or age 55 with 10 years of vested service, as defined) or upon permanent disability, all vested amounts credited to a participant's account become distributable. Distributions will be made as soon as administratively feasible, following a participant's request. Participant's whose vested interest is less than \$5,000 will be paid in a single lump sum payment, while a participant whose vested interest exceed \$5,000 will be paid in the form of an annuity unless the annuity option is waived. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan

Upon a participant's death, the participant's beneficiary is entitled to 100% of the participant's vested account balance.

Upon termination of service, other than for normal retirement or death, the Administrator will direct the current Trustee to pay to the participant his or her benefit in an immediate lump sum or a deferred lump sum, if certain criteria are met.

(f) Forfeitures

Upon a participant's termination date, and prior to the time the participant becomes vested in his or her account, the non-vested portion, if any, shall be forfeited. These forfeitures will be used to offset future Company contributions.

(g) Administrative Expenses

All administrative expenses are paid directly through the Plan and are allocated to the participants. Professional fees were paid by the Company. It is the Company's intention to pay for these fees in the future.

(2) Summary of Significant Accounting Policies

(a) Basis of Presentation

The accompanying financial statements have been prepared on an accrual basis and present the net assets available for plan benefits of the Plan and the changes in those net assets in conformity with accounting principles generally accepted in the United States of America.

(b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of changes in net assets available for plan benefits during the reporting period. Actual results could differ from those estimates.

(c) Risk and Uncertainties

The assets for the Plan are primarily financial instruments which are monetary in nature. As a result, interest rates have a more significant impact on the Plan's performance than do the effects of general levels of inflation. Interest rates do not necessarily move in the same direction or in the same magnitude as the prices of goods and services as measured by the consumer price index. Investments in funds are subject to risk conditions of the individual fund objectives, stock and bond market fluctuations, interest rate changes, economic conditions and world affairs.

(d) *Payment of Benefits*

Benefits are recorded when paid.

(e) *Investment Valuation and Income Recognition*

The Plan's investments in the common collective trust accounts are calculated by the fund manager based on the underlying investments. Quoted market prices of the underlying investments are used to value each fund and are based in the net asset value of the shares held by the Plan at the end of the year.

The Plan's investments in mutual funds are calculated by the net asset value available in an observable market.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

(f) *Fair Value Measurements*

Financial Accounting Standards Board(FASB) *Accounting Standards Codification*(ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Inputs are broadly defined as assumptions market participants would use in pricing an asset or liability. The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Shares of registered equity securities are valued at quoted market prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different instruments could result in a different fair value measurement at the reporting date.

(5) Party-In-Interest Transactions

Certain Plan investments were investments in mutual funds managed by the Newport Trust Company who was also the custodian of the Plan. Therefore, these transactions qualify as party-in-interest transactions.

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Company were to terminate the Plan, all participants in the Plan would become fully vested.

(7) Tax Status

The Company adopted a non-standardized prototype plan provided by the Trustee, who received an IRS opinion letter which stated that the Plan, as designed, is in compliance with the applicable section of the Code. The Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Service Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

(8) Subsequent Events

The Plan Administrator has evaluated subsequent events through May 7, 2025, the date the financial statements were available to be issued.
