Independent Auditors' Report

The Investment and Retirement Committee of S/A/R Academy 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the S/A/R Academy 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of August 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended August 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of August 31, 2024 and 2023 and for the year ended August 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

Basis for Opinion

1. Description of Plan

The following description of the S/A/R Academy 401(k) Plan (the "Plan") provides general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees who have completed at least one year and one day of employment with Salanter Akiba Riverdale Academy (the "Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The effective date of the Plan was September 1, 1982.

The assets of the Plan were transferred from Voya Retirement Insurance and Annuity Company to Charles Schwab Trust Bank on July 16, 2024.

Contributions

Under the provisions of the Plan, the Employer makes contributions to the Plan accounts based on a percentage of each employee's annual salary. Employer contribution varies between 2.5% and 8.5% depending on years of service. These are discretionary contributions (matching and profit-sharing) which may be credited to the participants' accounts at the end of a Plan year. The Employer contribution is provided to all employees who completed at least one year of service and worked 900 hours in a given 12-month eligibility period with the Employer.

Participants may enter into a salary reduction agreement with the Plan to have a portion of their salaries deferred in an amount not to exceed the annual Internal Revenue Code (the "Code") limit. Additionally, eligible employees making elective deferrals that have reached the age of 50 before the close of the Plan year are eligible to make catch-up contributions.

Participants may receive a matching contribution, subject to the Employer's discretion, if the employee makes a salary reduction contribution to the Plan. For the year ended August 31, 2024, the Employer did not contribute a matching contribution. For the year ended August 31, 2024, Employer discretionary profit-sharing contributions amounted to \$1,596,255, net of forfeitures.

The amount of contributions allocated to any participant during any Plan year may not exceed the lesser of:

- a. \$69,000 for 2024 and \$66,000 for 2023, or such maximum amount allowable in accordance with the Code, or
- b. 100% of the participant's compensation for such Plan year.

1. Description of Plan (*continued*)

Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon such termination, participants would become 100% vested in their Employer contributions.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's contribution, and (b) Plan earnings (losses). Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon.

Vesting in the Employer's contribution is based on years of continuous service. Additionally, participants are automatically 100% vested in the Employer's contributions if they retire from the Employer after reaching the age of 65 or if they reach the age of 55 (early retirement date for Employer discretionary and matching contributions), become disabled or die while employed by the Employer.

Vesting for both Employer discretionary profit-sharing and Employer matching contributions are based upon years of service as follows:

6 years or more	100%

Payment of Benefits

Upon retirement, death or disability, participants may, in accordance with the Plan provisions, elect to receive their participating interest in (a) a lump sum, or (b) monthly installments over a period not to exceed the joint life expectancy of the participant and spouse.

Expenses

Certain expenses of administering the Plan are paid directly by the Employer and are excluded from these financial statements. Investment related expenses are included in net appreciation in value of investments.

1. Description of Plan (*continued*)

Revenue Credit Account

The Plan and Voya Retirement Insurance and Annuity Company (“Voya”) entered into a revenue sharing arrangement whereby a portion of the revenue earned from certain funds is passed through to the Plan. In order for the Plan to receive credits as a result of this revenue sharing arrangement, the Plan created the Revenue Credit Account under the Plan. The Revenue Credit Account is a cash account within the Plan and is used to record the redistribution of plan-generated fund revenue that exceeds the costs associated with plan administration. The Revenue Credit Account balance was \$32,967 at August 31, 2023. During 2024, expenses of \$20,600 were paid from the Revenue Credit Account and no amounts were allocated to participants of the Plan. The Plan was not invested in the Revenue Credit Account at August 31, 2024.

Notes Receivable from Participants

Participants may borrow from their accounts up to a maximum amount equal to the lesser of (i) \$50,000 or (ii) 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at prime rate plus 1%. Loans must be repaid within a period not to exceed 5 years from the date the participant receives the loan, unless the loan is for the purchase of the participant's principal residence, in which case the loan must be repaid within 10 years. Repayment of principal and interest is made by semi-monthly payroll deductions.

Forfeitures

Forfeitures are used by the Employer to reduce future Employer contributions. At August 31, 2024 and 2023, forfeited non-vested accounts totaled \$18,614 and \$13,962. During 2024, Employer contributions were reduced by \$14,623 from forfeited non-vested accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the Net Asset Value (“NAV”) per share as a practical expedient are not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

All of the investments of the Plan are stated at fair value except for the Voya Fixed Account, which is stated at contract value. Investments in separate accounts are reported at the value reported to the Plan by the insurance company, which represents the approximate fair value of the underlying investments comprising the accounts. The Voya Fixed Account is reported at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Mutual funds and the cash equivalent held by the Plan are valued at fair value based on the daily closing price as reported by the funds and are deemed to be actively traded. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily net asset value and to transact at that price and are deemed to be actively traded. The common/collective trust is valued at the NAV of units held by the Plan. The NAV, as provided by the trustee of the trust, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is accrued when earned. Net appreciation in value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded upon a distributable event.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date the financial statements were available to be issued, which date is May 12, 2025.

3. Information Certified (Unaudited)

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year), including investments held at August 31, 2024 and 2023, and net appreciation in value of investments and interest and dividend income for the year ended August 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya and Charles Schwab Trust Bank, qualified institutions.

Voya held the Plan's assets as of August 31, 2023 and executed investment transactions from September 1, 2023 to July 16, 2024 and Charles Schwab Trust Bank held the Plan's assets as of August 31, 2024 and executed investment transactions from July 17, 2024 to August 31, 2024.

4. Investments *(continued)*

Voya Fixed Account

The Voya Fixed Account (the “Account”) is a fully benefit-responsive investment contract with Voya. The Account guarantees principal and a guaranteed minimum interest rate for the life of the contract, as well as featuring two declared interest rates: a current rate, determined at least monthly, and a guaranteed minimum floor rate declared for a defined period – currently one calendar year. The guaranteed minimum floor rate may change after the defined period, but it will never be lower than the guaranteed minimum interest rate that applies for the life of the contract. The current rate, the guaranteed minimum floor rate and the guaranteed minimum interest rate are expressed as annual effective yields. Taking the effect of compounding into account, the interest credited to a participant’s account daily yields the then current credited rate. Voya’s determination of credited interest rates reflects a number of factors, which may include mortality and expense risks, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains and/or losses realized on the sale of invested assets. Under this option, Voya assumes the risk of investment gain or loss by guaranteeing the principal amount allocated to this option and promises a minimum interest rate during the accumulation period and also throughout the annuity payout period. Voya may impose limitations on the ability to transfer funds out of this investment option. Withdrawals from the Account for reasons other than the payment of benefits to participants may be subject to a market value adjustment and a surrender charge.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The Account is presented on the face of the statements of net assets available for benefits at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan’s ability to transact at contract value with participants, is probable. The Account is an obligation of Voya’s general account, which supports all of Voya’s insurance and annuity commitments. The Plan was not invested in the Account at August 31, 2024.

Common/Collective Trust

The Reliance Trust Company Stable Value Fund (the “Fund”) is a collective investment trust that was formed for the purpose of allowing plan sponsors of defined contribution plans qualified under Sections 401(a) and 501(a) of the Internal Revenue Code to invest in the MetLife Group Annuity Contract 25053 and MetLife Group Annuity Contract 37000. Both contracts were issued by Metropolitan Life Insurance Company to Reliance Trust Company, who is the trustee of the Fund. Units of the Fund are valued daily. Unit purchases and redemptions are transacted at the NAV determined as of the close of business each day. The NAV per unit is computed by dividing the total assets of the Fund, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned is reinvested in the Fund and included in the determination of unit values.

5. Plan Tax Status

On November 30, 2020, the Internal Revenue Service issued an opinion letter to the Prototype Document Preparer, as defined, indicating that the Plan, as then designed, qualifies under the Code Section 401(a). The plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions for periods since 2021; however, there are currently no examinations for any tax periods in progress.

6. Party-in-Interest Transactions

Certain Plan investments are managed by Charles Schwab Trust Bank. Charles Schwab Trust Bank is a custodian, as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Certain employees of the Employer may also participate in the Plan or perform administrative services to the Plan at no cost to the Plan.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statement of net assets available for benefits.

7. Delinquent Contributions

During the 2024 and 2023 Plan years, the Employer did not successfully transmit to the Plan certain participants' contributions totaling \$1,249 and \$1,251 within the period prescribed by Department of Labor regulations. Delays in remitting these amounts to the Plan were due to payroll processing errors. Plan management has remitted the participants' contributions and has calculated and remitted lost earnings to the Plan.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to August 31, 2024 are not reflected in these financial statements.
