## INDEPENDENT AUDITORS' REPORT

### **Report on the Audit of the Financial Statements**

#### ***Opinion***

We have audited the accompanying financial statements of Inland Empire Teamsters Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and plan's benefit obligations as of July 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and changes in plan's benefit obligations for the years July 31, 2024 and 2023, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and benefit obligations of Inland Empire Teamsters Trust as of July 31, 2024 and 2023, and the changes in its net assets available for benefits and changes in its benefit obligations for the years ended July 31, 2024 and 2023, in accordance with accounting principles generally accepted in the United States of America.

#### ***Basis for Opinion***

The Plan was formed August 1, 1966, as a result of a collective bargaining agreement between Associated Industries of the Inland Empire (representing industry employers) and Driver-Salesmen, Food Handlers, and Miscellaneous Salesmen Local 582 affiliated with the International Brotherhood of Teamsters. Effective March 1, 2000, Local 582 merged with Local Union No. 690, affiliated with the Joint Council of Teamsters No. 28, International Brotherhood of Teamsters, Chauffeurs, Warehousemen and Helpers of America. Also included in the Plan are members of various other unions and nonunion employees who are participants of the Plan as a result of special negotiation with certain employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. A Summary of Material Modifications (SMM) reflecting significant changes to the plan was issued in January 2024.

**Eligibility**

To establish eligibility, an employee must first meet the requirements established in the collective bargaining agreement with a participating employer. The number of hours an employee must work in each month to maintain eligibility depends upon the governing agreement. Employees must meet the eligibility requirements of a collective bargaining agreement in two calendar months within a nine-month period. Coverage begins the first day of the month immediately following the second month the eligibility requirements of the collective bargaining agreement are met and provided the required contributions for all two months are paid to the Plan. Once an employee becomes eligible, he or she shall continue to be eligible on a monthly basis, as long as the monthly eligibility requirements of the collective bargaining agreement are met, and the required employer contribution is paid to the Plan.

**Contributions**

Contributions are paid by employers on behalf of employees who have worked the minimum hours required to maintain eligibility. Contributions are also made by terminated and retired or disabled participants on their own behalf, as determined by the Board of Trustees based on the anticipated costs of providing benefits. The trustees adjust the benefit structure on a periodic basis to adequately fund the benefit programs, based on information from the consultants.

Employers' contributions are subject to audit, and any delinquent accounts are subject to liquidated damages. At any point in time, certain accounts are receivable by the Plan due to audit results and may be the subject of various disputes or legal actions. Such accounts receivable are recognized based on the ultimate collectability as determined by management.

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Benefits**

The Plan is self-insured and provides medical, supplemental dental, drug, vision, time-loss, death, and accidental death and dismemberment benefits for eligible participants and their dependents. Dental benefits are funded under an insurance agreement. The Plan has obtained stop-loss insurance coverage for benefits in excess of a specified threshold. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

**Administration of the Plan**

The Plan is administered by a Board of Trustees with assistance from a contract administration organization. Medical claims administration responsibilities are shared between Rehn & Associates, Inc. and Premera. Administrative expenses are borne by the Plan.

**Stop-Loss Coverage**

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities and benefit obligations at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Concentration of Credit Risk**

The Plan maintains its cash balances in high credit quality financial institutions. Accounts at each institution are insured by the Federal Deposit Insurance Corporation up to \$250,000. At times, cash balances may be in excess of the insured limits.

**Payment of Benefits**

Claims are recorded when paid by the Plan.

**Stop Loss**

Premiums for stop-loss insurance are included in premium payments in the accompanying statements of changes in net assets available for benefits. Stop loss refunds of approximately \$53,000 and \$463,000 have been netted with claims paid in the accompanying statements of changes in net assets available for benefits for the years ended July 31, 2024 and 2023, respectively.

**Refunds**

Refunds are recorded when earned. Refunds due as of the financial statement date are reported as a receivable, with the offset netted against claims paid. Refunds of approximately \$3,334,000 and \$1,682,000 were offset against claims paid for the years ended July 31, 2024 and 2023, respectively.

**Plan Benefits**

Plan obligations at July 31, 2024 and 2023 for liabilities for claims payable, incurred but unreported claims, and eligibility coverage were estimated by the Plan's administration. See Note 4 for estimation methods used to calculate these liabilities.

**Change in Accounting Policy**

The Plan has adopted the Financial Accounting Standards Board (FASB) Accounting Standards Update (ASU) 2016-13, *Financial Instruments - Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments*, effective August 1, 2023, utilizing the modified retrospective transition method. The accounting standard modifies the method for estimating credit losses on financial assets from probable or incurred credit losses to lifetime expected future credit losses (CECL). No cumulative effect adjustment to net assets available for benefits as of August 1, 2023, was necessary upon adoption.

**Reclassifications**

During the current year, certain amounts in the prior year financial statements have been reclassified to conform to the current year presentation. These reclassifications had no effect on the previously reported net increase in net assets available for benefits.

**Subsequent Events**

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through April 16, 2025, the date the financial statements were available to be issued.

**NOTE 3 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at July 31, 2024 and 2023.

*Short Term Funds and Mutual Funds:* Valued at the daily closing price as reported by the fund. The mutual fund held by the Plan is an open-end mutual fund that is registered with the Securities and Exchange Commission. The fund is required to publish its daily net asset value (NAV) and to transact at that price. The mutual fund held by the Plan is deemed to be actively traded.

**NOTE 4 BENEFIT OBLIGATIONS**

The Plan “self-funds” the benefits provided to participants. As of each July 31, there are many self-funded claims that have been incurred on which benefit payments will be made subsequent to that date. The liability for claims payable at July 31, 2024 and 2023 was estimated based on actual claims adjudicated prior to July 31 but paid after July 31. The liability for claims incurred but not reported at July 31, 2024 and 2023 was estimated using Plan provisions, the number of eligible participants, and the actual lag patterns of the Plan as well as industry-wide factors. These amounts are paid by the Plan only if claims are submitted and approved for payment. The estimated liability for eligibility coverage payable at July 31, 2024 and 2023 is an estimate of the cost to the Plan for benefits earned based on work performed within the plan year for coverage not yet granted.

**NOTE 5 TAX STATUS**

The Trust established under the Plan to hold the Trust's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC) and, accordingly, the Trust's net investment income is exempt from income taxes. The Trust obtained a favorable tax determination letter in which the Internal Revenue Service (IRS) stated that the Trust, as designed, was in compliance with the applicable requirements of the IRC. The Trust administrator believes that the Trust, as amended, continues to qualify and to operate in accordance with the applicable provisions of the IRC.

**NOTE 5 TAX STATUS (CONTINUED)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 PLAN TERMINATION**

In the event the Plan terminates, assets remaining after payment of all expenses shall be used for the continuance of benefits until such assets have been depleted. If the assets are insufficient to pay all accrued benefits and liabilities, distribution of the assets shall be made in accordance with Plan termination provisions of ERISA and applicable government regulations.

**NOTE 7 PARTIES-IN-INTEREST TRANSACTIONS**

As described in Notes 1 and 2, the Plan has several arrangements with service providers. These transactions qualify as party-in-interest transactions under ERISA.

**NOTE 9 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The liability for claims incurred but not reported at July 31, 2024 and 2023 was estimated using Plan provisions, the number of eligible participants, historical claims paid, and the actual lag patterns of the Plan as well as industry-wide factors. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

The estimate for liability for eligibility coverage payable is based on certain assumptions pertaining to health care trends and inflation rates. Due to uncertainties in the estimations and assumptions process, it is at least reasonably possible that changes in these assumptions in the near term would be material to the disclosure to the financial statements.
