



Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of MacBeath Hardwood Company, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of July 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTE 1 PLAN DESCRIPTION

The following description of MacBeath Hardwood Company, Inc.'s 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees who are not leased employees. The Plan entrance dates are the first day of each month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility

Employees who are not leased, are eligible to participate in the Plan when they have completed six months of service.

Contributions

Participants may contribute to the Plan up to 90% of their compensation, subject to limits imposed by Federal tax law. The Company's matching contribution is discretionary.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, allocations of investment earnings, and allocations of the administrative expenses. Allocations are based on a participant's compensation or account value, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts plus earnings thereon is based on years of service. A participant is 100% vested after six years of credited service or if they die, become disabled or reach normal retirement age.

Payment of Benefits

Upon termination of employment, death, disability, or retirement, the participant may receive a lump sum distribution as soon as administratively feasible following the date on which a distribution is requested or is otherwise payable.

Investment Options

All investments of the Plan are participant directed.

Forfeitures

Forfeitures are first used to pay Plan expenses or to reduce the Company's contributions. Forfeitures for 2024 and 2023, were \$28,107 and \$11,055, respectively. As of July 31, 2024 and 2023, forfeited nonvested account totals were \$18,654 and \$17,756 respectively.

Participant Loans (Notes Receivable from Participants)

Participant loans are permitted under the Plan. The minimum amount of a loan is \$1,000. Loans cannot exceed the lesser of \$50,000 or 50% of a participant's vested balance. Repayment of loans shall not exceed five years except if the loan proceeds are used to acquire the participant's principal residence. An administrative fee is charged for establishing and maintaining the loan. The loans are secured by the balance in the participant's account and bear interest. Loans are repaid ratably through payroll deductions.

NOTE 2 SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Concentration of Credit Risk

The Plan invests in investment companies (funds) administered by The Reliance Trust Company. The funds' investments are not insured and are affected by the fluctuations in the stock and bond markets.

Valuation of Investments and Income Recognition

The investments of the Plan are stated at fair value. See Note 8 for further information regarding valuation of the Plan's investments. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's interest in the stable value fund is valued based on information reported by the trustee.

Security transactions are accounted for on the date securities are purchased or sold (trade date). Dividend income is recorded on the ex-dividend date. Interest income is recognized when earned. Capital gain distributions are included in dividend income. Net appreciation and depreciation of the fair value of investments consists of the unrealized appreciation or depreciation of investments held during the year and the realized gain or loss on investments sold during the year.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

Investment advisory fees for portfolio management are paid directly from fund earnings; they are included in the fund expense ratio and will not reduce assets of the Plan. All other expenses including administrative costs, legal fees, auditing fees, and other costs are paid by the Plan or Plan sponsor.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Reclassifications

Certain amounts from the prior year have been reclassified to conform with the current year presentation.

Evaluation of Subsequent Events

The Plan has evaluated subsequent events through May 07, 2025, which is the date the financial statements were available to be issued.

NOTE 3 PLAN TERMINATION

Although the Company has not expressed any intent to do so, it has the right, by action of its directors, to terminate the Plan subject to the provisions of the ERISA. In the event of Plan termination, amounts credited to the participants' accounts will become fully vested and nonforfeitable.

NOTE 4 PARTIES IN INTEREST

There were no known prohibited transactions with known parties in interest as defined in ERISA Section 3(14) and regulations thereunder, including those transactions set forth in ERISA Sections 406 and 407(a) and Internal Revenue Code Section 4975(c).

Certain Plan investments are shares of mutual funds and common collective trusts. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

NOTE 5 INCOME TAX STATUS

The Plan has adopted a non-standardized form of a pre-approved plan. The pre-approved plan provider, ADP, LLC, has received an opinion letter dated June 30, 2020, from the Internal Revenue Service as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code. The plan document has been amended since receiving the opinion letter. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Management has evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

NOTE 6 SUMMARY OF CERTIFIED FINANCIAL DATA

NOTE 8 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Statement ASC 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at July 31, 2024 and 2023.

Registered investment companies funds: Valued at the closing price reported on the active market on which the individual securities are traded.

Common collective trust: Valued based on the fair value of the underlying investments comprising the fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
