Notes to Financial Statements

1. Description of Plan

The following description of the Sherrill, Inc. 401(k) Profit Sharing Plan & Trust (the “Plan”) provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan available to eligible employees of Vertical Supply Group, formerly Sherrill, Inc. (the “Company”) who have attained 20.5 years of age. Employees are eligible for participation immediately upon hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Contributions

Eligible employees are automatically enrolled at a 4% pre-tax deferral percentage which will increase by increments of 1% annually up to a maximum of 8% unless they elect an alternative percentage or decline participation. Participants may otherwise elect to contribute up to 100% of their pre-tax and/or after-tax (“Roth”) compensation, as defined by the Plan, not to exceed the limits set by the Internal Revenue Service (“IRS”). Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (“rollovers”). During 2024 and 2023, the Company made discretionary matching contributions equal to 100% of the first 3% and 50% of the next 2% of base compensation contributed to the Plan for participants. In 2023, participants were generally required to be employed on the final day of the Plan year to be eligible for discretionary matching contributions. Effective January 1, 2024, Company discretionary matching contributions are calculated each pay period and participants are no longer required to be employed as of the last day of the plan year. The Company may also make discretionary profit sharing contributions. However, there were no discretionary profit sharing contributions in 2024 or 2023. Participants must work at least 1,000 hours and be employed on the last date of the plan year in order to receive discretionary profit sharing contributions.

Effective January 1, 2025, the Company will begin making safe harbor matching contributions equal to 100% of the first 3% and 50% of the next 2% of base compensation contributed to the Plan.

Upon enrollment in the Plan, a participant may direct their contributions into any of the investment options offered through the Plan and change their investment options and deferral percentages at any time.

Participant Accounts

Each participant’s account is credited with the participant’s and the Company’s contributions and an allocation of the Plan’s net earnings and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s contributions, plus any actual earnings thereon, is based on years of service according to the following schedule:

1. Description of Plan (Concluded)

Payment of Benefits

Upon termination of service due to death, disability, retirement, or separation, a participant is entitled to receive his or her vested account balance in a lump-sum payment. In-service withdrawals may be made to participants who have reached age 59½. Withdrawals may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan.

Forfeitures

Forfeitures from non-vested participant accounts may be used to offset administrative expenses or Company discretionary matching contributions. During 2024 and 2023, forfeitures of approximately \$15,000 and \$12,000 were used to offset administrative expenses. As of December 31, 2024 and 2023, there were \$7,000 and \$0 forfeitures available to offset administrative expenses or future discretionary matching contributions.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Terms are primarily up to five years or up to 15 years for the purchase of a primary residence. Participants may only have one outstanding loan at a time. The notes are secured by the vested account balance in the participant's account and bear interest at a rate commensurate with market rates. Principal and interest are paid ratably through payroll deductions.

Administrative Expenses

The Company absorbs certain expenses incidental to the administration of the Plan, including internal administrative costs. Other fees, including custodian and asset fees, are paid by the Plan. Loan and distribution fees are paid out of affected participant accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are primarily stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in investment contracts through the Transamerica Stable Value Core Option.

2. Summary of Significant Accounting Policies (Concluded)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management has evaluated events occurring subsequent to the date of the financial statements through May 5, 2025, the date that the financial statements were available to be issued and determined that no events require adjustment to or additional disclosure in the financial statements.

3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company.

4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

5. Income Tax Status

The Plan has adopted a prototype non-standardized plan document sponsored by CCH Incorporated ("CCH"). The IRS has determined and informed CCH by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since the date of the determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with applicable provisions of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

6. Plan Termination

Although it has not expressed any intent to do so, the plan sponsor has the right to discontinue the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

7. Party-in-Interest Transactions

Fees paid by the Plan to Transamerica Retirement Solutions for recordkeeping services were approximately \$25,000 and \$20,000 during 2024 and 2023.

Fees paid by the Plan to Global Retirement Partners for investment advisory services were approximately \$24,000 and \$36,000 during 2024 and 2023.

Fees paid by the Plan to Wealth Advisory Services for investment advisory services were approximately \$20,000 during 2024.

8. Fair Value Measurements

The Plan has adopted Accounting Standards Codification 820, "Fair Value Measurements and Disclosures" ("ASC 820"), which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under ASC 820 are as follows:

Basis of Fair Value Measurements

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at net asset value ("NAV") of shares held by the Plan at year-end. The NAV for these investments is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

9. Guaranteed Investment Contracts

The Plan is invested in the Transamerica Stable Value Core Option, which is a group annuity product issued by Transamerica Life Insurance Company ("TLIC"). Amounts contributed are invested broadly to ensure that deposits are credited with a consistent interest rate, that is established semi-annually and contains no set maturity. Principal and accumulated interest are fully guaranteed by TLIC. Plan participants may generally withdraw assets from the investment without restrictions; however, a hold may apply on the Plan's assets in certain instances as further defined in the contract. The minimum crediting rate under the contract was 1.58% and 1.17% at December 31, 2024 and 2023.


