#### Note 1. Description of Plan

The following description of the Spire Power Solutions, LP Union Employees Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering all hourly employees of Spire Power Solutions, LP (the Company or Plan Sponsor) who have three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan Committee is responsible for oversight of the Plan. The Plan Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Eligibility:** Employees, apart from interns, non-union employees, leased employees and non-resident aliens, who have completed three consecutive months of service with the Company, during which they complete at least 250 hours of service become eligible for the Plan and Company matching contributions. The Plan provides for eligible employees to enter the Plan on the first day of the month following the three-month anniversary of their start date.

**Contributions:** Each year, participants may contribute to the Plan a percentage of their annual compensation, as defined by the Plan, up to the maximum allowed under the Internal Revenue Code (IRC). Participants may elect to change this percentage at any time. Participants may also make Roth after-tax contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan has elected a discretionary match contribution, under which the Company contributes 50% of the participant's salary deferrals that do not exceed 6% of the participant's eligible compensation. The Company may make profit sharing contributions at the option of the Company's Board of Directors. No profit sharing contributions were made during the year ended December 31, 2023. Contributions are subject to certain limitations.

**Investment options:** Upon enrollment in the Plan, a participant may direct contributions into a variety of investments as more fully described in the Plan's literature. Participants may change their investment options daily.

**Participant accounts:** Each participant's account is credited with the participant's contributions, Company's discretionary match contributions and allocations of (a) the Company's profit sharing contributions, (b) Plan earnings (losses) and (c) forfeitures of terminated participants' nonvested accounts, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which participants are entitled is the benefit that can be provided from the participants' vested accounts.

**Vesting:** Participants are immediately vested in their participant-directed, rollovers and profit sharing contributions made by the Company, plus actual earnings thereon. Participants vest in the Company's discretionary matching contribution portion of their account 50% a year beginning with the second anniversary of their hire date and are fully vested after three years of employment.

#### Note 1. Description of Plan (Continued)

**Notes receivable from participants:** Participants may borrow from their fund account up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable terms range from one to five years or longer if used to purchase a principal residence. The notes receivable are collateralized by the balance in the participant's account and bear interest at 2.00% above the prime rate at the time of loan origination. Principal and interest payments are paid ratably through payroll deductions.

**Payment of benefits:** On termination of service due to death, disability retirement or other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount. In addition, hardship distributions out of the participant's account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59½.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan have been prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by the investment trustee and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions:** Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which participant compensation is paid.

**Payment of benefits:** Benefit payments to participants are recorded when paid.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expense when they are incurred. Delinquent notes receivable from participants are treated as distributions based upon the terms of the Plan document.

**Payment of benefits:** Benefits are recorded when paid.

**Subsequent events:** The Sponsor has evaluated subsequent events through May 12, 2025, the date the financial statements were available to be issued.

#### Note 3. Information Certified or Provided by Ascensus Trust Company, (Trustee)

The following is a summary of the Plan's asset information as of December 31, 2023 and 2022, and for the year ended December 31, 2023, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by Ascensus Trust Company, the trustee, and furnished to the Plan Administrator.

The Plan Administrator has obtained certifications from the trustee that information provided to the Plan Administrator by the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following assets:

Ascensus Trust Company also certified the completeness and accuracy of \$612,083 of net appreciation in fair value of investments, \$271,938 of interest and dividends, and \$17,877 of interest income on notes receivable from participants for the year ended December 31, 2023.

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Accounting Standards Codification (ASC) 820 are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

#### Note 4. Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022:

**Shares of registered investment companies:** Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Change in fair value levels:** To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

The Plan management evaluated the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2023, there were no transfers in or out of Level 3.

#### Note 5. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts. Any unallocated assets of the Plan would be allocated to participants' accounts and distributed in such manner as the Plan Sponsor may determine.

#### **Note 6. Income Tax Status**

The Plan adopted a nonstandardized form of a pre-approved plan sponsored by Ascensus, LLC, that was qualified, and the trust established under the Plan is tax-exempt under IRC 401(a) pursuant to the pre-approved opinion letter dated June 30, 2020. The pre-approved plan opinion letter has been relied upon by the Plan. The Plan has since been amended, and the Plan Administrator believes that the Plan is currently designed and is being operated in compliance with the applicable sections of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 7. Related-Party and Party-In-Interest Transactions**

Investments are managed by Ascensus Trust Company. These transactions, therefore, qualify as party-in-interest. Administrative expenses paid by the Plan to Ascensus Trust Company were \$39,883 during the year ended December 31, 2023. In addition, certain administrative functions are performed by the Plan Sponsor or employees of the Plan Sponsor for which no compensation is received from the Plan.

#### **Note 8. Risks and Uncertainties**

Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **Note 9. Late Deposits**

The Plan inadvertently failed to deposit \$21,866 of participant contributions and loan repayments during the year ended December 31, 2022, \$2,514 of participant contributions and loan repayments during the year ended December 31, 2021, and \$359,898 of participant contributions and loan repayments during the year ended December 31, 2020, within the required timeframe as stated by the United States Department of Labor regulations. The Plan sponsor deposited lost earnings to correct this failure in April 2023. An application to the Voluntary Fiduciary Correction Program was submitted April 6, 2023, requesting a no-action letter based on the correction performed.
