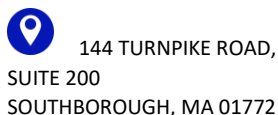
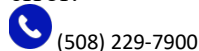

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Pine Health Benefit Trust's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Supplemental Schedules Required by ERISA**

Our audit was conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of assets (held at year end) as of December 31, 2024 and 2023 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1 TRUST DESCRIPTION**

The following description of the PINE Health Benefit Trust (the Trust) provides only general information about the Trust's provisions. Trustees and participants should refer to the Trust agreement for a more complete description of Trust provisions, a copy of which may be obtained from the Trust.

The Trust was formed on May 1, 1989 to provide group health, dental, life and accidental death and dismemberment coverage and such other benefits as the Trustees may determine for employees of employer members of the Graphic Arts Institute of New England, Inc. d/b/a Printing Industries of New England (the Association), who are engaged in the graphic arts industry in New England. During the years ended December 31, 2024 and 2023, the Trust provided only fully insured dental coverage to participants.

The Trust is funded by contributions made to the Trust by the Association's member companies and their employees who elect to participate. Such contributions are calculated by the Trust based on insurance premiums due in order to provide designated benefits to participants and a service fee. Generally, all permanent employees who work at least 30 hours per week for a participating member company are eligible to become participants. Member companies may voluntarily terminate their participation in the Trust by giving 30 days advance written notification of their intent to terminate participation. Participants should refer to the Summary Plan Description and the Trust Document for further information.

**NOTE 2 SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements of the Trust are prepared using the accrual basis of accounting.

**Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

**NOTE 2 SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**Cash Equivalents**

The Trust considers equivalent to cash all money market funds and other deposits with an original maturity of ninety days or less from date of purchase. Cash equivalents are stated at cost which approximates market.

**Investment Valuation and Income Recognition**

Investments in marketable equity securities with readily determinable fair values are reported at their fair values in the statements of net assets available for benefits based on published quotations. Dividends and interest earned on investments, cash equivalents and certificates of deposit are recorded on the accrual basis. Net appreciation and depreciation includes the Trust's realized and unrealized gains and losses on investments.

**Contributions Receivable**

The Trust carries its contributions receivable at the original invoice amounts, net of amounts determined to be uncollectible. On a periodic basis, the Trust evaluates its contributions receivable and establishes an allowance for uncollectible amounts, based on its historical collection experience and current credit conditions. As of December 31, 2024 and 2023, based on the Trust's evaluation, no allowance for uncollectible amounts has been considered necessary by management.

**Revenue Recognition**

Contributions are billed monthly and recognized as revenue during the period of premium coverage.

**Date of Management's Review**

The Trust has evaluated subsequent events through March 27, 2025, the date the financial statements were available to be issued. No significant subsequent events were identified.

**NOTE 4 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under the *Fair Value Measurements* accounting standard are described as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Trust has the ability to access.
  
- Level 2** Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
  
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**NOTE 5 TRUST TERMINATION**

Although the Association has not expressed any intent to terminate the Trust, it may do so at any time. If the Trust is terminated, any remaining Trust assets shall be used to pay insurance premiums for periods prior to the termination date and any other liabilities. Any assets remaining after all eligible claims incurred are paid shall be used to fund other eligible benefits to the participants. If the Trust assets are insufficient for the payment of benefits, the benefits which are not fully insured may not be fully paid.

**NOTE 6 TAX STATUS**

The Trust was informed by the U.S. Treasury Department, on February 17, 1993, that it is qualified under section 501(c)(9) of the Internal Revenue Code. The Trust administrator believes that the Trust is being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that it is tax-exempt.

Accounting principles generally accepted in the United States of America require Trust management to evaluate tax positions taken by the Trust and recognize a tax liability if the Trust has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Trust administrator has analyzed the tax positions taken by the Trust, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require the recognition of a liability or disclosure in the financial statements. The Trust is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 REINSURANCE**

The Trust was a participant in the Printers Disability Trust (PDT). PDT purchases and administers health programs for employees of participating companies and is sponsored by the Association and other local affiliates. For the years ended December 31, 2024 and 2023, the Trust received commissions from PDT in the amounts of \$5,985 and \$7,253, respectively.

**NOTE 8 ADMINISTRATIVE EXPENSES AND RELATED PARTY TRANSACTIONS**

The Trust is sponsored by the Association. The Trust incurred administrative fees to the sponsor and its subsidiary amounting to \$19,496 and \$21,138 for the years ended December 31, 2024 and 2023, respectively. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. The Trust had a payable due to the Association of \$332 at December 31, 2024. The employees of the Association are participants in the Trust. The Association and its employees contributed \$2,877 and \$2,359 to the Trust for the years ended December 31, 2024 and 2023, respectively.



