As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of July 31, 2024 and 2023, stating that the certified investment information, as described in Note G to the financial statements, is complete and accurate.

Notes to Financial Statements

Note A – Description of Plan

The following description of the Lexington Eye Associates, Inc. Retirement Savings Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering eligible employees of Lexington Eye Associates, Inc. (the “Company”, “Plan Administrator”, or “Employer”). The Plan Administrator is responsible for oversight of the Plan and determines the appropriateness of the Plan’s investment options and monitors investment performance. Employees are eligible to participate in the Plan on the first day of the month coinciding with or following the date the eligibility requirements have been met. An employee becomes eligible to participate in the Plan following one year of service, as defined in the Plan, and attained the age of eighteen. The Plan was adopted by the Company on July 1, 1974. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective August 1, 2022, the Plan was amended to allow the years of service with Dedham Ophthalmic Consultants and Surgeons, P.C. to be recognized for the purposes of eligibility, vesting and allocations.

SECURE ACT 2.0

In December 2022, Congress passed the Consolidated Appropriations Act of 2023 which included the SECURE Act 2.0. The SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since the SECURE Act 2.0 provisions include both required and optional elements, the Plan Administrator will determine the optional provisions to elect and amend the Plan documents accordingly.

Contributions

Each year, participants may make pre-tax elective contributions and Roth 401(k) contributions equal to a percentage of the contributing participant’s eligible compensation. Each participant may contribute up to 100% of their compensation into the Plan each year subject to certain Internal Revenue Service (“IRS”) limitations. Participants who have attained the age of 50 before the end of the Plan year are eligible to make annual “catch-up” contributions. Participants may also rollover amounts distributed or transferred from other eligible retirement plans. Participants direct the investment of deferrals, rollovers, and Company contributions into various investment options offered by the Plan.

On behalf of each Participant who is eligible to share in matching contributions for the Plan year, the Employer may make a discretionary matching contribution equal to a uniform percentage (to be determined each year by the Employer) of each participant’s elective deferrals. No employer discretionary matching contributions were made for the year ended July 31, 2024. The Employer may make a discretionary matching and/or profit sharing contribution to Plan participants who have completed a year of service during the Plan year and were employed on the last day of the Plan year. These conditions are waived for participants who have terminated during the Plan year due to death, disability, or who have attained the normal retirement age. Such contribution will be allocated to the account of each eligible participant in the proportion that each individual participant’s compensation bears to the total compensation of all participants.

The Employer may make a safe harbor nonelective contribution equal to 3% of each participant’s compensation for a Plan year. Nonelective safe harbor contributions are 100% vested.

Note A – Description of Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution, if any, Plan earnings (losses) from investments and is charged for specific administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

Vesting

Participants are immediately vested in their contributions and safe harbor contributions plus earnings thereon. Vesting in the employer profit sharing and employer matching contributions made to their accounts plus actual earnings thereon is based on years of credited service. A participant is 100% vested after three years of credited service.

A participant who attains normal retirement age or who becomes disabled or dies will be considered 100% vested.

Payment of Benefits

Upon retirement, death, disability, or other termination of service, participants will be entitled to receive a lump sum, partial payment, or installment payments for required minimum distributions. The Plan may automatically make distributions to terminated participants, without their consent, if the value of their vested account balances is \$1,000 or less, and the amount will be paid in a lump sum distribution. With vested account balances between \$1,000 and \$5,000, such amount will be rolled over to an individual retirement account designated by the Plan Administrator. If the participant is married on the date the benefits are to begin, the participant will automatically receive a joint and 50% survivor annuity, unless an alternative form of payment is elected. A participant may elect a joint and 75%, or 100% survivor annuity instead of the standard joint and 50% survivor annuity. If the participant is not married on the date the benefits are to begin, the participant will automatically receive a life annuity, unless an alternative form of payment is elected.

Active participants may take a distribution from the vested portion of their account if they are at least age 59½.

Forfeitures

As of July 31, 2024 and 2023, the balance of forfeited non-vested accounts totaled \$7,630 and \$6,430, respectively. The forfeitures of unvested account balances are used to reduce Plan administrative expenses.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The loans are secured by the balance in the participant's account and bear interest at a rate dependent on the prime rate plus 1%. Principal and interest are paid ratably through bi-weekly after-tax payroll deductions. Interest rates are fixed for the duration of the loan. Such loans are scheduled to mature within 5 years, unless loan proceeds are used to acquire a principal residence, in which case, at the discretion of the Plan Administrator, maturity may be for a longer period.

Notes Receivable from Participants (continued)

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of July 31, 2024 or 2023. Delinquent notes receivable from participants meeting such terms are reclassified as deemed loans. The balance of deemed loans at July 31, 2024 and 2023 was \$2,695 and \$2,608, respectively. The balance continues to be included in notes receivable from participants until the participant repays the notes receivable or when the account balances of the defaulted borrower(s) are distributed from the Plan.

Note B – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for insurance contracts which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of mutual fund shares are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year and capital gain distributions from the investments.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Evaluation of Subsequent Events

The Plan Administrator has evaluated the effect which subsequent events may have on these financial statements. The Plan Administrator’s evaluation was completed on January 17, 2025, the date the financial statements were available to be issued.

Note C – Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels. *Level 1* inputs consist of unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access, *Level 2* inputs in general consist of quoted prices for similar assets in active markets and *Level 3* inputs are unobservable and significant to the fair value measurement priority.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at July 31, 2024 and 2023.

- Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note D – Cash Value of Life Insurance Policies

The Plan holds life insurance policies issued by Metropolitan Life Insurance Company for three participant beneficiaries of the Plan. As of July 31, 2024 and 2023, the life insurance policies face value totaled \$116,316. The policies’ contract value was determined using their total cash values.

Note E – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note F – Tax Status

The Plan adopted a non-standardized pre-approved profit sharing 401(k) plan. The non-standardized preapproved profit plan received a favorable opinion letter from the IRS on June 30, 2020 which stated that the prototype plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since the non-standardized pre-approved profit plan received the favorable opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of July 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest expense or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note G - Information Certified by Custodian (Unaudited)

For the years ended July 31, 2024 and 2023, the Capital Bank and Trust Company (“Custodian”) held the Plan’s investments as custodian. The following is a summary of the Plan’s financial information that is included in the financial statements based on information certified by the Custodian as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

Note H – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note I – Related Party Transactions and Parties-In-Interest Transactions

Certain operating expenses of maintaining the Plan are paid by the Company. Additionally, employees of the Company perform certain routine administrative services for the Plan without charge.

Certain Plan investments include shares of mutual funds that are managed by affiliates of the Custodian. Notes receivable from participants are also considered party-in-interest transactions.

Effective September 17, 2024, the Plan was restated. As part of the Plan restatement Lexington Eye Associates – Optical, LLC adopted the Plan and became an adopting employer of the Plan.
