Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of U-TEC Construction, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits – modified cash basis- as of July 31, 2024 and 2023, and the related statement of changes in net assets available for benefits -modified cash basis- for the period beginning January 1, 2024 and ended July 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of U-TEC Construction, Inc. Emphasis of Matter

As discussed in Note 1 to the financial statements, U-TEC Construction, Inc., the Plan's sponsor, elected to merge the Plan with Contractors Retirement Plan, a multiple employer plan. Accordingly, all assets were subsequently transferred into that plan as of July 31, 2024 and the Plan ceased operations as a separate entity. The 2023 financial statements do not include any adjustments that might be necessary upon merger and termination. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about U-TEC Construction, Inc. Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Notes to Financial Statements
July 31, 2024 and December 31, 2023

1. DESCRIPTION OF THE PLAN

The following description of U-TEC Construction, Inc. (the “Company”) Retirement Plan (the “Plan”), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

- A. *General and Plan Merger.* The Plan is a defined contribution plan covering all eligible employees of the Company. Employees must have a minimum of 6 months service to be eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The trustees of the Plan approved the merger of the Plan into the Contractors Retirement Plan, a multiple employer plan. Accordingly, all investments were transferred to the Contractors Retirement Plan as of July 31, 2024 and the statement of changes in net assets is for the period January 1, 2024 through July 31, 2024.

- B. *Contributions.* Each year, participants may contribute up to 100% of pretax annual compensation as defined by the Plan, except that no employee may make annual tax-deferred contributions in excess of amounts provided by the Internal Revenue Code. Participants may also contribute amounts representing rollover distributions from other qualified plans and ROTH contributions are also allowed. The Company may match a percentage of each participant’s current pre-tax contribution at its discretion.
- C. *Participant Accounts.* Each participant’s account is credited with the participant’s deferral contribution and allocations of (a) the Company’s contribution (if any) and (b) plan earnings including administrative expenses. Allocations are based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- D. *Vesting.* Participants are immediately vested in their salary deferral contribution plus actual earnings thereon. Vesting in the Company’s contribution portion, if any, of their account plus actual earnings thereon is based on years of continuous service; a participant is 100% vested after six years of credited service with the vesting percentage accruing ratably each year of the period.
- E. *Payment of Benefits.* Distributions from the Plan are made in the form of a lump sum of a Participant’s entire vested account balance or a single sum distribution of a portion of the Participant’s vested account balance. Optional forms of payment available upon termination of employment include lump sum distribution of entire vested account balance or single sum distribution of a portion of the vested account balance.
- F. *Forfeited Accounts.* Forfeitures may be used to reduce plan expenses and employer match.

2. SUMMARY OF ACCOUNTING POLICIES

A. *Basis of Accounting.* The financial statements are prepared on the modified cash basis which is a basis of accounting other than accounting principles generally accepted in the United States of America (US GAAP). Under this basis, revenue and the related assets are recognized when received rather than when earned and expenses are recognized when paid rather than when incurred, except for investments which are valued at fair value. Management has determined that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances.

B. *Payment of Benefits.* Benefit payments are recorded when paid.

C. *Investment Valuation and Income Recognition.* Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. *Use of Estimates.* The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

E. *Participant loans.* Loans are available to Participants and Beneficiaries on a reasonably equivalent basis. Loans shall not be made available to Highly Compensated Employees in an amount greater than the amount that is made available to other Participants and Beneficiaries. Loans shall bear a reasonable rate of interest, be adequately secured, and provide for a periodic repayment over a reasonable period of time. Furthermore, no Plan loan shall exceed a Participant's Vested interest in the Plan.

3. INVESTMENT CONTRACT WITH TRUSTEE

The Plan entered into an investment contract with Charles Schwab Trust Bank. Funds are participant-directed into investment funds. All Plan assets were held with Charles Schwab Trust Bank in a fiduciary trust plan and were transferred in full to the Contractors Retirement Plan.

5. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of fair value hierarchy under FASB ASC 820 are described below:

Basis of Fair Value Measurement:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following describes the valuation methodologies used for assets measured at fair value on a recurring basis. The techniques utilized in estimating the fair values of financial instruments are reliant on the assumptions used. Care should be exercised in deriving conclusions based on the fair value information of financial instruments presented below. There have been no changes in the methodologies used at December 31, 2023.

Fair value estimates are made as of a specific point in time, based on available market information and judgments about the financial instrument. Such estimates do not consider the tax impact of the realization of unrealized gains or losses. In addition, the disclosed fair values may not be realized in the immediate settlement of the financial instrument.

Mutual Funds - The mutual funds are held as individual plan assets. The mutual funds have publicly available prices that are quoted daily in active markets. Lifecycle funds are managed based on a target date. Due to similar valuation techniques, they are classified as mutual funds.

Participant loans - Valued at amortized cost, which approximates fair value.

The preceding described methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. PLAN TERMINATION

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions. During 2024, the Plan was merged into the Contractors Retirement Plan, a multiple employer plan (Note 1).

7. RELATED-PARTY TRANSACTIONS

Certain plan investments were money market and mutual funds managed by an affiliate of Charles Schwab Trust Bank, a trustee of the Plan, and, therefore, these are considered party-in-interest transactions.

The Plan also pays administrative fees to Charles Schwab Trust Bank. These fees are considered exempt party-in-interest transactions. Other administrative expenses of the Plan were absorbed by the Plan sponsor. Therefore, those expenses are not reflected in these statements.

8. TAX STATUS

The Plan utilized a service provider to handle administrative matters including plan design. An opinion letter from the Internal Revenue Service has been obtained by the service provider accepting the Plan as a prototype qualifying under the appropriate Internal Revenue Code Sections. The Plan has been amended since receiving the letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. RISK AND UNCERTAINTIES

The Plan provides various investment options. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.

10. SUBSEQUENT EVENTS

Plan management has evaluated the need for disclosures or adjustments resulting from subsequent events through May 12, 2025, the date the financial statements were available for issuance. No events were identified that required disclosure in or adjustments to the financial statements.
