- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Brown Truck Leasing Corporation 401(k) Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements and supplemental schedule are prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Brown Truck Leasing Corporation 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters – Supplemental Schedule Required by ERISA

The supplemental schedule of assets held at end of year as of July 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS**

NOTE 1 DESCRIPTION OF THE PLAN

The following brief description of the Brown Truck Leasing Corporation 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for the complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering any nonunion employee of Brown Truck Leasing Corporation or its subsidiaries (the Company) over the age of twenty-one who has one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

All eligible employees may make voluntary contributions to the Plan up to 100% of compensation, not to exceed the limitations of Internal Revenue Service Code Section 401(k). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company provides matching contributions determined annually at the discretion of the management of Brown Truck Leasing Corporation. During the years ended July 31, 2024 and 2023, the Company made matching contributions equal to one-third of the participant's contribution percentage up to a maximum of 2.0% of employee compensation.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of plan earnings or losses based on account balances, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately and entirely vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts and actual earnings thereon is based on years of credited service, and the participant is 100% vested after five years of credited service.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump-sum payment equal to the value of the participant's vested interest in his or her account or an annuity. Benefits are recorded when paid. Normal retirement age is defined in the Plan as sixty-five years of age.

The Plan allows for hardship withdrawals to participants who meet an immediate and severe financial need and are limited to a participant's vested account balance.

Notes Receivable from Participants

Participants may borrow from their Plan accounts a minimum of \$1,000 up to maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1-15 years, are secured by the balance in the participant's account, and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator which was 5% at July 31, 2024 and 2023. Principal and interest are paid ratably through weekly payroll deductions.

Forfeitures

If a participant terminates employment for any reason other than death, disability, or retirement, the unvested portion of the participant's account, if any, is forfeited. At July 31, 2024 and 2023, forfeited unallocated invested accounts totaled \$23 and \$17,436, respectively. Forfeited amounts are retained in the Plan and used to reduce the Company's matching contributions for the next Plan year or pay the quarterly trustee fee. Forfeitures of \$18,967 and \$-0- were used to pay reduce the Company's matching contributions for the years ended July 31, 2024 and 2023, respectively. Forfeitures of \$-0- and \$641 were used to pay quarterly trustee fees for the years ended July 31, 2024 and 2023, respectively.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions into various investment options. The Plan currently offers a money market fund, a stable value portfolio, and several mutual funds with varying long-term investment objectives. Participants may change their investment options at any time.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the modified cash basis of accounting. Under this basis, certain revenues and the related assets are recognized when received rather than when earned, and certain expenses are recognized when paid rather than when the obligation is incurred. The modified cash basis of accounting differs from generally accepted accounting principles primarily because the Plan has not recognized contribution receivables and their related effect on earnings in the accompanying financial statements.

Investment Valuation and Income Recognition

The Plan's investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants (participant loans) are measured at their unpaid principal balances plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of July 31, 2024 and 2023.

In accordance with the Plan document, participant loans are considered to be in default if any scheduled loan repayment remains unpaid by the end of the grace period. Defaulted loans are reported as taxable deemed distributions in the year in which the default occurs. During the years ended July 31, 2024 and 2023, \$-0- and \$6,124, respectively, of deemed distributions of participant loans were reported in the accompanying statements of changes in net assets available for benefits.

Payment of Benefits

Benefit payments to participants are recorded upon distribution. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan but have not yet been paid at July 31, 2024 and 2023.

Administrative Expenses

Certain administrative functions are performed by officers or employees of the Company or its subsidiaries. No such officer or employee receives compensation from the Plan. Certain other administrative expenses, including the third party administrator fees and audit fees, are paid directly by the Plan sponsor. Fees to the Plan's 401(k) advisor are paid by the Plan. During the years ended July 31, 2024 and 2023, fees totaling \$15,523 and \$13,517, respectively, paid to the Plan's 401(k) advisors were charged to each participant's account in accordance with the Plan document.

NOTE 4 FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification (ASC) 820 are described as follows:

Level 1—Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2—Inputs other than quoted prices included within Level 1 that are observable for the asset, either directly or indirectly, such as:

- quoted prices for similar assets in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3—Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at July 31, 2024 and 2023:

Money market and mutual funds—Money market and mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable value portfolio—The stable value portfolio is composed primarily of guaranteed investment contracts and other security-backed contracts. The value of the portfolio is determined by the trustee of the Plan based upon the fair values of the underlying investments of the contracts held at year end.

The following tables set forth by level within the fair value hierarchy the Plan investment assets at fair value as of July 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

NOTE 5 TAX STATUS

The Plan has executed the Fidelity Management Trust Company Prototype and Trust adoption agreement. A determination letter dated June 30, 2020, has been obtained in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter. Although the Plan has been amended since the date of the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of July 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of accounts managed by Fidelity Management Trust Company. Fidelity Management Trust Company (Fidelity) is the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid to Fidelity by the Plan for recordkeeping services amounted to \$6,379 and \$6,454 for the years ended July 31, 2024 and 2023, respectively.

The plan trustee is an officer of the Company and is currently a participant in the Plan.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE 8 RISKS AND UNCERTAINTIES

Participants invest their account balances in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through May 8, 2025, the date which the financial statements were available to be issued. There were no subsequent events required to be accrued or disclosed.
