Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Responsibilities of Management for the Financial Statements



NOTE A - DESCRIPTION OF PLAN

The following description of Middle Tennessee Christian School Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of Middle Tennessee Christian School (the "Sponsor" or the "School") who are age eight-teen or older and have worked more than 20 hours per week. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 ("ERISA").

Contributions

Each year, participants may contribute up to 100 percent of pretax annual compensation subject to IRS prescribed limits. Participants may also contribute amounts representing distributions from other qualified plans.

The School matches 100% of the first 6% of pretax compensation contributed by eligible participants to the Plan. Eligible participants include employees who are eligible for contribution and have 1 year of service to the School. During the year ended July 31, 2024 the School contributed \$286,428 in employer contributions.

The School may make discretionary profit share contributions to the Plan. Participants eligible for the discretionary profit share contributions include employees with 1,000 hours of service, 1 year of service and employed by the School on the last day of the plan year. During the year ended July 31, 2024, the School elected not to contribute a discretionary profit share contribution to the plan.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the School's contribution and (b) plan earnings. Allocations are based on participant earnings or account balances, as defined. Forfeited balances of terminated participants' nonvested accounts are used to reduce future School contributions or cover plan expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, match contributions and the School's discretionary profit share contributions plus actual earnings thereon.

Investment Options

Upon enrollment in the Plan, a participant may direct employee, match contributions and the School's discretionary profit share contributions to selected investment options. Participants may change their investment options at any time.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Administrative Costs

The School absorbs significant administrative costs of the plan.

NOTE B - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Investment Valuation and Income Recognition

The Plan's investments consist of shares of registered investment companies which are stated at fair value. Quoted market prices are used to value investments. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Payments of Benefits

Benefits are recorded when paid.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures of contingent assets and liabilities at the date of the financial statements, and the reported revenue and expenses during the reporting period. Accordingly, actual results may differ from those estimates.

Forfeitures

As of July 31, 2024 and 2023, forfeited non-vested accounts totaled \$569 and \$569, respectively. During the year ended July 31, 2024 no forfeited funds were used to reduce employer contributions or plan expenses.

NOTE C- INFORMATION CERTIFIED BY THE CUSTODIAN

The investments as of July 31, 2024 and 2023 which consisted of registered investment companies totaling \$5,542,255 and \$4,493,875 the net depreciation of investments, net of gains and losses on sale totaling \$515,323 and other investment transactions during the year ended July 31, 2024 were certified as complete and accurate by Charles Schwab Trust Bank, the custodian.

NOTE D - PLAN TERMINATION

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

NOTE E - TAX STATUS

The Plan has adopted a prototype non-standardized 403(b) retirement plan adoption agreement that was sponsored by the Plan's third-party administrator. Although the Plan has been amended since the prototype non-standardized 403(b) retirement plan determination letter was received the Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, management believes the Plan was qualified as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken any uncertain tax positions that more likely than not would not be sustained upon examination by the Internal Revenue Service ("IRS"). As of July 31, 2024 and 2023, the Plan has not recognized any uncertain tax positions. The plan is subject to audits by taxing and compliance jurisdictions; however, there are currently no audits for tax periods in process. The plan is no longer subject to tax examination for years prior to 2016.

NOTE F – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE G – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Codification 820-10 (FASB ASC 820-10), *Fair Value Measurements* (formerly FASB Statement No. 157), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

NOTE G – FAIR VALUE MEASUREMENTS (CONTINUED)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of July 31, 2024 and 2023.

Registered investment companies: Value is based on quoted asset values of the shares held by the Plan at year-end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.



NOTE A - DESCRIPTION OF PLAN

The following description of Middle Tennessee Christian School Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of Middle Tennessee Christian School (the "Sponsor" or the "School") who are age eight-teen or older and have worked more than 20 hours per week. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 ("ERISA").

Contributions

Each year, participants may contribute up to 100 percent of pretax annual compensation subject to IRS prescribed limits. Participants may also contribute amounts representing distributions from other qualified plans.

The School matches 100% of the first 6% of pretax compensation contributed by eligible participants to the Plan. Eligible participants include employees who are eligible for contribution and have 1 year of service to the School. During the year ended July 31, 2024 the School contributed \$286,428 in employer contributions.

The School may make discretionary profit share contributions to the Plan. Participants eligible for the discretionary profit share contributions include employees with 1,000 hours of service, 1 year of service and employed by the School on the last day of the plan year. During the year ended July 31, 2024, the School elected not to contribute a discretionary profit share contribution to the plan.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the School's contribution and (b) plan earnings. Allocations are based on participant earnings or account balances, as defined. Forfeited balances of terminated participants' nonvested accounts are used to reduce future School contributions or cover plan expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, match contributions and the School's discretionary profit share contributions plus actual earnings thereon.

Investment Options

Upon enrollment in the Plan, a participant may direct employee, match contributions and the School's discretionary profit share contributions to selected investment options. Participants may change their investment options at any time.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Administrative Costs

The School absorbs significant administrative costs of the plan.

NOTE B - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Investment Valuation and Income Recognition

The Plan's investments consist of shares of registered investment companies which are stated at fair value. Quoted market prices are used to value investments. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Payments of Benefits

Benefits are recorded when paid.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures of contingent assets and liabilities at the date of the financial statements, and the reported revenue and expenses during the reporting period. Accordingly, actual results may differ from those estimates.

Forfeitures

As of July 31, 2024 and 2023, forfeited non-vested accounts totaled \$569 and \$569, respectively. During the year ended July 31, 2024 no forfeited funds were used to reduce employer contributions or plan expenses.

NOTE C- INFORMATION CERTIFIED BY THE CUSTODIAN

The investments as of July 31, 2024 and 2023 which consisted of registered investment companies totaling \$5,542,255 and \$4,493,875 the net depreciation of investments, net of gains and losses on sale totaling \$515,323 and other investment transactions during the year ended July 31, 2024 were certified as complete and accurate by Charles Schwab Trust Bank, the custodian.

NOTE D - PLAN TERMINATION

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

NOTE E - TAX STATUS

The Plan has adopted a prototype non-standardized 403(b) retirement plan adoption agreement that was sponsored by the Plan's third-party administrator. Although the Plan has been amended since the prototype non-standardized 403(b) retirement plan determination letter was received the Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, management believes the Plan was qualified as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken any uncertain tax positions that more likely than not would not be sustained upon examination by the Internal Revenue Service ("IRS"). As of July 31, 2024 and 2023, the Plan has not recognized any uncertain tax positions. The plan is subject to audits by taxing and compliance jurisdictions; however, there are currently no audits for tax periods in process. The plan is no longer subject to tax examination for years prior to 2016.

NOTE F – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE G – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Codification 820-10 (FASB ASC 820-10), *Fair Value Measurements* (formerly FASB Statement No. 157), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

NOTE G – FAIR VALUE MEASUREMENTS (CONTINUED)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of July 31, 2024 and 2023.

Registered investment companies: Value is based on quoted asset values of the shares held by the Plan at year-end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
