## INDEPENDENT AUDITOR'S REPORT

To the Participants and Board of Trustees of  
Teamsters Retiree Trust:

### Opinion

We have audited the financial statements of Teamsters Retiree Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits and of benefit obligations as of July 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of Teamsters Retiree Trust as of July 31, 2024 and 2023, and the changes in its net assets available for benefits and change in benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Teamsters Retiree Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Teamsters Retiree Trust's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. **1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Method of Accounting**

The accompanying financial statements are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Active Subsidy Receivable**

The active subsidy is money received from Northern California General Teamsters Security Fund ("NCGTSF") based on a set dollar amount per active member in NCGTSF, which is paid on a monthly basis. Active subsidy contributions due and not paid prior to year-end are recorded as active subsidy receivable.

**Reserve Subsidy Receivable**

The reserve subsidy is money received from NCGTSF. The subsidy is based on the amount needed to provide benefits to certain retirees, less the amount the retiree is required to pay. The amount is transferred on a monthly basis. Reserve subsidy contributions due and not paid prior to year-end are recorded as reserve subsidy receivable.

**Prescription Rebates Receivable**

Amounts due from the Plan's prescription drug administrator for rebates earned prior to year-end and received after year-end are recorded as prescription rebates receivable.

**Investment Valuation, Transactions and Income Recognition**

*General*

Investments are carried at fair value, which is determined, presented and disclosed in accordance with Financial Accounting Standards Board Accounting Standards Codification ("FASB ASC 820"), *Fair Value Measurements and Disclosures*. Under FASB ASC 820, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., the "exit price") in an orderly transaction between market participants at the measurement date.

FASB ASC 820 establishes a fair value hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs reflect the Plan's assumptions about inputs that market participants would use in pricing the investments developed based on the best information available in the circumstances. The fair value hierarchy is categorized into three levels, based on the inputs, as follows:

*Level 1* - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

*Level 2* - Valuations based on quoted prices in markets that are not active, quoted prices for similar investments in active markets or model-based valuations for which all significant assumptions are observable and can be corroborated by observable market data.

*Level 3* - Valuations based on unobservable inputs that are supported by little or no market activity and are significant to the overall fair value measurement. Values are determined using proprietary pricing models, discounted cash flow models that include the investment entities' own judgments and estimations, or some other pricing method using unobservable inputs.

In determining fair value, FASB ASC 820 allows various valuation approaches. The specific methods used for the Plan's investment class are presented below.

*Mutual Funds and Exchange-Traded Investments:* The fair value of mutual funds and exchange-traded investments (including exchange-traded funds, exchange-traded notes, and other exchange-traded vehicles) is generally based on quoted prices in active markets (Level 1). Certain funds are valued at amortized cost, which approximates fair value (Level 2).

The valuation techniques used in the accompanying financial statements have been consistently applied.

Purchases and sales of securities are recorded on a trade-date basis. Dividend and interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Deferred Income**

Contributions from participants received for eligibility months after July 31 are recorded as deferred revenue.

**Payment of Benefits**

Premiums paid are recorded as group insurance premiums in the accompanying statement of changes in net assets available for benefits. Self-funded benefits are recorded when submitted to the Plan by the third-party claims processor for reimbursement. Self-funded benefits paid by the claims processor prior to year-end or claim payments submitted to the Plan by the third-party claims processor that are not yet paid are recorded as an amount currently payable in the accompanying statements of benefit obligations. Premiums not yet paid at year-end are included as an amount currently payable in the accompanying statements of benefit obligations.

**Rebates**

Prescription rebates due from the Plan's prescription benefit manager are recorded when earned. Rebates due at year-end are recorded as a receivable on the statements of net assets available for benefits. Prescription rebates are recorded as Prescription rebates and credits in the accompanying statement of changes in net assets available for benefits

**Benefit Obligations**

Claims payable and incurred but not reported was estimated based on claims experience. Group insurance premiums payable was estimated based on payments made subsequent to year-end for eligibility prior to year-end. This Plan does not have post-retirement benefit obligations; therefore, none were recorded.

**Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

**Risks and Uncertainties**

The Plan invests in mutual funds and exchange-traded investments. Such investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with these investments and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

**2. DESCRIPTION OF THE PLAN**

The following description of Teamsters Retiree Trust (the “Plan”) provides only general information. Participants should refer to the Plan booklets for more complete benefit information and eligibility requirements.

**General**

The Plan was created on July 23, 1993, by a trust agreement between a group of employers and certain local unions affiliated with the International Brotherhood of Teamsters, AFL-CIO, in order to provide health and welfare benefits for retired employees and their dependents. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

In 1993, the Plan’s Board of Trustees signed a Declaration of Trust of the Teamsters Retiree Trust (the “Inter-Trust Agreement”) with the Northern California General Teamsters Security Fund. The purpose of the Inter-Trust Agreement is to provide retired employees with health and welfare benefits. Under the terms of the Inter-Trust Agreement, all eligible retired participants of NCGTSF will qualify for eligibility under the Plan as long as they continue to make monthly self-payments in a timely manner. Based on the Inter-Trust Agreement, NCGTSF retains the responsibility and obligation for providing an arrangement for benefits to retired beneficiaries and, therefore, this Plan has not recorded such an obligation in the accompanying financial statements.

**Benefits**

The Plan provides medical, prescription drug and dental benefits on a self-funded basis. Participants also have an option of obtaining medical, prescription drug, dental and vision benefits through Kaiser, United HealthCare, or Vision Service Plan. Effective January 1, 2022, the Board of Trustees approved to change the benefit structure for retirees with Medicare from a self-funded basis to an insured program with Anthem.

**Stop-Loss Insurance**

Certain self-funded medical benefits are paid under the terms of a stop-loss insurance policy. The stop-loss insurance policy periods do not coincide directly with the Plan’s fiscal years. If the claims paid on behalf of an eligible participant or dependent exceed the deductible amount of \$450,000 and \$425,000 for the policy periods ended December 31, 2024 and 2023, respectively, the carrier will reimburse the Plan for the excess in accordance with the terms of the stop-loss insurance arrangement. During the years ended July 31, 2024 and 2023, \$805,074 and \$1,284,005, respectively, was reimbursed to the Plan for claims paid in excess of the deductible during the policy periods ended December 31, 2024 and 2023. As of July 31, 2024 and 2023, \$371,624 and \$517,074, respectively, was due for stop-loss reimbursements earned but not yet received.

**Eligibility**

To be eligible for benefits, a retiree must satisfy the eligibility rules for retiree coverage of the trust under which the participant retired.

**3. PRIORITIES UPON TERMINATION**

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy, or make provisions to satisfy, the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will, in the opinion of the Trustees and in accordance with the Inter-Trust Agreement, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for, or diverted to, purposes other than the exclusive benefit of the participants.

**4. TAX STATUS**

The Plan obtained its latest determination letter in September 1994, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan's administrator and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require management to evaluate the tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the Internal Revenue Service. The Plan has analyzed the tax positions taken by the Plan and has concluded that, as of July 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan believes it is no longer subject to income tax examinations for the fiscal years prior to 2021.

**5. FUNDING POLICY**

The Plan is funded by active and reserve subsidy amounts received from NCGTSF and by employer and retiree contributions. The monthly contribution rates are periodically determined by the Plan's Board of Trustees.

**6. CASH CONCENTRATIONS**

At July 31, 2024 and 2023, the Plan's cash balances of the following account exceeded the federal insured limits:

The Plan places its cash with financial institutions deemed to be creditworthy. Cash balances may at times exceed the insured deposit limits of \$250,000 per institution. Any loss incurred or a lack of access to such funds could have a significant adverse impact on the Plan's financial condition, results of operations, and cash flows.

The Trustees of the Plan also serve as Trustees of NCGTSF. For the years ended July 31, 2024 and 2023, NCGTSF remitted active and reserve subsidies totaling \$33,511,058 and \$28,852,396, respectively, to the Plan. As of July 31, 2024 and 2023, the financial statements of the Plan reflect receivables from NCGTSF totaling \$0 and \$1,495,437, respectively.

**9. SETTLEMENT**

During the year ended July 31, 2023, the Plan received \$784,631 in settlement payments as a result of a class action lawsuit vs. Sutter health, et. al., a Plan healthcare provider. The class action lawsuit relates to claims under state antitrust and unfair competition laws. The settlement payments are reported with other income on the statement of changes in net assets available for benefits.
