(1) DESCRIPTION OF PLAN

The following description of **Davies Office Refurbishing, Inc. Profit Sharing Plan** (hereinafter referred to as The Plan) provides only general information. Participants should refer to The Plan agreement for a more complete description of The Plans provisions.

1. General - The Plan is a single-employer profit sharing plan covering all full-time employees of the company. Participation eligibility is one year of service. Normal retirement is at age 65.
2. Contributions - Each year The Company determines its contribution to The Plan based on its profits. Plan contributions by The Company are discretionary. The Company contributed \$0 and \$0 in 2024 and 2023, respectively.
3. Participants Accounts - Each participant's account is credited with the participants contribution and allocation of (a) the company's contribution (b) Plan earnings and Forfeitures of terminated participants non-vested accounts shall be applied to reduce the employer's contribution for the plan year. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participants account.
4. Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of the accounts is based on years of continuous service. A participant is vested 20% a year after two years (100% after 6 years).
5. Payment of Benefits - On termination of service a participant may elect to receive either a lump sum amount equal to value of his or her account or actuarially equivalent to a single life annuity. Pre-retirement benefits are payable as a lump sum on death of a participant. A qualified pre-retirement survivor annuity is payable to the surviving spouse unless waived with spousal consent.

(2) INVESTMENTS

The Plans investments are held by Principal Life Insurance Company. Quoted market prices are used to value investments. Fair value of investments as at August 31, 2024 and 2023 are as follows:

(3) PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions as any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

(4) SUPPLEMENTARY FINANCIAL INFORMATION

During 2024 and 2023 there were no transactions with parties as interest, no loans or fixed income obligations due in default or uncollectible, no leases in default or uncollectible and, as reported by Fleet investment advisors, there were no transactions in excess of 5% of the current value of plan assets (except as described in Note 2 and in the reinvestment of those funds).

(5) OTHER PLANS

On August 20, 1999, the Company adopted an Employee Stock Ownership Plan (ESOP). This plan covers substantially all of the employees covered by the Davies Office Refurbishing, Inc. Profit Sharing Plan.
