As a result, the plan has changed its basis of accounting from the going-concern basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

1. Description of the Plan

The following description of RRR, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions. As discussed in Note 8, the Plan terminated effective March 31, 2024 and all assets were distributed out of the Plan by July 31, 2024. The provisions described below refer to the Plan provisions while the Plan was operating.

- A. General - The Plan is a defined contribution plan covering substantially all employees of the participating affiliates of RRR, LLC, comprised of participants employed with Imported Cars of Maryland, Inc., RRR Bowie, LLC, Queenstown Motor Co., Inc., Capital Certified Collision Center, RRR, LLC, K Cars of Bowie d/b/a Kia of Bowie, RGH Management Services, LLC, and Owings Mills Autos, LLC. All participating affiliates and employers are collectively referred to as the Company and the Plan Sponsor. The Plan became effective January 1, 2002 and was most recently amended and restated effective June 30, 2020. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The management of the Plan oversees governance, the appropriateness of the Plan's investment offerings, and monitors investment performance.
- B. Contributions - Each year, participants may contribute pretax annual compensation, from 2% to 100%, subject to Internal Revenue Service (IRS) limitations. Employees become eligible to participate in the Plan after completing one year of service, as defined by the Plan, and attaining 21 years of age. Entry dates into the Plan are the first day of each plan year quarter immediately following or coincident with the date the employee completes the eligibility conditions. The Plan allows additional catch-up contributions for participants age 50 or older at the end of the plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans and after-tax (Roth) deferrals.

Beginning on April 1, 2008, 5% of eligible employees' compensation is contributed unless otherwise directed by the employee. This automatic deferral applies to all plan years and has no scheduled increases.

The Plan contains a provision for the Company to match 20% of the participant deferrals to a maximum of a 5% deferral of eligible compensation. The Plan does not match on catch-up contributions. For the plan year ended July 31, 2024 there was \$46,212 of employer matching contributions, of which \$2,789 was funded from the forfeiture account. In addition, the Company may make additional discretionary contributions at the option of its board of directors. For the seven months ended July 31, 2024, there were no additional discretionary contributions.

- C. Participant Investment Options - Participants are allowed to invest in a variety of investment choices as more fully described in the Plan 's literature. Participants may change their allocations on a daily basis.
- D. Participant Accounts - Each participant's account is participant-directed in a limited choice of funds and is credited with the participant's contribution and allocations of (a) the Company's contribution, and (b) plan earnings, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- E. Notes Receivable from Participants - Participants may borrow from their fund accounts the lesser of \$50,000 or 50% of their vested account with a minimum loan of \$1,000. Loan transfers are treated as a transfer to (from) the investment fund and from (to) the participant notes receivable fund. Loan terms range from 1 to 5 years or up to 25 years if used to purchase a primary residence. The maximum number of loans that a participant may have in any 12-month period is two. The loans are secured by the vested balance in the participant's account and bear interest at the prime rate as published in the Wall Street Journal plus one percent. At July 31, 2024 there are no outstanding loans. Principal and interest are collected ratably through payroll deductions.
- F. Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of participants' accounts plus actual earnings thereon is based on years of continuous service, as defined by the Plan. Individuals acquire a vested interest in the Company's contribution based on years of service according to the following schedule:

G. Payment of Benefits - The Plan provides for distribution of accumulated benefits upon the death, disability, or retirement of participants. Benefits are limited to lump-sum distributions. Upon termination of service, participants are entitled to the value of accumulated benefits and investment income, subject to the vesting limitations, as described above.

A hardship withdrawal may be taken to satisfy an immediate and heavy financial need that cannot be satisfied from other financial resources. Hardship withdrawals are limited to the participant's vested account balance and may only be taken for reasons as defined in the plan document.

H. Forfeited Accounts - Forfeited nonvested accounts totaled \$-0- and \$3,493 at July 31, 2024 and December 31, 2023, respectively. Forfeited nonvested accounts are used to reduce the Company's contributions to the Plan and/or pay plan expenses. During the seven months ended July 31, 2024, \$34,658 was used to reduce the Company's contribution and/or pay plan expenses.

2. Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan were prepared on the accrual basis of accounting until January 1, 2024, at which time the Plan adopted the liquidation basis of accounting as a result of the Plan terminations described in Note 8.

Use of Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of July 31, 2024 and December 31, 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value) at December 31, 2023, and liquidation value for the periods beginning after January 1, 2024. There were no material differences in fair value and liquidation value for assets held by the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrator determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive contracts. Contract value is the relevant measurement for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation, as presented in the statement of changes in net assets available for benefits, includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan may be paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

4. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits until January 1, 2024, at which point the Plan began to value assets at liquidation value, although there was no material difference in fair value and liquidation value and all plan assets had been liquidated by July 31, 2024. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used when no Level 1 inputs are available and Level 3 inputs are used when no Level 2 inputs are available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of mutual funds are based on quoted net asset values (NAV) of the shares as reported by the fund. The mutual funds and money market funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Collective Investment Trusts

Valued at the NAV of units of the common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value.

Pooled Separate Accounts

Valued at the NAV of shares in each account held by the Plan at year end. The net asset value is not a publicly quoted price in an active market. The NAV, as provided by the insurance carrier, is used as a practical expedient to estimating fair value.

Gains and losses included in the statements of changes in net assets available for benefits for the years ended July 31, 2024 and December 31, 2023, are reported in net appreciation in fair value of investments.

The Plan's policy is to recognize transfers between Level 1 and Level 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended July 31, 2024 and December 31, 2023, there were no significant transfers between Level 1 and Level 2 or into or out of Level 3.

5. Investment Contracts with Insurance Company

The Plan entered into a fully benefit-responsive guaranteed investment contract with Principal. Principal maintains the contributions in a general account. The account is credited with contributions, earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal at a specified interest rate that is guaranteed to the Plan. The crediting interest rate ranged from 1.55% to 1.75% during 2024 and 2023. The crediting interest rate is based on a formula agreed upon by the issuer, which is updated semiannually. The fixed account does not permit the insurance company to terminate the agreement prior to the scheduled maturity dates.

The Plan's ability to receive amounts due in accordance with this fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the Plan's ability to transact at contract value with the issuer. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

6. Income Tax Status

The Plan adopted a non-standardized form of a prototype plan sponsored by Principal Life Insurance Company. The prototype plan has received an opinion letter dated June 30, 2020 from the Internal Revenue Service (IRS) as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Plan Termination

During 2024, the Plan Sponsor was acquired by Group 1 Automotive, Inc. Effective March 31, 2024, RRR, LLC 401(k) Plan was terminated under the provisions of ERISA, and all plan assets were distributed by July 31, 2024. Participants were given the option to take a cash distribution or rollover their funds into the Group 1 Automotive, Inc. 401(k) Savings Plan or an IRA. Any outstanding loans during the seven months ended July 31, 2024 were treated as a taxable distribution to the participant.

9. Party-In-Interest Transactions

The Plan invests money into various investments managed by Principal. Principal is the trustee as defined by the Plan during this year and, therefore, these transactions qualify as a party-in-interest transaction. As described in Note 2, the Company pays certain expenses related to plan operations. The Plan has a number of service providers. Such parties are parties-in-interest under ERISA. All of the party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

10. Subsequent Events

The plan has evaluated subsequent events through May 13, 2025, the date the financial statements were available to be issued.
