Notes to Financial Statements

Note 1: Description of Plan

The following description of Endries International Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan, which became effective on September 1, 2017, is a defined contribution plan covering all eligible employees of Endries International Inc. (the "Company") who have completed 90 days of service with the Company and are age 18 or older. Participants enter the Plan immediately upon meeting the service and age requirements. To be eligible for the Company's discretionary nonelective contributions, participants must be employed on the last day of the plan year and have completed at least 1,000 hours of service during the plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Those who become employees of the Company by reasons of merger or acquisition may be credited for all prior years of service for all purposes with the merged or acquired employer (to the extent credited under such prior employer's plan) as though they had been employees of the Company, as provided in such merger or acquisition agreement or plan merger agreement.

Contributions

Participants may contribute up to 100% of annual compensation, as defined in the Plan, on a pre-tax or Roth basis. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions allocated to predetermined Plan investments with a scheduled increase of 1% each year, not to exceed 15%, unless the participant elects otherwise.

The Company contributes a matching contribution equal to 100% of the first 2% and 50% of the next 3% of base compensation that a participant contributes to the Plan. Rollover contributions are not matched. Additional contribution amounts may also be contributed at the discretion of the Company. The Company made a matching contribution of \$1,608,875 for the year ended July 31, 2024. There were no discretionary nonelective contributions for the year ended July 31, 2024. Contributions are subject to certain Internal Revenue Service limitations.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions, and allocations of (a) the Company's discretionary nonelective contributions and (b) plan earnings (losses). Participant accounts are reduced by withdrawals and charged with an allocation of investment management fees and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary contributions, plus actual earnings thereon. Vesting in the Company's matching and discretionary nonelective contributions, plus actual earnings thereon, is based on years of continuous service. Participants vest at a rate of 20% per year beginning with the first year of service. Participants become fully vested after five years of service. Participants who terminate service with the Company because of death or disability become 100% vested in Company contributions.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from 1 to 5 years or up to 10 years for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the plan administrator. The interest rates on existing notes ranged from 4.25% to 9.50% at July 31, 2024. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service because of death, disability, retirement (age 65), or termination of employment, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or annual installments. In addition, hardship distributions out of the participant's voluntary contributions and Company matching contributions accounts are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2. Participants may withdraw from their rollover contributions at any time.

Forfeitures

At July 31, 2024 and 2023, there were forfeited nonvested accounts totaling \$20,169 and \$29,108, respectively. These accounts may be used to reduce future Company contributions or to pay administrative expenses of the Plan in accordance with the plan document. During the year ended July 31, 2024, Company contributions were reduced by \$130,246 from forfeited nonvested accounts.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses had been recorded as of July 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Note 2: Summary of Significant Accounting Policies (Continued)

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the distributions and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are allocated proportionately to plan participants based on their respective account balances and are included in net investment income in the accompanying statement of changes in net assets available for benefits. Certain investment-related expenses are included in net appreciation in fair value of investments, since they are paid through revenue sharing rather than a direct payment. All other expenses paid by the Plan are allocated proportionately to plan participants based on their respective account balances and are included in administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events through May 14, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would be used only if Level 1 or Level 2 inputs were not available. There were no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of July 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Mutual funds held in pooled separate accounts: Fair value is estimated using the NAV per unit by the issuer of the pooled separate accounts. Fair value is based on the fair value of the underlying investments held by the pooled separate accounts.

Note 3: Fair Value Measurements (Continued)

Common/collective trust fund: Valued at the NAV provided by the administrator of the fund using NAV as a practical expedient to estimate fair value. This practical expedient would not be used if it were determined to be probable that the fund would sell the underlying investments for an amount different than the reported NAV. The NAV's unit price is quoted on a private market that is not active; however, the unit price is based on underlying investments that are traded on an active market. Participant transactions (purchases and sales) may occur daily, and there are no restrictions as to the redemption of this fund or unfunded commitments at July 31, 2024.

Note 4: Investment Contract With Insurance Company

The Plan has entered into a fully benefit-responsive investment contract with Empower Annuity Insurance Company ("EAIC"). EAIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The general account issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Note 4: Investment Contract With Insurance Company (Continued)

As described in Note 2, because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. Contract value, as reported to the Plan by EAIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment option or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. The investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 5: Information Prepared and Certified by the Trustee and Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of July 31, 2024, including investments at fair value and the fully benefit-responsive investment contract at contract value, and notes receivable from participants at July 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended July 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC ("Empower"), the trustee of the Plan, and EAIC, the custodian of the Plan.

Note 6: Party-in-Interest Transactions

Morgan Stanley Global Banking Operations ("Morgan Stanley") is a nondiscretionary trustee of the Plan and acts as an investment advisor. Therefore, the fees paid to Morgan Stanley qualify as party-in-interest transactions. Fees paid by the Plan for investment management services amounted to \$134,016 for the plan year ended July 31, 2024.

Certain plan investments are managed by the Trustee and Custodian as mentioned in Note 5. Therefore, these transactions qualify as party-in-interest transactions. Fees incurred and paid by the Plan to EAIC for administrative expenses were \$98,449 for the year ended July 31, 2024. Certain fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments because they are paid through revenue sharing rather than a direct payment.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 7: Tax Status

The Plan has adopted a non-standardized pre-approved plan document with an IRS notification letter dated September 16, 2022, which states the document as then designed is in compliance with the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the letter, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
