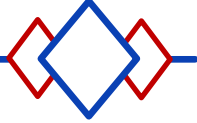

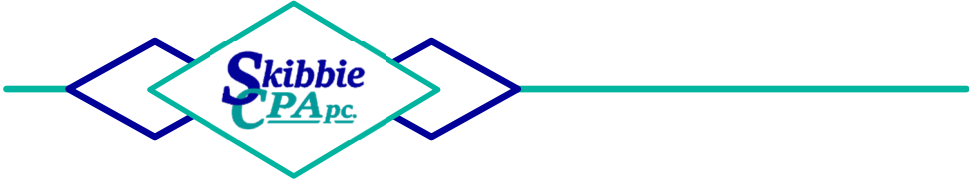

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of Commercial Service of Bloomington, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). - the information in the accompanying 2024 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

The accompanying statement of net assets available for benefits of Commercial Service of Bloomington, Inc. Retirement Plan as of December 31, 2023, and the related statement of changes in net assets available for benefits for the year then ended were not audited, reviewed, or compiled by us and, accordingly, we do not express an opinion or any other form of assurance on them.

Other Matter – Plan Termination and Liquidation

During 2024, management of the Plan decided to discontinue contributions to the Plan and adopted the Wealth Wise Retirement Plan PEP. As of October 31, 2024, all assets of the Plan were transferred to the Wealth Wise Retirement Plan PEP.

1. Description of Plan

The following description of the Commercial Service of Bloomington, Inc. Retirement Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General.

The Plan was a defined contribution plan covering all eligible employees, with the exclusion of union employees, leased employees, and non-resident aliens, of the Commercial Service of Bloomington, Inc. and Centered Capital Group, LLC (hereafter, collectively referred to as the “Company”) who had 1 year of service and were age 21 or older. Entry dates were semi-annual (the first day of the first month and of the seventh month) of the Plan year. The Plan was established on July 1, 1993 and was subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA) as amended.

Contributions.

Each year eligible participants could make pre-tax or Roth contributions from their eligible compensation, as defined by the Plan adoption agreement, up to a maximum of 90%, subject to applicable limits established by law. Participants who have attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover contributions).

The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 3% of eligible compensation upon initial eligibility. Auto enrolled contributions were invested in a designated fund until changed by the participant.

During 2024 and 2023, the Company provided a safe harbor non-elective contribution equal to 3% of a participant’s Plan compensation.

Each year, the Company could also make a discretionary matching or profit-sharing contribution. The Company did not make any such discretionary contributions for 2024 or 2023.

Participant and Company contributions were invested as directed by the participant in investment options offered by the Plan.

Plan termination.

During 2024, management of the Plan decided to discontinue contributions to the Plan and adopted the Wealth Wise Retirement Plan PEP. As of October 31, 2024, all assets of the Plan were transferred to the Wealth Wise Retirement Plan PEP.

1. Description of Plan (continued...)

Participant accounts.

Participants directed their account balance into various investment options offered by the Plan. Participant accounts were credited with the participant's contributions, the Participating Employer's contributions, if any, and investment earnings and/or losses and charged with the participant's benefit payments and applicable transactions charges, which were considered administrative expenses. Allocations were based on participant compensation, deferrals, or the earnings and losses of the participant's account balances, as defined. Income was allocated daily based on the number of shares or units in the participant's account. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting.

Participants were immediately vested in their contributions and the Company's safe harbor contributions plus actual earnings on the contributions. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon was based on years of continuous service as follows: less than 1 year = 0%, 1 to 2 years = 20%, 2 to 3 years = 40%, 3 to 4 years = 60%, 4 to 5 years = 80%, more than 5 years = 100%. A participant is 100 percent vested after 3 years of credited service or attaining the retirement age of 65, or upon death or disability.

Notes receivable from participants.

Participant loans were not permitted by the Plan.

Payment of benefits.

On termination of service, death, disability, or retirement, a participant, or their beneficiary, could elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. In-service withdrawals could be taken after attaining age 59-1/2. Withdrawals could also be made in conjunction with IRS hardship distribution regulations.

Forfeited accounts.

Forfeited nonvested accounts could be used to reduce future employer contributions or to pay Plan administrative expenses. Forfeited account balances were \$0 and \$1,834 as of October 31, 2024, and December 31, 2023, respectively

2. Summary of Accounting Policies

Basis of Accounting and Use of Estimates.

The financial statements of the Plan are prepared on the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition.

Plan investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants.

Participant loans were not permitted by the Plan.

Payment Benefits.

Benefits are recorded when paid, except for material corrective distributions which are accrued during the year in which the originating contributions were made. The Plan does not accrue non-distributed benefits related to participants who have withdrawn from the Plan.

Expenses.

Plan expenses paid directly by the Company are excluded from these financial statements. Fees charged directly to participant accounts are included in administrative expenses. Investment-related expenses are included in net appreciation of the fair value of investments.

Subsequent Events.

Plan management has evaluated events and transactions that occurred between October 31, 2024, and May 7, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

3. Information Certified by the Plan Custodian

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of October 31, 2024, and December 31, 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of October 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the ten months ended October 31, 2024 has been reported to the Plan and certified as complete and accurate by the Plan's custodian, John Hancock Life Insurance Company.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 31, 2024, and December 31, 2023.

Cash and cash equivalents: The carrying amounts for cash reflect the assets' fair value. The fair values for cash equivalent are determined based on quoted market prices. These assets are included in Level 1.

Pooled separate accounts: Investments in pooled separate accounts are valued using the unadjusted NAV as of the reporting date, which is the basis for current transactions. The NAV is used as a practical expedient to estimate fair value. Pooled separate accounts are valued based on the underlying investments (i.e., common stock, mutual funds, and short-term securities) in the separate account as reported by Principal Financial Group. While the majority of the underlying assets values are based on quoted prices, NAV of the pooled separate accounts are not publicly quoted.

Collective Trust Funds: Valued at the NAV of the units held by the Plan at year-end. The NAV, as provided by the trustee/custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require advance notification to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Investments Recorded at Contract Value

The Plan did not hold any investments recorded at contract value as of October 31, 2024, and December 31, 2023.

6. Rollover Contributions

The Plan may accept a rollover, provided the rollover will not jeopardize the tax-exempt status of the Plan or create adverse tax consequences for the Employer. The amounts rolled over shall be separately accounted for in a "Participant's Rollover Account." For purposes of this Section, the term Participant shall include any Eligible Employee who is not yet a Participant.

7. Related-Party Transactions and Party-in-Interest Transactions

Certain Plan investments are shares of pooled separate accounts or collective trust funds managed by John Hancock Life Insurance Company; the custodian as defined by the Plan. Fees incurred within these investments qualify as party-in-interest transactions. Investment fees paid to parties-in-interest are netted against investment returns.

During 2024, fees were also paid to Blue Benefits Consulting, Inc. and Baird Insurance Services, Inc. for their advisory and administrative services to the Plan. These fees include investment fees, third party administrative fees, and other professional service fees, and are based on customary charges as agreed upon by the Plan. These transactions qualify as party-in-interest transactions for which there is a statutory exemption. Certain administrative functions are performed by officers or employees of the Plan's sponsor. No such officer or employee receives compensation from the Plan.

8. Tax Status

Although the Plan has not received a determination letter from the Internal Revenue Service, it has adopted a pre-approved Prototype Plan. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified, and is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS/DOL. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of October 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

10. Reconciliation of Financial Statements to Form 5500

Certain differences may exist between the recording of accruals for financial reporting purposes and IRS/Department of Labor's (DOL) Form 5500 purposes. There were no such differences as of October 31, 2024, and December 31, 2023.

11. Termination and Liquidation of the Plan

During 2024, management of the Plan decided to discontinue contributions to the Plan and adopted the Wealth Wise Retirement Plan PEP. As of October 31, 2024, all assets of the Plan were transferred to the Wealth Wise Retirement Plan PEP.
