Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedules of Assets (Held at End of Year) and Delinquent Participant Contributions as of the year ended July 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of the Plan

The following description of The Taos Ski Valley, Inc. and Blanca Forestry Products 401(k) Plan ("Plan") provides only general information. The Plan sponsor is Taos Ski Valley, Inc. The Plan covers substantially all employees of Taos Ski Valley, Inc. and Blanca Forestry Products, Inc., which are members of a controlled group due to common ownership and are collectively referred to as the "employer". Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan providing retirement benefits to all eligible employees under the provisions of Section 401(k) of the Internal Revenue Code ("IRC"). Employees that are age 18 or older are eligible to participate after one month of service and can enter the plan immediately upon satisfying the eligibility requirements. Participants can change their deferral elections at any time as soon as administratively feasible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Contributions. Effective April 17, 2023, participants may contribute up to 85% of their annual compensation, not to exceed the limit as established annually by the Secretary of the Treasury, as pre-tax or Roth deferrals. Participants can change or discontinue their elected participant contribution percentages at any time. Prior to this amendment, participants could change their elected participant contribution percentages quarterly and could contribute up to 100% of their annual compensation. The IRC limits compensation for purposes of these computations and participant contributions are also subject to the results of discrimination testing. Excess contributions resulting from these limitations are required to be returned to the participants. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Safe Harbor Matching Contributions. The Plan provides for safe harbor matching contributions equal to 100% of salary deferrals that do not exceed 3% of compensation plus 50% of salary deferrals over 3% but not in excess of 5% of compensation are provided. Safe harbor matching contributions are contributed each payroll period. Participants are immediately eligible to receive safe harbor matching contributions upon completion 1,000 or more hours of service within any one-year period.

Participant Accounts. The Plan maintains individual investment accounts for each participant. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a common collective trust. Each participant's account is credited with the participant's contributions, allocations of the employer's contributions, and Plan earnings and is charged with an allocation of administrative expenses. Allocated amounts are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Under the current Plan, participants are fully vested in all account balances and immediately vested in all safe harbor matching contributions when received.

Forfeited Accounts. Forfeited balances may be used to reduce employer contributions or pay Plan administrative expenses. The balances of forfeited accounts at July 31, 2024 and 2023 were \$3,064 and \$5,529, respectively.

Notes Receivable from Participants. Participants may borrow from their accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. In no event will a participant be permitted to have more than two loans outstanding. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined by the Plan administrator. The term of the note may not exceed 5 years unless the loan is for the purchase of a principal residence.

Principal and interest is repaid ratably through payroll deductions, unless the participant terminates employment. If a Participant with an outstanding loan balance terminates employment, the outstanding principal and accrued interest on the loan will not be immediately due and payable. Instead, the loan will continue to be payable in accordance with the provisions of the promissory note.

Retirement Age. Normal retirement age under the Plan is 59½.

Payment of Benefits. Participants may withdraw the vested balance of their account upon retirement, disability, death or termination of employment. Participants may receive their distribution in lump sum or accounts may be rolled over into another IRS-approved tax deferral account. Hardship distributions are permitted on demonstration of financial hardship. All participants who have attained the age of 59½ years may request in-service distributions. At July 31, 2024, there were no participants who had elected to withdraw from the Plan but had not been paid.

Plan Termination. Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their employer contributions.

2. Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. The most significant estimate is the valuation of investments. Actual results may differ from those estimates.

Contributions

Plan contributions are recorded in the financial statements based on the date the related compensation was paid.

Investment Valuation and Income Recognition

Except for the common collective trust described below, the Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of the fair value measurements.

The inputs or methodologies to value securities are not necessarily an indication of risk associated with investing in those securities. There have been no changes in the methodologies used during 2024 and 2023.

One of the Plan's investments, the Galliard Stable Return Fund, is a common collective trust which primarily invests in fixed income portfolios that are wrapped by stable value contracts. The Plan reports its investment in the Galliard Stable Return Fund at fair value using the net asset value of the units held by the fund at year-end as a practical expedient. The Galliard Stable Return Fund does not invest directly in fully benefit-responsive contracts, and therefore the Plan is not required to include in the financial statements the disclosure requirements for investments in fully benefit-responsive contracts or stable value funds. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. There are no unfunded commitments or reserves as of July 31, 2024 and 2023.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation (depreciation) in fair value on the Plan's investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants.

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balances plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. No allowance for credit losses has been recorded at July 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

The Plan sponsor also pays certain administrative expenses on behalf of the Plan and provides certain administrative and accounting services to the Plan at no cost. Expenses relating to specific participant transactions (e.g., loan fees, distribution fees, etc.) are deducted directly from the participant's account. Other plan fees and administrative expenses, including commissions and fees connected with the general administration of the Plan, are paid from the assets of the Plan. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA and are reported as administrative expenses in the Statement of Changes in Net Assets Available for Benefits.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Recent Accounting Pronouncements

In June 2016, the FASB issued accounting guidance in ASU 2016-13, "Financial Instruments – Credit Losses" (Topic 326), to introduce a new model for recognizing credit losses on financial instruments based on an estimate of current expected credit losses. The new guidance was effective for fiscal years beginning after December 15, 2022, and the adoption of the standard did not have a significant impact on the financial statements.

3. Information Certified by the Plan Trustee

The Plan's investments are held and transactions executed therein by the trustee, Fidelity Management Trust Company ("Fidelity"). The Plan administrator has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits do not extend to any of Fidelity's prepared investment information that has been certified to be complete and accurate. The certified information includes the investments and notes receivables from participants reported in the accompanying Statement of Net Assets Available for Benefits as of July 31, 2024 and 2023 and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of July 31, 2024. The related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended July 31, 2024 was also certified by Fidelity.

4. Fair Value Measurements

Accounting standards provide a three-level hierarchy that prioritizes inputs to valuation techniques used to measure fair value and report financial assets and liabilities at fair value. The hierarchy is based on the observability and objectivity of pricing inputs, as follows:

- Level 1 Quoted prices for identical assets or liabilities in active markets accessible by the Plan.
- Level 2 Significant directly observable data (other than Level 1 quoted prices) or significantly indirectly observable data through corroboration with observable market data. Inputs would normally be (i) quoted prices for similar assets or liabilities in active markets, (ii) quoted prices for identical and similar assets or liabilities in inactive markets, (iii) inputs other than quoted prices that are observable for the asset or liability, or (iv) information derived from or corroborated by observable market data. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Significant unobservable inputs, therefore requiring an entity to develop its own assumptions.

Financial assets and financial liabilities are classified within the hierarchy based on the lowest level of any input that is significant to the fair value measurement. Valuation technologies used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The following describes the valuation methodologies used for the Plan's investments. There have been no changes in the methodologies used during 2024 and 2023.

Mutual Funds: The fair value is determined using the closing prices reported in the active market in which the securities are traded.

Common and Collective Trust: Using the market approach, the common and collective trust is valued at the net asset value per share based on the fair value of the underlying investment assets held in the common and collective trust on the last business day of the plan year. The shares of these accounts may be purchased or sold daily. There are no restrictions or notice requirements for participant transactions. Restrictions and notice requirements do apply in situations where the Plan desires to liquidate all the shares held in an account. The Plan makes no funding commitments to the common and collective trust.

The inputs or methodologies to value securities are not necessarily an indication of risk associated with investing in those securities. The valuation methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. In accordance with accounting standards, investments that are measured at net asset value are not classified in the fair value hierarchy.

5. Income Tax Status

The Plan adopted a prototype plan document that obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the volume-submitter plan is designed in accordance with the applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2020.

6. Party-in-Interest Transactions

Fidelity, the Plan trustee, provides administration and recordkeeping services to the Plan. Certain Plan investments are also managed by Fidelity. These transactions and investments qualify as allowable party-in-interest transactions under the provisions of ERISA. Fees paid to Fidelity during 2024 for investment management or administrative and recordkeeping services totaled approximately \$35,000.

7. Subsequent Events

Management has evaluated subsequent events through May 14, 2025, the date that the financial statements were available to be issued.
