Report on the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Opinion

Basis for Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. NOTE 1 - DESCRIPTION OF PLAN

The following description of the Thrive Mortgage, LLC 401(k) (the Plan) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

1. General

The Plan is a defined contribution plan covering substantially all employees of Thrive Mortgage, LLC (the Company) who have completed 90 days of service and attained the age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's trustees are responsible for oversight of the Plan. The investment committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's trustees.

2. Plan Merger

Effective March 1, 2024, all contributions to the Plan were suspended as the Plan was merged into the Lower, LLC 401(k) Profit Sharing Plan.

3. Contributions

Each year, participants may contribute before-tax and qualified Roth deferrals to the Plan, up to 90% of annual eligible compensation, as defined in the Plan documents. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation, and their contributions are invested in a designated balanced fund until changed by the participant. The deferral rate is increased by 1% each year, up to a maximum of 5%, of the participant's compensation.

The Company may elect to make discretionary matching contributions and discretionary profit sharing contributions. For the Plan period from January 1, 2024 through July 31, 2024, the Company matched 20% of the first 5% of eligible deferred compensation contributed to the Plan. The Company did not make any discretionary profit sharing contributions for the period from January 1, 2024 through July 31, 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

4. Participant Accounts

Each participant's account is credited with the participant's contribution and the Company's discretionary matching contributions and discretionary profit sharing contributions, as well as allocations of the earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan documents. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

5. Vesting

Participants are vested immediately in their contributions and previous Company safe harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary profit sharing and discretionary matching contribution portion of their accounts is based on continuous years of service. A year of service is defined as 1,000 hours of service during a plan year. A participant is 100% vested after three years of credited service.

6. Notes Receivable from Participants

Participants may borrow from their fund accounts at a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate will be prime rate plus 2.00%. Principal and interest is paid ratably through monthly payroll deductions.

7. Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or as installment payments over a specified period of time (annually, quarterly or monthly), not exceeding the participant's life expectancy or joint life expectancy with their designated beneficiary, or as part lump sum and part installment payments. For termination of service for other reasons, a participant may elect to receive a distribution as soon as administratively feasible. Vested account balances of \$5,000 or less shall be automatically distributed from the Plan as a lump sum distribution.

8. Forfeited Accounts

At July 31, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$0 and \$12,079, respectively. These accounts are to be used to pay future Plan expenses or meet future employer contribution obligations. During the period from January 1, 2024 through July 31, 2024, available forfeitures of \$61,531 and \$23,249 were used to reduce employer contributions and plan expenses, respectively.

9. Transfers Out of the Plan

During the period from January 1, 2024 through July 31, 2024, participant account balances totaling \$16,216,870 and forfeited non-vested accounts totaling \$8,989 were transferred from the Plan into Lower LLC 401(k) Profit Sharing Plan. Transferred amounts are reflected as transfer of assets out of the Plan on the statement of changes in net assets available for benefits.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

1. Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) as codified in the Financial Accounting Standards Board's (FASB) *Accounting Standards Codification* (ASC).

2. Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying the notes. Actual results could differ from those estimates.

3. Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the period from January 1, 2024 through July 31, 2024.

4. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses on the statement of changes in net assets available for benefits and are expensed when they are incurred.

5. Payment of Benefits

Benefits are recorded when paid.

6. Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses on the statement of changes in net assets available for benefits. Investment related expenses are included in net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

NOTE 3 - CERTIFIED INVESTMENT INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments and notes receivable from participants held at July 31, 2024 and December 31, 2023, and net appreciation in fair value of investments and interest income on notes receivable from participants for the period from January 1, 2024 through July 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company of New York (the Custodian and Insurance Company).

NOTE 4 - FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements* (ASC 820), defines fair value as the price that would be received upon sale of an asset or paid upon transfer of a liability in an orderly transaction between market participants at the measurement date and in the principal or most advantageous market for that asset or liability. The fair value should be calculated based on assumptions that market participants would use in pricing the asset or liability, not assumptions specific to the entity.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023. There were no assets measured at fair value as of July 31, 2024.

Pooled separate accounts: Valued at fair value based on the underlying investments held by the fund or similar instruments registered with the SEC, over-the-counter or other regulatory body. The underlying investments are valued based on readily determinable market prices.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Fair Value of Other Financial Instruments

Due to their short-term nature, the carrying value of short-term receivables approximate their fair value as of December 31, 2023. There were no short-term assets as of July 31, 2024.

NOTE 5 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as risk of foreign currency fluctuations relative to the U.S. Dollar, interest rate risk, credit risk, issuer going concern risk, and overall market volatility. During the period from January 1, 2024 through July 31, 2024, net appreciation in fair values of investments approximated \$1.4 million. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 - PLAN TERMINATION AND MERGER

The Plan was merged with the Lower, LLC 401(k) Profit Sharing Plan as of March 1, 2024, and ceased to exist as a separate plan as of July 5, 2024. Plan assets were transferred to the trustee of the Lower, LLC 401(k) Profit Sharing Plan in July 2024.

NOTE 7 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the Custodian and, therefore, these transactions qualify as party-in-interest transactions. Additionally, notes receivable from participants are considered party-in-interest transactions and are secured by the vested balances in the participants' accounts.

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments on the statement of changes in net assets available for benefits, as they are paid through revenue sharing, rather than direct payment. The Company pays directly any other fees related to the Plan's operations. These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

The Company pays certain Plan accounting and administrative fees. The Company incurred \$20,025 for accounting and administrative fees during the period from January 1, 2024 through July 31, 2024. These fees are not reflected in the accompanying financial statements.

NOTE 8 - TAX STATUS

The Plan adopted a prototype plan document sponsored by Nova 401(k) Associates, Inc. (Nova). Nova received an opinion letter from the IRS, dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since the prototype plan received the determination letter, the Plan's management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 - PROHIBITED TRANSACTIONS

As required by ERISA Section 2510.3-102, the Plan sponsor is required to segregate employee contributions to the Plan from its general assets as soon as practicable but in no event more than 15 business days following the end of the month in which amounts are withheld from wages. During the years ending December 31, 2022 and 2023, the Plan sponsor inadvertently failed to transmit \$201,987 and \$120,192, respectively, of participant contributions to the Plan within the required timeframes as noted above. These untimely employee contributions are considered prohibited transactions.

The Plan sponsor made an interest payment of \$660 to compensate the Plan for lost investment earnings relating to the prohibited transactions.

NOTE 10 - SUBSEQUENT EVENTS

The Plan's management has evaluated subsequent events through May 15, 2025, the date on which the financial statements were available to be issued.
