Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of August 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Notes to Financial Statements

1. Plan Description

The following description of Cascade Engineering, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, composed of both a profit-sharing and a retirement savings portion, which covers substantially all employees of Cascade Engineering, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility

Each employee of the Company is eligible to participate in the Plan through retirement savings and matching contributions immediately upon full-time employment as defined by the Plan, or the first month after the part-time employee completes one "Year of Participation Service," as defined in the Plan. Each eligible participant is eligible to receive employer discretionary contributions if: 1) they are employed on the last day of the Plan year (August 31) and have at least 1,000 hours of service during that Plan year, or 2) have a severance from employment during the Plan year as a result of retirement after reaching age 65, total disability, or death.

Contributions

Participants may contribute any amount or percentage of pre-tax annual compensation, as defined in the Plan, subject to certain limitations. Participants are automatically enrolled at 6%, unless the participant opts out or changes their deferral. Participants' deferral percentage will be automatically increased each September 1 by 1% up to a maximum of 10%. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or contribution plans.

The Company has elected to make safe harbor matching contributions to the Plan. The safe harbor match contribution is 100% of salary deferral contributions up to 3% of pay, plus 50% of salary deferral contributions from 3% to 5%. The Company may also elect to contribute discretionary contributions. There were no employer discretionary contributions for 2024 or 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of Company matching contributions, and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Employer discretionary contributions are allocated based on the ratio of a participant's points to aggregate participants' points for the year. Participants' points are allotted based upon years of service under the Plan and annual compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their account balances (including employer discretionary and matching contributions) into various investment options offered by the Plan.

Vesting of Benefits

Participants are immediately vested in their contributions, as well as the Company's matching and discretionary profit-sharing contributions, plus actual earnings thereon.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or separation, a participant may elect to receive benefits in a single lump-sum payment or installment distributions. Withdrawals may also be made upon attainment of age 59½ and under certain circumstances of financial hardship.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Company. In 2024 and 2023, certain administrative fees and fees resulting from participant-directed activities were paid by the Plan and allocated to participant accounts. In addition, certain Plan expenses have been offset by revenue-sharing income and, therefore, are not included on the statements of changes in net assets available for benefits.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared under the accrual method of accounting.

Subsequent Events

Subsequent events have been evaluated by management through March 21, 2025, the date these financial statements were available to be issued.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets and changes therein. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell

an asset (an exit price) in the principal or most advantageous market for the asset in an orderly transaction between market participants on the measurement date. See Note 3 for a discussion of fair value measurements.

The Plan's fully benefit-responsive investment contract (see Note 8) is valued at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes gains and losses on investments bought and sold, as well as held during the year.

Contributions

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

Payment of Benefits

Benefits are recorded when paid.

3. Fair Value Measurements

In accordance with Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, the Plan utilizes a fair value hierarchy for valuation inputs that gives the highest priority to quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The three levels of the fair value hierarchy are described as follows:

Level 1 - This level consists of inputs to the valuation methodology that are unadjusted quoted prices for identical assets in active markets.

Level 2 - This level consists of inputs to the valuation methodology that include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, and other inputs that are observable or can be corroborated by observable market data.

Level 3 - This level consists of inputs to the valuation methodology that are both significant to the fair value measurement and unobservable.

The following valuation methodologies were used to measure the fair value of the Plan's investments:

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Account (PSA) - This PSA is valued based on the underlying investments (i.e., common stock, mutual funds, short-term securities, and corporate bonds). While the majority

of the underlying asset values are based on quoted prices, the PSA is not publicly traded on an active market. The NAV is reported by the fund manager as of the financial statement date based on recent transaction prices and is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The PSA held by the Plan provides for daily redemptions by the Plan at reported NAV with no advance notice requirement. The Plan is permitted to redeem participation units at NAV on the valuation date. There are no unfunded commitments relating to these investments. The fund is a direct filing entity.

The Plan's valuation methods may result in a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Although Plan management believes the valuation methods are appropriate and consistent with the market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Information Certified by Qualified Institutions

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments held as of August 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividend income for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company (Principal) and Massachusetts Mutual Life Insurance Company (MassMutual), qualified institutions.

5. Related Party Transactions

Certain Plan investments are in funds and accounts managed by Principal, the trustee and contract holder of the Plan. The Plan also invests in a guaranteed investment contract managed by MassMutual, a contract holder of the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for trustee and record-keeping services amounted to

approximately \$104,000 and \$99,000 in 2024 and 2023, respectively. Other expenses paid by the Plan include accounting and investment advisory fees.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of termination, the trust is to continue under the provisions of the Plan, and accounts of affected participants will be segregated and distributed by the trustee, as directed by the administrative committee.

7. Tax Status

The Plan uses a pre-approved plan document sponsored by Miller Johnson. Miller Johnson received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there currently are no audits for any tax periods in progress.

8. Investment Contract with Insurance Company

The Plan has entered into a traditional fully benefit-responsive investment contract with MassMutual. The Separate Account Guaranteed Interest Contract (SAGIC) maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by the SAGIC. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The separate account guaranteed SAGIC contract is fully benefit-responsive; contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options, or (3) Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, if the contract holder determines that such establishment, activation, amendment, or change has an adverse effect on the contract holder's administrative procedure or other investors with investment agreements in the same class as this

agreement or results in a financial loss to the contract holder. The Plan Administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.
