## **Independent Auditor's Report**

To the Plan Administrator

### **Opinion**

We have audited the financial statements of IPS Enterprises, Inc. 403(b) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of July 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended July 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of July 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended July 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of assets (Held at End of Year) and schedule of delinquent participant contribution as of July 31, 2024 are presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under Employee Retirement Income Security Act of 1974 (ERISA). Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules are fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### Note 1. Description of the Plan

The following description of the IPS Enterprises, Inc. 403(b) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all eligible employees of IPS Enterprises, Inc. (the Plan Sponsor). The Plan Sponsor, previously a governmental entity, was restructured to become a nonprofit 501(c)(3) entity. The Plan became subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Employees who are at least 18 years of age are automatically enrolled to make elective deferral contributions to the Plan equal to 4% of eligible wages, unless the employee elects an alternative deferral percentage or opts out of participation. Employees who normally work fewer than 20 hours per week or are classified as "students" are not eligible to participate.

#### **Contributions**

Each year, participants may contribute up to 100% of their eligible compensation to the Plan, up to the maximum allowable by the Internal Revenue Code (IRC). The Plan allows catch-up contributions for participants that attain the age of 50 up to the maximum allowable by the IRC. The Plan allows for Roth contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The employer makes matching contributions to the Plan equal to 100% of the participants' elective deferrals, up to 4% of eligible compensation. The employer contributed \$1,540,129 of matching contributions for the year ended July 31, 2024.

#### **Participant Accounts**

Participants direct the investment of their contributions into various investment options offered by the Plan. Each participant's account is credited with the participant's and employer's contributions, plan gains or losses, and applicable administrative expenses. Allocations of plan earnings and expenses are based on account balances.

Participants are immediately vested in their elective deferrals and employer matching contributions, plus actual earnings thereon.

#### **Risks and Uncertainties**

The Plan's investments are comprised of various mutual funds. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Note 1. Description of the Plan (Continued)

#### **Payment of Benefits**

On termination of service, death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's account, or by any other option approved by the Plan Administrator. Additionally, under certain circumstances of financial hardship, a participant is allowed to withdraw funds from the Plan. Small account balances may be automatically paid out at the discretion of the Plan Sponsor.

#### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000, or 50%, of their account balance. The loans are secured by the balance in the participant's account. Loans bear an interest rate which is determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

#### **Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right to terminate the Plan at any time. In the event of termination, the net assets will be allocated to participants as prescribed by ERISA and regulations issued pursuant thereto.

#### **Administrative Expenses**

Administrative expenses of the Plan may be paid by the Plan Sponsor or the Plan as provided in the Plan Document.

### Note 2. Summary of Significant Accounting Policies

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### **Contributions**

Contributions from plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Certain expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of July 31, 2024 or 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan Document.

#### **Tax Status**

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated March 31, 2017, stating that the form of the preapproved plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the preapproved plan document. However, The Plan Administrator believes the Plan is designed, and is being operated, in conformity with the applicable requirements of the IRC and therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America provide accounting and disclosure guidance about positions taken by a plan in its tax returns that might be uncertain. The Plan Administrator believes that it has appropriate support for any tax positions taken, and as such, does not have any uncertain tax positions that are material to the financial statements.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 Inputs other than the quoted prices included within the Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3 Inputs that are unobservable inputs for the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at July 31, 2024 and 2023.

*Mutual Funds* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Security Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money Market* - Valued at the quoted market prices on the available market.

The methods previously described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of July 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

#### Note 4. Prohibited Transactions

During the year ended July 31, 2024, the Plan Sponsor failed to deposit \$363,025 of participant contributions within the required timeframe as stated by the United States Department of Labor (DOL). The DOL considers late deposits to be prohibited transactions. The Plan Sponsor calculated lost earnings in the aggregated of \$1,245. These lost earnings will be deposited in May 2025 to compensate those participants for potential lost income due to the delays.

#### Note 5. Subsequent Events

The Plan Administrator has evaluated subsequent events through the date that the financial statements were available to be issued, May 13, 2025, and determined that no events required disclosure. No further subsequent events occurring after this date have been evaluated for inclusion in these financial statements.
