## **Report of Independent Auditors**

### ***Opinion***

**Notes to Financial Statements**

July 31, 2024 and 2023

**Note 1. Summary of Significant Accounting Policies**

**Method of Accounting** - The accompanying financial statements of Plumbers and Pipefitters Locals 502 & 633 Health and Welfare Trust Fund (the Plan) have been prepared using the accrual basis of accounting.

**New Accounting Pronouncement** - In June 2016, the Financial Accounting Standards Board (FASB) issued Accounting Standards Update (ASU) No. 2016-13, *Financial Instruments - Credit Losses* (Topic 326), which is effective for the Plan for the year ended July 31, 2024. This new standard provides financial statement users with more decision-useful information about the expected credit losses on financial instruments and other commitments to extend credit held by a reporting entity at each reporting date. The standard replaced the incurred loss impairment model with a methodology that reflects expected credit losses and requires consideration of a broader range of reasonable and supportable information to inform credit loss estimates. The standard had no material impact on the Plan's financial statements.

**Investments** - The investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell that asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Purchases and sales of the investments are reflected on a trade-date basis.

Dividend income is recorded on the ex dividend date. Interest income is recorded on the accrual basis.

**Contributions Receivable** - Employer contributions due and not paid prior to year end are recorded as contributions receivable. Employer delinquencies and payroll compliance audit deficiencies are recognized upon settlement with the employer. An allowance for uncollectible accounts is considered unnecessary and is not provided.

**Note 1. Summary of Significant Accounting Policies (continued)**

**Property and Equipment** - Property and equipment are carried at cost. Major additions are capitalized while replacements, maintenance and repairs which do not improve or extend the lives of the respective assets are expensed currently. Depreciation and amortization are computed by the straight-line method over the following estimated useful lives of the related assets:

Leasehold improvements	3 years
Office furniture and equipment	7 - 10 years

Depreciation and amortization expense was \$828 for each of the years ended July 31, 2024 and 2023.

Use of the property and equipment is shared by the Plan and the related pension and 401(k) plans. The Plan is reimbursed for its proportionate share of all costs and expenses related to the property and equipment.

**Benefit Obligations** - Benefit obligations are estimated by the Plan's actuary in accordance with accepted actuarial principles, based on claims experience, Plan benefits and other data as considered necessary.

The obligation for accumulated eligibility credits represents an estimate of claims which will be due the following year for participants credited with sufficient hours prior to July 31 to maintain eligibility after year end.

**Revenue Recognition** - Revenue derived from employer contributions is recognized in the period in which covered work is performed, based on the number of hours worked in covered employment and the contribution rates set forth in the collective bargaining agreement. Employers are required to remit contributions monthly. The Plan carries out its purpose as described in Note 2 in the plumbing and pipe fitting industry, within a jurisdiction primarily located in the Kentuckiana region, as well as certain other counties in Kentucky.

## **Note 1. Summary of Significant Accounting Policies (continued)**

**Reciprocal Contributions** - The Plan is signatory to reciprocity agreements with various other multiemployer health and welfare plans for its participants who perform work outside the geographic jurisdiction of the local unions. Participants who are normally employed within the territory of one local union (home local) may be temporarily employed within the territory of another local union (reciprocating local). When a participant of the home local works in the territory of a reciprocating local, the latter is to make contributions to the former's fringe benefit plans on the participant's behalf. Monies received by the Plan on behalf of persons from outside participating local unions are forwarded to their home local fringe benefit plans. The Plan uses the same recognition and measurement criteria for contributions received on behalf of its participants under the terms of reciprocity agreements, as for all other employer contribution revenue. Amounts paid to other plans under the terms of reciprocity agreements are not reflected in the statements of changes in net assets available for benefits, as the amounts received are not revenue earned by the Plan, and the corresponding payments are not an expense of the Plan. The Plan recognizes a liability upon receiving reciprocal contributions on behalf of non-participants working within the jurisdiction of the local union, and recognizes a decrease in that liability upon remitting those contributions to the appropriate plan. Employer contributions included reciprocal contributions of \$1,049,931 and \$649,161 for the years ended July 31, 2024 and 2023, respectively, from various affiliated health and welfare plans under the terms of reciprocity agreements. The Plan remitted a total of \$13,550,056 and \$2,375,057 in reciprocal contributions to various affiliated health and welfare plans under the terms of reciprocity agreements for the years ended July 31, 2024 and 2023, respectively.

**Health Reimbursement Accounts** - Included in net assets available for benefits are amounts available to reimburse participants for qualifying medical expenses under a Health Reimbursement Arrangement (HRA). At July 31, 2024 and 2023, HRA accounts totaled approximately \$15,832,000 and \$13,554,000 respectively. Claims payable from the HRA accounts totaled \$13,700 and \$3,200 at July 31, 2024 and 2023, respectively.

**Benefits** - All benefits except for life insurance, accidental death and dismemberment (AD&D), and Medicare retiree medical and dental benefits are paid by the Plan on a self-funded basis. The benefits paid by the Plan on a self-funded basis include medical, prescription drug, certain vision and short-term disability benefits. Life insurance and AD&D benefits are provided through insurance contracts with ULLICO; Medicare benefits are provided through an insurance contract with United Healthcare; and dental benefits are provided through an insurance contract with Delta Dental.

**Subrogation Settlements** - Claims that are reimbursed pursuant to subrogation matters are recorded upon settlement. Subrogation matters involved third parties considered to be responsible for claims paid by the Plan from whom the Plan seeks reimbursement. For the years ended July 31, 2024 and 2023, subrogation recoveries totaling \$4,299 and \$22,768 respectively, have been netted with self-funded medical benefits paid in the accompanying statements of changes in net assets available for benefits.

## **Note 1. Summary of Significant Accounting Policies (continued)**

**Stop-Loss Insurance** - The Plan maintains a stop-loss arrangement in an effort to limit its exposure for self-insured benefits. During the years ended July 31, 2024 and 2023, under the terms of the contract, individual participant claims incurred within the contract year in excess of \$325,000 and \$310,000 respectively, are reimbursed to the Plan. For the years ended July 31, 2024 and 2023, stop-loss refunds totaling \$1,024,114 and \$161,831 respectively, have been netted with self-funded medical benefits paid in the accompanying statements of changes in net assets available for benefits.

**Prescription Drug Rebates** - The Plan utilizes a pharmacy benefit manager (PBM) who periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs. Refunds due from the Plan's PBM are recorded when earned. For the years ended July 31, 2024 and 2023, prescription drug rebates totaling \$3,810,623 and \$2,967,322 respectively, have been netted with prescription drug benefits paid in the accompanying statements of changes in net assets available for benefits.

**Leases** - Lease arrangements for office space with related parties are described in Note 9. Due to the immaterial nature of the amounts owed pursuant to the leasing agreements, the Plan has not adopted the provisions of accounting guidance for leases required by generally accepted accounting principles.

**Expenses** - Certain investment related expenses are included in net appreciation in fair value of investments.

**Estimates** - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

**Subsequent Events** - Subsequent events have been evaluated through May 14, 2025, which is the date the financial statements were available to be issued.

## **Note 2. Description of the Plan**

The Plan was established pursuant to collective bargaining agreements to provide health care benefits for eligible participants and their dependents, on both an insured and self-insured basis. The Plan is a multiemployer welfare plan, subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

## **Note 2. Description of the Plan (continued)**

To become initially eligible for benefits, participants must be employed by a contributing employer or employers and working within the jurisdiction of the Plan and must be credited with contributions of 130 hours in the preceding work month. Once a participant becomes initially eligible, eligibility continues for three months. Quarterly coverage continues provided the participant is credited with a minimum of 375 hours during the immediately preceding work quarter, or 1,500 hours during the immediately preceding four consecutive quarters. A participant who fails to meet the hours requirement may elect to continue coverage through self-pay contributions. Retirees are also permitted to make self-payments to the Plan to maintain coverage.

The Plan also offers a Health Reimbursement Arrangement (HRA) program. An HRA is an account the Plan establishes and maintains on behalf of participants to keep track of contributions, reimbursements and a participant's available balance. Each HRA is funded exclusively through contributions made on a participant's behalf by an employer that contributes to the Plan under a collective bargaining or participation agreement. The amount of contributions is determined by the Board of Trustees and is subject to change or discontinuance at any time. Participants are not vested in the contributions made on their behalf and their available balance may be used only for certain health care expenses that are not otherwise covered under the Plan, or to make self-payments to maintain eligibility. No earnings are credited to a participant's HRA. The HRA benefit to which a participant is entitled is the benefit that can be provided from the participant's HRA account. HRA balances will be forfeited if a participant opts out of the HRA program in writing at any time, or upon death if there is no surviving spouse or dependent. If coverage under the Plan terminates, balances will not automatically be forfeited. However, the Plan will deduct the cost of administration from the HRA balance until eligibility is reinstated. No HRA accounts were forfeited during the years ended July 31, 2024 and 2023.

The Plan also provides benefits for pre-apprentices. Under current provisions of the Plan, pre-apprentices and their dependents are eligible for medical, prescription drug, death, AD&D, and disability benefits. Pre-apprentices obtain initial eligibility under the same requirements as all other participants.

The Plan also provides health care benefits to eligible participants through a health center located in Louisville, Kentucky. The health center was established to provide participants with health clinic and wellness programs, including preventative, wellness, disease management, health consultation, occupational health and primary care services. The Plan entered into an agreement with Proactive MD whereby the Plan pays a monthly per capita fee to cover costs incurred at the health center. During the years ended July 31, 2024 and 2023, the Plan paid Proactive MD a total of \$680,134 and \$586,787 respectively, for fees related to the health center. As described in Note 9, the Plan entered into a leasing arrangement for the health center with Crittenden Drive Holdings, LLC, a wholly owned entity of Plumbers, Pipefitters & Service Technicians of the United Association Local 502 (Local 502).

**Note 2. Description of the Plan (continued)**

Continuation of health care benefits to persons who would otherwise lose those benefits due to certain events, as mandated by Consolidated Omnibus Budget Reconciliation Act (COBRA) was adopted by the Plan.

Participants should refer to the summary plan descriptions for more complete information.

**Note 3. Priorities upon Termination**

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy or make provisions to satisfy the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will in the opinion of the Trustees bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for or diverted to purposes other than the exclusive benefit of the participants.

**Note 4. Tax Status**

The Plan has obtained a notice of exemption in which the Internal Revenue Service stated that the trust established under the Plan, as then designed, was in compliance with the applicable requirements of Section 501(c)(9) of the Internal Revenue Code. The Plan has been amended since receiving the notice of exemption. The Trustees of the Plan and legal counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. They therefore believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 5. Funding Policy**

The Plan is primarily funded by contributions from employers and participants. Employer contributions to the Plan are made under various negotiated collective bargaining agreements. The hourly contribution rate for the years ended July 31, 2024 and 2023 was predominantly \$10.31 and \$9.91 respectively.

**Note 5. Funding Policy (continued)**

Participants are allowed to self-pay contributions for hours needed to extend eligibility for benefit coverage. Participant self-payment rates are the difference between the required 375 hours and the number of hours that have been paid on the participant's behalf in the corresponding work quarter. Participant contributions are also allowed to provide benefits under COBRA. COBRA monthly rates for the years ended July 31, 2024 and 2023 ranged from \$1,202 to \$2,306 depending on the participant's coverage option.

Eligible retired participants are allowed to self-pay monthly contributions for benefit coverage. Retiree self-payment monthly rates for the years ended July 31, 2024 and 2023 ranged from \$237 to \$1,935 depending on the retiree's coverage option.

**Note 6. Concentration of Cash**

The Plan places its cash with financial institutions deemed to be creditworthy. Balances are insured by the FDIC up to \$250,000 per financial institution. At July 31, 2024, the Plan's cash exceeded federally insured limits by approximately \$8,563,000.

**Note 7. Fair Value Measurements**

The *Fair Value Measurements and Disclosures* Topic of the FASB Accounting Standards Codification established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 7. Fair Value Measurements (continued)**

The following tables set forth, by level within the fair value hierarchy, the Plan's investment assets at fair value as of July 31, 2024 and 2023. As required, assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. In accordance with generally accepted accounting principles, certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the following tables are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

## **Note 7. Fair Value Measurements (continued)**

### Level 1 Measurements

The fair value of the mutual fund is determined by reference to the fund's underlying assets, which are principally marketable equity securities. Shares held in mutual funds are traded on national securities exchanges and are valued at the net asset value as of the last business day of each period presented.

### Level 2 Measurements

Corporate bonds are generally valued by benchmarking model-derived prices to quoted market prices and trade data for identical or comparable securities. To the extent that quoted prices are not available, fair value is determined based on a valuation model that includes inputs such as interest rate yield curves and credit spreads. Securities traded in markets that are not considered active are valued based on quoted market prices, broker or dealer quotations, or alternative pricing sources with reasonable levels of price transparency. Securities that trade infrequently and therefore have little or no price transparency are valued using the investment manager's best estimates.

The short-term investment fund is valued at cost, which approximates its fair value.

### Measurements Using Net Asset Value as a Practical Expedient

The common collective trusts are valued at the net asset value per share, used as a practical expedient to estimate fair value. The net asset value is based on the fair values of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value.

The common collective trusts are direct filing entities (DFEs) that file a Form 5500 annual report with the U.S. Department of Labor. The Plan is not required to disclose the investment strategies of DFE investments. Redemptions of the common collective trusts are available monthly or quarterly. Notice periods range from 0 to 15 days.

## **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits. The current economic environment has increased the degree of uncertainty.

## **Note 8. Risks and Uncertainties (continued)**

Due to inherent uncertainties involved in the valuations of investments that are not publicly traded, estimated fair values may differ materially from the values that would have been used had a ready market for the underlying securities existed.

As of July 31, 2024 and 2023, the Plan held units in the Vanguard Total Stock Market Index Fund with a fair value of \$20,309,448 (approximately 29% of net assets) and \$14,069,159 (approximately 26% of net assets), respectively. As of July 31, 2024 and 2023, the Plan held units in NIS Intermediate Fixed Income QP Fund with a fair value of \$28,764,558 (approximately 42% of net assets) and \$23,662,350 (approximately 44% of net assets), respectively. It is reasonably possible that changes in the fair values of these funds could materially affect the amounts reported in the statements of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

## **Note 9. Related Organizations**

The Plan has a number of related organizations including two local unions, a pension plan and a 401(k) plan, all of which are tax-exempt.

### Shared Expenses

The Plan shares facilities, equipment and staff with the related pension and 401(k) plans on a direct and pro-rata basis. These expenses are allocated based on estimated time, utilization and actual costs. Shared administrative expenses allocated to the Plan for the years ended July 31, 2024 and 2023 totaled \$352,546 and \$306,912 respectively. In relation to these shared expenses, the Plan owed the related pension plan \$4,035 at July 31, 2024. The related pension plan owed the Plan \$8,945 at July 31, 2023. In addition, at July 31, 2024, one of the related local unions and the related 401(k) plan owed the Plan \$29,181 and \$652 respectively, and at July 31, 2023, \$19,591 and \$307 respectively.

### Leases

#### *Office Space*

The Plan leases shared office space under a noncancellable operating lease with Crittenden Drive Holdings, LLC, a wholly owned entity of Local 502. The lease, which expired on June 30, 2024, and was renewed for a three-year term through June 30, 2027, requires the Plan to pay monthly rental payments of \$2,519. The Plan's allocated portion of rental expense for this lease for the years ended July 31, 2024 and 2023 was \$27,598 and \$28,260 respectively, and is included in the shared expenses described previously.

## Note 9. Related Organizations (continued)

### Leases (continued)

#### *Health Center*

As described in Note 2, the Plan leases space from Crittenden Drive Holdings, LLC to be utilized for purposes of a health center. The lease, which expired on June 30, 2024 and was renewed for a three-year term through June 30, 2027, requires the Plan to pay monthly rental payments of \$2,187. Rental expense for this lease for each of the years ended July 31, 2024 and 2023 was \$26,762.

### Lockbox Account

The Plan maintains a lockbox account. Contributions for the Plan and other affiliated organizations are received and deposited in the lockbox account. On a regular basis, contributions due to the related organizations are transferred from the lockbox account to the appropriate organization.

Lockbox contributions not yet remitted at year end are reflected as a liability in the statements of net assets available for benefits.

## Note 10. Postretirement Benefit Obligations

The postretirement benefit obligation represents the total actuarial present value of those estimated future benefits that are attributed to employee service rendered to July 31, reduced by the actuarial present value of contributions expected to be received in the future from current plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with the participating employers. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service in the industry rendered to the valuation date. Postemployment benefit obligations consist of COBRA and medical benefits for active and inactive participants.



## **Note 10. Postretirement Benefit Obligations (continued)**

Valuation assumption changes increased obligations by \$26,381,303 for the year ended July 31, 2024. This increase was primarily due to updating the trend on future costs and contributions, including the estimated impact of the Inflation Reduction Act on MAPD premiums. Other changes include updating valuation-year per capita health costs, updating the retiree contribution rates, and increasing the discount rate from 4.75% to 5.25%. The discount rate is reset each year based on the rates of return on high-quality fixed income investments currently available as of the valuation date whose cash flows match the timing and amount of expected benefit payments.

Valuation assumption changes decreased obligations by \$548,436 for the year ended July 31, 2023. This decrease was primarily due to increasing the discount rate from 4.00% to 4.75%. The discount rate is reset each year based on the rates of return on high-quality fixed income investments currently available as of the valuation date whose cash flows match the timing and amount of expected benefit payments.

A Plan amendment increased obligations by \$287,218 for the year ended July 31, 2024. This increase was due to decreasing the in-network specialist office visit copay for non-Medicare retirees from \$50 to \$25.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

The costs of postretirement benefits are shared by the Plan's participating employers and retirees. The cost of the postretirement benefits is estimated annually by the Plan's consulting actuary. The Plan's Trustees then periodically adjust the portion to be paid by the participants. Retiree contributions are projected to cover approximately 60% and 66% of the estimated present value of the postretirement benefits as of July 31, 2024 and 2023, respectively.

The Plan's deficiency of benefit obligations over net assets relates primarily to the postretirement benefit obligation, the funding of which is not covered by the contribution rate provided by the current collective bargaining agreements. However, the Plan empowers the Board of Trustees to increase or decrease the amount of self-payments by eligible retired participants, and to modify the terms and conditions under which retiree eligibility may be maintained; therefore, the cost to the Plan can be reduced or eliminated prospectively by action of the Board of Trustees.

### Note 11. Major Employers

During the year ended July 31, 2024, contributions from four employers accounted for approximately 59% of the total employer contributions collected. During the year ended July 31, 2023, contributions from two employers accounted for approximately 25% of the total employer contributions collected. In the event these employers were to suspend contributions, the Plan would terminate coverage to the employers' participants as outlined in the Plan document. The Plan would retain the risk of meeting current fixed administrative expenses until the appropriate adjustments were made.
