### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Gastrointestinal Specialists, AMC 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ### **Notes To Financial Statements July 31, 2024 and 2023**

#### **NOTE A – DESCRIPTION OF THE PLAN**

The following description of the Gastrointestinal Specialists, AMC 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **[1] General**

The Plan is a defined contribution plan covering all employees of Gastrointestinal Specialists, AMC (the Employer or the Company) who have completed at least 500 hours of service during the first 6 months of employment, are age twenty-one or older, are not a member of a union collective bargaining unit, and are not a nonresident alien. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **[2] Contributions**

Each year, participants may elect to defer up to the maximum percentage of compensation permissible under the Internal Revenue Code; these amounts are contributed to the Plan on the employees' behalf. The Plan also allows contributions to be in the form of Roth 401(k) contributions; these contributions are treated as includible in the participant's taxable income at the time the compensation would have been received. Participants who have attained the age of fifty before the end of the Plan year are also eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer will make a safe harbor matching contributions to eligible participants each Plan year equal to 100% of the first 3% and 50% of the next 2% of eligible compensation that a participant contributes into the Plan. Contributions are subject to certain IRS limitations.

If the participant was employed by the Company on the last day of the Plan year and completed at least 1,000 hours of service during the year, the participant is eligible for an Employer profit sharing contribution, if declared by the Board of Directors of the Employer. For the year ended July 31, 2024, the profit sharing contribution totaled \$1,014,519.

#### **[3] Participant accounts**

Each participant's account is credited with (a) the participant's contribution, (b) the Employer's matching contribution, (c) the Employer's profit sharing contribution (if any) and (d) an allocation of the Plan's earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **[4] Vesting**

Participants are vested immediately in their contributions and the Employer safe harbor matching contributions, plus actual earnings thereon. Vesting in the Employer profit sharing contributions is based on completed years of continuous service, and a participant is 100% vested in their portion of the Employer profit sharing contribution after six years of service as further described in the plan document.

#### **[5] Payment of benefits**

Upon termination of service due to death, disability, retirement, or separation of service, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

#### **NOTE A – DESCRIPTION OF THE PLAN (CONTINUED)**

##### **[6] Forfeitures**

Forfeited nonvested accounts may be used to reduce future Company contributions. During the year ended July 31, 2024, forfeitures of approximately \$19,091 was used to reduce employer contributions. Forfeited nonvested accounts available at July 31, 2024 and 2023 were approximately \$27,621 and \$19,091, respectively.

#### **NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### **[1] Basis of accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

##### **[2] Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

##### **[3] Investment valuation and income recognition**

The Plan's investments are reported at estimated fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **[4] Payment of benefits**

Benefits are recorded when paid.

##### **[5] Plan expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Expenses for items such as record keeping are allocated to participants. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

##### **[6] Subsequent events:**

The Plan has evaluated subsequent events through May 15, 2025, the date the financial statements were available to be issued.

#### **NOTE C – INFORMATION PREPARED AND CERTIFIED BY THE QUALIFIED INSTITUTION**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Vanguard Fiduciary Trust Company, has certified to the completeness and accuracy of all investments and related investment activity in the accompanying statements of net assets available for benefits as of July 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended July 31, 2024 and the accompanying supplemental schedule of assets (held at end of year) as of July 31, 2024.

#### NOTE D - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board's Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at July 31, 2024 and 2023.

*Mutual funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money market funds* – Valued at one dollar per share held by the Plan at year end. Money market funds held by the Plan are mutual funds invested in highly liquid, near-term instruments and are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The money market funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan administrator believes the valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE E - TAX STATUS

The Plan has adopted the Vanguard Group Non-standardized Pre-Approved Profit Sharing with CODA prototype plan. On June 30, 2020, the Internal Revenue Service ("IRS") stated in an opinion letter that the prototype adopted by the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC") and, therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management of the Plan to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of July 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE F - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain investments are managed by Vanguard Fiduciary Trust Company (Vanguard); and therefore, transactions related to these investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA. The Plan paid administrative fees to Vanguard, which totaled \$2,906 for the year ended July 31, 2024.

#### NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at July 31, 2024, may not necessarily be indicative of amounts that could be realized in a current market exchange.

#### **NOTE H - MUTUAL FUND FEES**

Certain investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940. These annual fees are used to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity, and thus not separately identifiable as an expense.

#### **NOTE I – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their portion of the Employer profit sharing contributions.

#### **NOTE J - NONEXEMPT PARTY-IN-INTEREST TRANSACTION.**

During the year ended July 31, 2024, it was discovered that certain amounts withheld were not timely remitted to the Plan. The Plan administrator deposited \$6,442 into the Plan on March 13, 2024, which includes earnings of \$89, in order to make the affected participants whole.

#### **NOTE K - PLAN OPERATIONS**

During the year ended July 31, 2024, errors were made in the Company's payroll processing system, and therefore the amount of eligible plan compensation, for some of the Plan participants, is incorrect. These errors were the inappropriate inclusion of expense reimbursements and the inappropriate exclusion of some bonus amounts. As a result, some participant and employer contributions for the year were not properly calculated as per the Plan document. The Plan administrator is in the process of determining affected participants and intends to make the Plan whole for any amounts due, including applicable earnings. The amount due to the Plan is expected to be minor but has not yet been determined.
