NOTES TO FINANCIAL STATEMENTS

July 31, 2024 and 2023

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Lee's Pet Club, Inc. ("the Company") Profit Sharing Plan II ("the Plan") provides only general information. Employees of Red Cart Market, Inc. are also covered under this plan. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

General

The Plan is a defined-contribution plan covering all full-time employees of the Company. Employees are eligible to participate in the Plan on the first August 1st and February 1st that immediately falls on or after the date they have worked for the Companies for a period of twelve months, have at least 1,000 hours during that twelve month period, and are at least age twenty-one. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The amount of the Company's contribution will be made at the sole discretion of the Company. The Company reserves the right to reduce, suspend or discontinue contributions for any reason at any time. Contributions to the plan are made to a trust fund. The assets in the trust fund are invested in a pooled account directed by the Plan trustees and their advisors, if applicable.

Voluntary employee contributions are not permitted; however, participants may contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Contributions are subject to certain limitations as imposed by the Internal Revenue Service (IRS).

Participant Accounts

Each participant's account is credited with contributions and allocations of (a) the Company's contributions and (b) Plan earnings. Allocations are based on the allocation method for the Allocation Group to which a participant is assigned. The Allocation Group consists of Group 1 and Group 2. Contributions will be allocated to the participant based on ratio of that participant's compensation to the total compensation of that group. The Internal Revenue Service (IRS) has rules and regulations that require the plan to perform yearly tests to ensure that benefits provided to the employees in each group are similar on an average basis when measured as an equivalent value at the plan's normal retirement age.

The net income of the Plan will be allocated to participant accounts in accordance with such rules and procedures that are established by the plan administrator and that are applied in a uniform and nondiscriminatory manner.

Forfeited balances of terminated participants' nonvested accounts may be used by the plan administrator to pay administrative expenses incurred by the plan. The portion not used to pay administrative expenses will be used to restore (with certain limitations) previous forfeitures of rehired participants and, if any forfeitures still remain, reduce future Company contributions.

Vesting

Vesting percentage is determined under the following schedule, based on Years of Service.

Benefits automatically become 100% vested upon death or disability. Benefits also become 100% vested when a participant reaches the Plan's Normal Retirement Age (65) or the 5th anniversary of plan participation, if later.

The Plan does not allow participant loans.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may elect to receive the value of the vested interest in his or her account as a lump-sum distribution, subject to premature withdrawal penalties, if any. Terminating participants may elect to rollover such distributions to another tax deferred plan.

Forfeited Accounts

For the years ended July 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,117 and \$3,732 respectively. The accounts will be used to offset administrative expenses, restore previous forfeited accounts for returning participants or reduce future employer contributions.

NOTE B – SIGNIFICANT ACCOUNTING POLICIES

Accounting Method

The financial statements were prepared using accrual method of accounting. This method, which recognizes receivables and payables, results in the recognition of income when earned and expenses when incurred.

Use of Estimates

The preparation of financial statements, in conformity with accounting principles generally accepted in the United States of America, requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for a discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investment bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan can be paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Subsequent Events

The Plan has evaluated subsequent events through May 14, 2025 the date the financial statements were available to be issued.

NOTE C – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FAS ASC 820 are described below:

Level 1 -

Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 -

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 -

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for asset measured at fair value. There have been no changes in the methodologies used at July 31, 2024 and 2023.

Registered Investment Companies and Exchange Traded Funds -

Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

Common Stock -

Valued at the closing price reported on the active market in which the individual securities are traded.

Money Market Funds -

Valued at cost which approximates fair value.

Limited Partnership –

The value of the limited partnership represents the ownership interest in the net asset value (NAV) of the partnership. Audits of the limited partnership are prepared on a calendar year basis. At July 31, 2024 and 2023, 99% of the investments held by the limited partnership were Level 1 assets and 1%, Level 2.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE F - TAX STATUS

The Internal Revenue Service has determined and informed the Company by letter dated March 31, 2008, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirement of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or the Department of Labor. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in question.
