Scope and Nature of ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Car Group 401(k) Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of July 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended July 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Note 1. Plan Description

The following description of The Car Group 401(k) Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by Norm Reeves, Inc. (Company) effective August 1, 1988 for the benefit of eligible employees of Norm Reeves, Inc.; Coastal Auto Sales, Inc.; West Covina Auto Retail, Inc.; Cerritos Auto Retail Company, Inc.; Cerritos Auto Retail Company 3, Inc.; Conant Auto Retail, San Diego, Inc.; Parkway Premium Motors, Inc.; Port Charlotte Auto Retail, Inc.; Irvine Auto Retail I, Inc.; Irvine Auto Retail II, Inc.; Vista Auto Retail, Inc.; Modernity Equity Holdings Little Hills, Inc.; First Book Equity Holdings Little Hills, Inc.; Saxet Equity Holdings Goldmound, Inc.; Saxet Equity Holdings Stonedyke, Inc.; and Conant Auto Resources, LLC who have a minimum of six months of service and are age 21 or older. Participants may enroll in the Plan on the first day of the month following completion of the eligibility requirements. VOYA Retirement Insurance and Annuity Company (VOYA) serves as the custodian and record keeper for the Plan. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Contributions

Each year, participants may contribute compensation, as defined in the plan document, subject to Internal Revenue Code (IRC) limitations. The Plan allows for Roth 401(k) (after-tax) salary deferrals along with traditional 401(k) (pretax) deferrals. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 3.00% of eligible compensation, with an annual increase of 1.00% up to a maximum of 10.00%. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The plan sponsor may elect to make discretionary non-elective and/or matching contributions to the Plan. The Company matched 25.00% of the participants' elective contributions up to a maximum of \$1,000 per participant. Matching contributions are contributed to the Plan each payroll period. No additional discretionary contributions were made to the Plan in 2024.

Investment Options

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers a variety of pooled separate accounts and a fixed interest account.

Participant Accounts

Each participant account is credited with the participant's contribution, the Company's contributions, and allocation of the Plan's earnings (losses) and charged with benefit payments, transaction fees related to notes receivable from participants and distributions, and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100.00% vested after five years of credited service.

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50.00% of their vested account balance. The loans are secured by the balance in the participant's account and

bear interest at rates that are commensurate with local prevailing rates, as determined by the plan administrator. At July 31, 2024, outstanding loans bore interest rates from 5.25% to 10.50%. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in their account in either a lump-sum amount or various installment options as provided by the Plan. Hardship distributions are permitted upon demonstration of financial hardship. All fully vested balances are available for distribution after the participant reaches the age of 59.5 years.

Forfeitures

At July 31, 2024 and 2023, forfeited nonvested accounts totaled \$350,817 and \$210,236, respectively. These accounts will be used to reduce employer contributions or pay administrative expenses. During 2024, no forfeitures were used to reduce employer contributions or pay plan expenses.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared under the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded upon distribution.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the plan sponsors, as provided by the plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (notes receivable from participants and distributions) are charged directly to the participant's account.

Subsequent Events

The Plan has evaluated subsequent events through May 15, 2025, the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

Fair value as defined under GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices included within level 1 that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at July 31, 2024 and 2023.

Pooled Separate Accounts

The Plan invests in pooled separate accounts for which quoted prices are not available in active markets for identical instruments. The Plan utilizes the net asset value (NAV) of units, as determined by VOYA as the estimated fair value. Because quoted prices in active markets for identical assets are not available, these prices are determined using observable market information, such as quotes from less active markets and/or quoted prices of securities with similar characteristics.

The Plan held no investments within the fair value hierarchy as of July 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4. Fully Benefit-Responsive Fixed Interest Account

The Plan has a guaranteed investment contract (fixed interest account) with VOYA that totaled \$6,731,010 and \$8,179,837 as of July 31, 2024 and 2023, respectively. VOYA maintains contributions in a general account. The account meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. The account's issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The account is a traditional investment contract under which the Plan owns only the contract itself. Traditional investment contracts are designed to accrue interest based on credit rates established by contract issuers.

The traditional investment contract held by the Plan is a guaranteed investment contract. There are no reserves against contract value for credit risk of the contract issuers or otherwise. The crediting interest rate is based on a formula agreed upon with the issuers. Such interest rates are reviewed on an annual basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with issuers. Such events include the following: 1) amendments to the plan document (including complete or partial plan termination or merger with another plan), 2) changes to the Plan's prohibition on competing investment options, 3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or 4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Examples of such events include the following: 1) an uncured violation of the Plan's investment guidelines, 2) a breach of material obligation under the contract, 3) a material representation, or 4) a material amendment to the agreements without consent of the issuer.

Note 5. Unaudited Information Certified by Custodian

Note 6. Allocated Insurance Contracts

Certain participants hold life insurance and fixed annuity contracts with National Western Life Insurance Company and Mass Mutual Life Insurance Company. Contributions to these contracts ceased in August 1997. Participants have the option to transfer these contracts to other investment options within the Plan. These accounts are credited with earnings as specified by each contract and charged with withdrawals and any premiums or fees charged by the insurance company.

These insurance contracts are allocated contracts. Plan benefits under these contracts are fully guaranteed by the insurance companies, which have legal obligations to make the benefit payments to the participants covered by the allocated contracts. In accordance with GAAP, allocated contracts and the related benefit obligations are excluded from the Plan's financial statements because the purchase of the contract transfers the obligation to pay the benefits and the related risks to the insurance companies. At July 31, 2024 and 2023, the values of allocated contracts were \$275,985 and \$460,350, respectively.

Note 7. Exempt Party-in-Interest Transactions

Certain plan investments are shares of pooled separate accounts managed by VOYA, which serves as the custodian as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid by the Plan to VOYA for administrative services amounted to \$82,524 for the year ended July 31, 2024.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100.00% vested in their accounts.

Note 9. Tax Status

The Plan has not obtained a determination letter from the Internal Revenue Service (IRS) stating that the Plan was in compliance with the applicable requirement of the IRC. The Plan is relying on the IRS approval of the prototype plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated June 30, 2020, that the prototype plan document was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable

requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Note 11. Non-Exempt Party-in-Interest Transaction

During the plan year ended July 31, 2024, there were unintentional delays by the Company in submitting participant contributions in the amount of \$69,078 to the custodian. These delinquent contributions constitute prohibited transactions, and the Company will make contributions to the affected participants' accounts to compensate those participants lost income due to delays.
