**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2023 Financial Statements**

We have performed an audit of the accompanying financial statements of BTB Home Care LLC 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ### NOTES TO FINANCIAL STATEMENTS FOR THE YEARS ENDED DECEMBER 31, 2023 AND 2022

#### NOTE A - DESCRIPTION OF PLAN

The following brief description of the BTB Home Care LLC 401(k) Profit Sharing Plan & Trust (“the Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

##### General

The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC) established on January 1, 2020 covering substantially all employees of BTB Home Care LLC (the Company) except for employees covered by a collective bargaining agreement (union employees), nonresident aliens, employees as a result of a transaction described in Code section 410(b)(6)(C), residents of Puerto Rico (effective February 1, 2023), and employees who have not met the applicable age and service requirements. Effective March 9, 2022, the Plan was amended and changed its age and service requirements. From January 1, 2020 through March 8, 2022, the age requirement was age 21. Effective March 9, 2022, the age requirement was amended to age 18. From January 1, 2020 through March 8, 2022, the service requirement was one year of service during which the employee worked at least 1,000 hours and 500 hours of service to avoid a break in eligible service. Effective March 9, 2022, the service requirement was amended to no eligibility service requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective February 1, 2023, the Plan changed service providers from Paychex, Inc. to ADP, Inc. As a result of the change in service providers, on February 6, 2023, assets of \$35,177 were transferred out of Mid Atlantic Trust Company to Reliance Trust Company. Reliance Trust Company received the assets of \$35,177 on February 8, 2023. The Plan adopted the ADP, Inc. non-standardized defined contribution pre-approved plan document on February 1, 2023. Any significant changes made to the Plan’s provisions as a result have been disclosed in the footnotes.

Effective December 29, 2023, the Board of Trustees made the decision to terminate the BTB Home Care LLC 401(k) Profit Sharing Plan & Trust as a result of the adoption of the Colorado SecureSavings Program, which is a state-sponsored retirement program.

##### Contributions

The Plan has an Eligible Automatic Contribution Arrangement (EACA). Unless a participant affirmatively elects otherwise, participants are automatically enrolled to contribute 3% of compensation each payroll period on a pre-tax basis. The initial automatic deferral amount increases by 1% of compensation up to a maximum of 10% of compensation each succeeding Plan year. Effective January 1, 2020 through January 31, 2023, the Plan’s entry date was immediately upon meeting the eligibility requirements. Effective February 1, 2023, the Plan’s entry date was amended to be the first day of the month coinciding with or next following the date the eligibility requirements are met. Effective January 1, 2020 through January 31, 2023, participants may make pre-tax or after-tax (Roth) contributions from 0% up to 92% of compensation. Effective February 1, 2023, the contribution limit was amended to 90% of compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Contributions (continued)

The Company may make discretionary nonelective contributions to the Plan. The Company has not made any contributions to the Plan since its formation on January 1, 2020. Participants direct the investment of their discretionary nonelective contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company discretionary non-elective contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan, if any. Allocations are based on earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants vest in the Company discretionary nonelective contributions portion of their account based on years of service, as follows:

0 - 2	0%
3	100%

If a participant dies or is disabled prior to attaining the normal retirement age, the participant becomes 100% vested.

Notes Receivable from Participants

Participants may borrow from their fund accounts. Effective January 1, 2020 through January 31, 2023, participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Effective February 1, 2023, participants may borrow a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

##### Payment of Benefits

Participants, or their beneficiaries, may receive the vested interest of their Plan account through a distribution of benefits upon retirement, death, termination of employment, or a qualifying withdrawal. Hardship distributions are permitted by the Plan. In-service distributions may be made to a participant who has not separated from service provided the participant has attained age 59 ½. Benefit payments may be made in the form of lump sum distributions, partial payments, and installment payments. From January 1, 2020 through January 31, 2023, the Plan also permitted annuity contracts as a form of distribution. Effective February 1, 2023, the Plan was amended to exclude annuity contracts as a form of distribution. If a participant's vested balance is less than \$5,000, but more than \$1,000, the participant's balance will automatically be distributed and rolled over into an individual retirement account unless the participant elects otherwise. If a participant's vested balance is less than \$1,000, the participant's balance will automatically be distributed in the form of a lump sum to the participant.

##### Forfeited Accounts

Forfeitures result from non-vested benefit payments remaining in the Plan for all terminated employees or adjustments, if any. Forfeitures may be used to pay Plan expenses or reduce Company contributions. There was no forfeiture balance as of December 31, 2023 and 2022. No forfeitures were used during the year ended December 31, 2023.

#### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### Basis of Accounting

As a result of the decision to terminate the Plan effective December 29, 2023, and in accordance with U.S. generally accepted accounting principles (U.S. GAAP), the Plan's financial statements as of and for the year ended December 31, 2023 have been prepared using the liquidation basis of accounting. As of December 31, 2022, the financial statement was prepared using the ongoing basis of accounting.

Under the liquidation basis of accounting, assets are stated at their estimated net realizable cash value and liabilities are stated at their anticipated settlement amounts. There are no material changes to the 2023 financial statements resulting from the change to the liquidation basis of accounting. The investments are stated at fair value under the liquidation basis of accounting as fair value is the estimated net realizable cash value for investments as of December 31, 2023. Benefit payments are recorded when paid under the liquidation basis of accounting consistent with the ongoing basis of accounting in accordance with U.S. GAAP.

##### Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the participant's account and are included in administrative expenses. As of December 31, 2023 and 2022 and during the year ended December 31, 2023, there were no notes receivable from participants. Accordingly, no allowance for credit losses has been recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to the participant's account and are included in administrative expenses. Fees for recordkeeping services and third-party administration that are paid by the Plan are included in administrative expenses and are allocated to participant accounts based on a pro-rata formula.

NOTE C – CERTIFIED INVESTMENTS

NOTE D - FAIR VALUE MEASUREMENTS

The *Fair Value Measurements* topic of the Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC)* establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2023 and 2022.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE E – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Paychex, Inc. and ADP Retirement Services were recordkeepers for the Plan during the year ended December 31, 2023. ADP Retirement Services also performed the third-party administration, including the annual compliance testing and Form 5500 preparation, for the Plan during the year ended December 31, 2023. Fees paid to the service providers qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Fees paid to ADP, Inc., the parent entity to ADP Retirement Services, during the year ended December 31, 2023 totaled \$4,684. Fees paid to Paychex, Inc. during the year ended December 31, 2023 totaled \$15.

NOTE F - PLAN TERMINATION

The Company has the right under the Plan to terminate the Plan, subject to the provisions of ERISA. Effective December 29, 2023, the Company terminated the Plan due the adoption of the Colorado SecureSavings Program, which is a state-sponsored retirement program. Due to the termination of the Plan being imminent effective December 29, 2023, the financial statements as of and for the year ended December 31, 2023 have been prepared on the liquidation basis of accounting. Participants are fully vested in their balances as there have been no Company contributions made to the Plan since its formation. All assets were distributed during 2024 and as of December 31, 2024, the Plan was fully liquidated.

NOTE G - TAX STATUS

The Plan operates under a non-standardized defined contribution pre-approved plan. Effective from January 1, 2020 through January 31, 2023, the Plan adopted the Paychex, Inc. pre-approved Plan. The IRS has opined and informed Paychex, Inc. by a letter dated August 31, 2020, that the plan is designed in accordance with the applicable sections of the IRC. Although

the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is currently designed, and is being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Effective February 1, 2023, the Plan adopted the ADP, LLC (a subsidiary of ADP, Inc.) non-standardized defined contribution pre-approved plan. The IRS has opined and informed ADP, LLC by a letter dated October 6, 2020, that the plan is designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is currently designed, and is being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan as of December 31, 2023 and 2022, and is not aware of any uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market rate, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### NOTE I – OPERATIONAL FAILURE

During the year ended December 31, 2023, the Company failed to process participant contributions for three paycheck dates due to an oversight. This led to missed deferrals for all participants for these paycheck dates. The Company is in the process of correcting the operational failure in accordance with regulations. The Company's best estimate of the corrective contribution owed as of the date of the issuance of these financial statements is \$2,261, which is recorded as an other employer contribution receivable as of December 31, 2023 and as other employer contributions for the year ended December 31, 2023. Due to the nature of this estimate, it is at least reasonably possible that changes in the corrective contribution owed to the Plan for this failure could occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits. The corrective contribution, including lost earnings, will be made as soon as administratively feasible.

#### NOTE J – PROHIBITED TRANSACTION

During the year ended December 31, 2023, the Company inadvertently failed to remit the participant contributions for the February 24, 2023 paycheck to the Plan. The participant contributions totaled \$1,293 and are included in the participant contributions receivable as of December 31, 2023.

NOTE J – PROHIBITED TRANSACTION (CONTINUED)

The failure to remit the participant contributions to the Plan in a timely manner is a prohibited transaction.

The Company owes the participant contributions to the Plan plus lost earnings. Due to the termination and liquidation of the Plan prior to the discovery of the missed remittance, the contributions have not yet been funded, and the correction is not complete. The Company is working with its service providers to determine the steps to correct the missed remittance as soon as administratively feasible.
