## INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of  
Green Dot Public Schools 401(k) Plan:

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Green Dot Public Schools 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets in liquidation as of August 21, 2024 and December 31, 2023, and the related statement of changes in net assets in liquidation for the period from January 1, 2024 through August 21, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certification from a qualified institution as of August 24, 2024 and December 31, 2023, and for the period from January 1, 2024 through August 21, 2024 stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the liquidation basis of accounting described in Note 2.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution which management has determined to meet the requirements of ERISA Section 103(a)(3)(C).

### *Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### *Plan Termination and Liquidation Basis of Accounting*

As discussed in Note 1 of the financial statements, the governing body of the Plan approved to terminate the Plan, and all assets of the Plan were transferred to an affiliated plan on August 21, 2024. As a result of the Plan's termination, the Plan's financial statements have been prepared on the liquidation basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the liquidation basis of accounting described in Note 2, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### *Auditors' Responsibilities for the Audit of the Financial Statements*

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the liquidation basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of Green Dot Public Schools 401(k) Plan (the Plan) is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the Plan document.

*General*

The Plan was a defined contribution plan which was established on January 1, 2016 and most recently amended on April 20, 2022. The Plan was sponsored by Green Dot Public Schools National (the Company). Substantially all employees of the Company who had reached the age of 21 and had completed one month of service were eligible to participate in the Plan. Employees could enter the Plan on the first day of the month following the date on which the aforementioned requirements were met. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Plan Termination*

In February 2024, the governing body of the Plan determined that the Plan would be terminated; final liquidation of Plan assets took place on August 21, 2024.

*Administration*

The Plan was administered by the Company. Among other duties, it was the responsibility of the administrator to interpret the Plan, decide on questions of eligibility, determine the amount and manner of benefit payments and maintain administrative records of the Plan. All Plan assets as of December 31, 2023 and for period from January 1, 2024 through August 21, 2024 were held by Fidelity Management Trust Company (Fidelity).

*Trustee*

The trustee of the Plan was Fidelity. The primary duties of the trustee were to authorize investments and monitor payment of contributions, loans, and benefits, as directed by the Plan administrator.

*Participant Accounts*

Each participant's account was credited with the participant's contribution and the Company's contributions, as well as allocations of Plan earnings. Participant accounts were charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account balance.

*Notes Receivable from Participants*

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The notes were secured by the balance in the participant's account and bore interest at a rate commensurate with local prevailing rates at the time of borrowing, as determined by the Plan administrator. Principal and interest was paid ratably through semi-monthly payroll deductions.

*Corrective Distributions*

Due to the failure of certain 2023 compliance tests, \$8,626 of corrective distributions were paid in February 2024.

### *Payment of Benefits*

Participants were able to receive distributions from their accounts upon attainment of age 59½, retirement as a result of disability, incurrence of a financial hardship (as defined), termination of their employment with the Company, or death. The participant could elect to receive either a lump-sum amount equal to the vested value of the participant's account balance, or installments over a period not to exceed the participant's assumed life expectancy.

### *Contributions*

**Participants** – The Plan permitted each participant, at the participant's option, to elect to contribute 1 to 100 percent of pre-tax compensation as a basic contribution or after-tax compensation as a Roth contribution, not to exceed the Internal Revenue Service (IRS) limitations. For the period from January 1, 2024 through August 21, 2024, the maximum salary deferral permissible under IRS limitations was \$23,000. Participants who attain age 50 before the end of the Plan period were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined contribution plans (rollovers). Participants directed the investment of their contributions into various investment options offered by the Plan. The Plan offered various mutual funds, a common/collective trust, and an interest-bearing cash account as investment options for participants. Participants were vested immediately in their contributions plus actual earnings thereon.

**Employer** – The Company made safe harbor matching contributions. During the period from January 1, 2024 through August 21, 2024, fully-vested safe harbor matching contributions were equal to 100 percent of participant contributions up to 4 percent of the participant's eligible compensation. In order for a participant to share in these contributions, the participant must have completed at least 1,000 hours of service during the Plan year. All contributions made by the Company were fully-vested immediately.

## NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### *Basis of Accounting*

The accounting records of the Plan were historically maintained on the cash basis of accounting. As a result of the Plan's termination discussed in Note 1, the accompanying financial statements have been prepared and presented on the liquidation basis.

Investment contracts held by a defined-contribution plan were required to be reported at fair value. However, contract value was the relevant measurement attribute for that portion of the net assets in liquidation of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value was the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan did not have any fully benefit-responsive investments.

### *Investment Valuation and Income Recognition*

The Plan's investments were stated at fair value as determined by Fidelity. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the liquidation basis. Dividends were recorded on the ex-dividend date. Net increase in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the period.

#### *Notes Receivable from Participants*

Notes receivable from participants were measured at their unpaid principal balance. Interest income was recorded on a cash basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses had been recorded as of December 31, 2023. If a participant ceased to make loan repayments and the Plan administrator deemed the participant's loan to be in default, the participant loan balance was reduced and a benefit payment was recorded.

#### *Administrative Expenses*

Plan investments were subject to certain investment fees based on a percentage of invested assets. Such fees were included within net increase of the respective investments in the accompanying statement of changes in net assets in liquidation. Fees incurred for the administration of the Plan and participant requested services are reflected as administrative expenses in the accompanying statement of changes in net assets in liquidation.

#### *Use of Estimates*

The preparation of financial statements requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Subsequent Events*

Plan management has evaluated subsequent events through the date of the auditors' report, April 30, 2025, which was the date the accompanying financial statements were available to be issued.

### NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. That framework gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under *Accounting Standards Codification (ASC) 820* are described as follows:

- a) Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- b) Level 2            Inputs to the valuation methodology include:
  - quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- c) Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for the Plan's investment measured at fair value at December 31, 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

*Interest-bearing cash:* Valued at cost plus accrued interest, which approximates fair value.

*Common/collective trust:* Valued at the net asset value (NAV) of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it was determined to be probable that the fund will sell the investment for an amount different than reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of a collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidation will be carried out in an orderly business manner.

The preceding methods described may produce fair value calculations that may not be indicative of net realizable values or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table set forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

#### NOTE 4 – TRUST CERTIFICATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivables from participants held at December 31, 2023, net increase in fair value of investments, dividends and interest income from investments and notes receivable for the period ended from January 1, 2024 through August 21, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity.

#### NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

During the period from January 1, 2024 through August 21, 2024, the Plan paid fees of \$12,420 to Fidelity for trust services and \$56,502 to a Plan advisor for investment advisory fees. These fees have been reflected as administrative expenses on the accompanying statement of changes in net assets in liquidation.

#### NOTE 6 – TAX STATUS

The IRS had determined and informed the Company that the Plan and related trust were designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan had been restated since its last correspondence with the IRS, the Plan administrator believes that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan was qualified and the related trust was tax-exempt.
