To Whom It May Concern:

Please find enclosed the final filing for the Constant Craving, inc. 401k Plan. In March 2024, after more than 20 years in business, Constant Craving Café, a small food service, was forced to close due to rising food costs. Throughout those years, we relied on PayChex for payroll, tax processing, and managing our 401K.

As we navigated the process of dissolving our 401K, we had numerous phone calls with PayChex for guidance, as we were unfamiliar with the necessary steps. However, at no point did any PayChex representative inform us that the 5500 tax form had to be filed within seven months of closing the 401K, rather than the standard deadline of July 1. We only discovered this requirement recently, when contacting EFAST/Paychex with a technical question about downloading the 5500 form.

Despite multiple calls to PayChex to confirm our filing obligations post-closure, we were never advised of this critical deadline. Unfortunately, this oversight was an unintentional error, as we relied on PayChex as our trusted source for professional guidance regarding 5500 tax filings. We appreciate your consideration of reliance on a professional and that we are a small local business as we file this final return.
