NOTE 1 – DESCRIPTION OF PLAN

Verdun 401(k) Retirement Plan (formerly EP Energy 401(k) Retirement Plan) (the Plan) is a qualified retirement plan adopted by Verdun Management Co LLC (formerly EP Energy Global, LLC) effective as of June 1, 2012. Effective January 1, 2024, the Plan was amended to change the name of the Plan Sponsor from EP Energy Global, LLC to Verdun Management Co LLC and to change the name of the Plan from EP Energy 401(k) Retirement Plan to Verdun 401(k) Retirement Plan. Effective April 1, 2023, the Plan was amended and restated to modify certain provisions of the Plan. In addition, effective January 1, 2024, the definition of compensation was updated, and the after-tax contribution was removed from the Plan. The Plan is designed to encourage and assist eligible employees in adopting a regular savings program and to provide additional security for their retirement. The Plan is administered by the Retirement Plan Committee (the Retirement Committee) and covers EP Energy Management, L.L.C., a participating employer. Verdun Management Co LLC and EP Energy Management, L.L.C. are collectively referred to as the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Significant provisions of the Plan are summarized below. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions.

Eligibility: The Plan covers all non-excluded employees of the Company. Non-excluded employees are eligible to participate in the Plan on their date of hire. The entry date will be the date on which they satisfy the eligibility requirements.

Contributions: Participants may elect to reduce their compensation by a specific percentage or dollar amount, up to 50% of their eligible compensation each year, and have that amount contributed to the Plan as a salary deferral, not to exceed the dollar limit set by the law. Participants may contribute in any combination of pre-tax and Roth contributions. If a participant is at least age 50 or will attain age 50 before the end of the calendar year, then they may elect to defer additional amounts called catch-up contributions to the Plan for that year. Participants may revoke or make modifications to their salary deferral election in accordance with the plan provisions.

The Plan includes an automatic deferral feature. The Company will automatically withhold 6% of an eligible employee's compensation from their pay each payroll period and contribute that amount to the Plan as a pre-tax 401(k) deferral unless the employee makes a contrary election.

The Company will match 100% of a participant's contributions to the Plan as a before-tax or Roth contribution, up to 6% of a participant's earnings. These Company matching contributions are made each pay period and are contributed at the same time and the same manner as that of the participant's elective contributions to which they relate.

Rollover contributions from qualified retirement plans and certain IRAs are also permitted by the Plan.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings and losses, and (c) forfeitures of employer profit sharing contributions and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: Participants are always 100% vested in all of their Plan accounts.

Payment of Benefits: Participants may receive a distribution of some or all of their accounts in the Plan when they terminate employment with the Company. If a participant's vested account balance exceeds \$1,000, their consent is required to distribute their account. If a participant's vested account balance does not exceed \$1,000, a distribution of their vested account balance will be made to them, regardless of whether they consent to receive it.

In-Service Distributions: Participants who have attained age 59 ½ may receive distributions from all contribution accounts.

Hardship Distributions: Hardship distributions may be made to satisfy certain immediate and heavy financial needs that a participant may have.

Notes Receivable From Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance, or \$50,000 reduced by the highest outstanding loan balance in the last 12 months. The loans are secured by the balance in the participant's account. The loan interest rate is fixed and is the prime rate for the month in which a participant requests the loan plus 1%. Principal and interest are paid ratably through after-tax payroll deductions within a period of at least 12 months, but no more than 60 months, unless the loan is to be used to acquire a principal residence. If a participant terminates employment with the Company, he or she may continue to make loan payments through a pre-authorized check agreement. If the loan is not repaid, it will automatically be treated as a distribution to the participant.

Forfeitures: Any unvested portion of a terminated participant's account shall be forfeited. Amounts arising from forfeitures shall be used to reinstate previously forfeited amounts, reduce future employer contributions, or pay reasonable Plan administrative expenses. At December 31, 2024 and 2023, forfeited accounts totaled \$41,966 and \$71,540, respectively. During 2024, forfeitures of \$28,671 were used to pay Plan administrative expenses.

Plan Termination: Although the Company intends to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. Upon termination, no further contributions will be made to the Plan and all amounts credited to their accounts will continue to be 100% vested.

Administrative Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

Transfers from Other Plan: Effective March 1, 2024, participant balances including loans were transferred from a subplan of the Insperty 401(k) Plan into the Plan. Total transfers in amounted to \$7,184,756.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through May 16, 2025, which is the date the financial statements were available to be issued. Effective January 1, 2025, \$5,000 limits in the Plan related to mandatory distribution (i.e., involuntary cash-out) provisions was increased to \$7,000 effective for Distributions made on or after January 1, 2025. Effective March 1, 2025, the automatic deferral percentage will increase by 1% per year up to a maximum of 10% of compensation. The elective deferrals will increase on March 1 beginning with the March 1 of the plan year following the plan year in which automatic deferral first applies to a participant. Regardless of the elections above, the first increase with respect to participants whose first automatic deferral was prior to January 1, 2025, will occur on March 1, 2025.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit and risks resulting from global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Self-Directed Brokerage Account (SDBA): The Plan offers participants the option to invest in a self-directed brokerage account, which allows participants to invest in a wide array of investment securities. The fair values of investments held within the SDBA are based on quoted prices in active markets for identical assets and are classified as Level 1 within the fair value hierarchy. Investments in the SDBA are valued at the closing market prices on nationally recognized exchanges as of the measurement date. Because these prices are based on observable market data, they are categorized as Level 1 inputs under ASC 820-10.

Common Collective Trusts (CCTs): The fair values of participation units held in common collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

Nuveen seeks long-term capital appreciation by investing primarily in U.S. large-cap growth equities. The NAV for Nuveen was \$9,566,291 and \$8,883,527 at December 31, 2024 and 2023, respectively.

Putnam is designed to provide capital preservation and stable returns through a portfolio of fixed income securities and wrap contracts. Putnam was valued at \$4,169,238 and \$4,077,677 as of December 31, 2024 and 2023, respectively.

Both funds provide for daily redemptions with no advance notice requirement or redemption restrictions. The NAVs are provided by the fund managers and represent the exit prices as of the measurement date. There were no unfunded commitments associated with these investments, and there were no changes to the redemption terms or restrictions during either reporting period.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Empower Trust Company, LLC serves as the trustee and is a service provider to the Plan and, therefore, these transactions and the Plan’s payment of fees to the trustee qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 6 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated November 14, 2022 indicating that the non-standardized pre-approved profit sharing plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended from the original non-standardized pre-approved profit sharing plan document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
