To Whom It May Concern:

Enclosed is a Form-5500 return for the 2022 plan year. This letter is a request for consideration in assessing penalties for filing a late annual return for our health plan.

Our company employs an average of 17 employees each year and we have offered to provide employer-sponsored health coverage for our employees and their dependents. In 2023, we were able to provide coverage by offering a partially self-funded health plan to our employees.

As a small company, we do not contract with attorneys on retainer nor are we able to afford to have a certified public accountant at our disposal. Thus, we are somewhat at a disadvantage in obtaining all the technical ERISA rules and regulations compared to larger companies. However, we did not act intentionally in filing the annual report late, rather it was a clerical error.

At this time, we would ask for your consideration in waiving any applicable late penalties in the interest of promoting small employer provided health insurance. We believe we have acted in good faith by filing the late return as soon as we were made aware of the delinquency and before you notified us that we were delinquent.
