Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Garten Services Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in the "Information Certified by the Custodian" note to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

DESCRIPTION OF THE PLAN

The following description of Garten Services Retirement Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a noncontributory defined contribution plan covering all employees, other than temporary or on-call employees, of Garten Services, Inc. (the Employer and Plan Sponsor), a not-for-profit organization. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended.

Contributions

Contributions by the Employer to the Plan are determined annually by the Employer and limited to the maximum amount deductible for federal income tax purposes. The Plan does not provide for participant voluntary contributions. The Employer contributes 3% for eligible participants and 5% for the CEO, CFO and COO. Employer contributions were suspended effective January 1, 2024. Employer contributions during the years ended June 30, 2024 and 2023, totaled \$95,083 and \$171,740, respectively.

Eligibility

All employees, other than temporary or on-call employees, are eligible for participation in the Plan and may enter the Plan on the first day of the month after completion of 1,000 hours of service within a 12-month period and attainment of age 18.

Participant Accounts

Each eligible participant’s account is credited with an allocation of (a) employer contributions, (b) plan earnings (losses), and (c) forfeitures of terminated participants’ nonvested accounts. Allocations of the employer contributions and forfeitures are based on participant annual compensation, and Plan earnings are allocated based on the participant’s account balances, as defined in the agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account. The investment of Plan assets is directed by the Plan Administrator. Asset management fees are deducted from the Plan’s earnings.

Vesting

A participant becomes fully vested in their account balance after completing three years of credited service. Participants can also become 100% vested upon attainment of normal retirement age (62 years), death, or disability.

Forfeited Accounts

Under the terms of the Plan, forfeitures of non-vested accounts of terminated employees are to be applied first to plan expenses and then toward employer contributions. During 2024 and 2023, forfeitures resulting from the distribution of non-vested accounts totaled \$1,091 and \$2,170, respectively. At June 30, 2024 and 2023, forfeited non-vested accounts totaled \$1,091 and \$2,170, respectively. In 2024, plan administrative expenses were reduced by \$2,170.

Payment of Benefits

On termination of service, a participant may elect to receive either a lump sum amount equal to the value of the vested portion of his or her account or equal periodic payments over a period of time as determined by the participant if his or her vested account balance is greater than \$5,000. If it is less than \$5,000, the administrator may, without consent of the participant, distribute his or her balance in a lump sum amount. A participant who is still an employee and has reached age 59 ½ may request an in-service distribution of all, or a portion, of the participant's vested interest in his or her account in the form of a lump sum amount.

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See additional information in the "Fair Value Measurements" note to the financial statements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

In addition to the fees deducted from the Plan earnings, certain plan administrative expenses are paid directly by the Plan Sponsor and are excluded from these financial statements.

Funding Policy

It is the policy of the Plan Sponsor to fund estimated contributions to the Plan not less than quarterly.

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Subsequent Events

The Plan has evaluated subsequent events through April 21, 2025, the date the financial statements were available to be issued.

FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Pooled separate accounts: These accounts hold assets allocated to each separate account. The value of each separate account is determined at the close of each business day based on fair value. These accounts are

INFORMATION CERTIFIED BY THE CUSTODIAN (UNAUDITED)

The custodian, Empower Annuity Insurance Company of America (Empower), holds all investments and executes all investment transactions on behalf of the Plan. Information regarding the value of all investments, investment interest and dividend income, and net appreciation/depreciation in the fair value of investments has been certified by the custodian as complete and accurate in accordance with Section 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan contracts with Empower. The insurance company maintains the contributions in pooled separate accounts. The accounts are credited with earnings (losses) on the underlying investments and charged for Plan withdrawals and administrative expenses charged by the insurance company.

The value of the investment contract at June 30, 2024 and 2023, was \$1,672,736 and \$1,578,813, respectively.

RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of pooled separate accounts managed by Empower. The insurance company is the custodian as defined by the Plan, and therefore, these transactions qualify as party-interest transactions. Fees incurred by the plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. As described in the summary of significant accounting policies note, the Plan made direct payments to the third-party administrator and custodian totaling \$5,320 which were not covered by revenue sharing. The Plan Sponsor pays directly any other fees related to Plan operations. Other parties-in-interest include the Plan’s board of trustees, participants, and anyone performing services for the Plan.

TRUSTEES OF THE PLAN

The Plan provides for trustees to be appointed by the employer. These individuals are officers or employees of the Plan Sponsor.

PLAN TERMINATION

Although it has not expressed any intent to do so, Garten Services, Inc. has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions.

TAX STATUS

Garten Services, Inc. has adopted a volume submitter plan document and is relying on the volume submitter sponsor's opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020. The letter states that the form of the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the plan is no longer subject to income tax examinations for plan years prior to 2021.

RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
