We have performed audits of the financial statements of Culinaire 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). #### **Note 1 – Plan Description**

The following description of the Culinaire 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement or Summary Plan Description for a more complete description of the Plan’s provisions.

##### ***General***

The Plan is a defined contribution 401(k) plan that provides retirement savings benefits to eligible employees of Culinaire International, Inc. (“Company” or “Employer”). The Plan commenced effective January 1, 1996, and was amended and restated to comply with the latest rules and regulations effective April 25, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”).

##### ***Plan Custodian and Trustee***

Fidelity Management Trust Company (“Fidelity,” “Trustee,” or “Custodian”) is the Custodian maintaining custody of all investments held by the Plan, maintaining the Plan’s participant account balances, and providing record-keeping services to the Plan. Among other duties, the Custodian receives contributions, holds and invests the fund assets in accordance with the directions of participants, and makes distributions as directed by the Plan Administrator. Fidelity also serves as the Plan’s Trustee.

##### ***Eligibility and Plan Entrance Date***

All employees of the Company who are 18 years of age, have completed two months of service, and are not a nonresident alien or covered by a collective bargaining agreement are permitted to participate in the Plan. Eligible employees are permitted to enter the Plan on the first day of each month after which the employee has satisfied the eligibility requirements.

##### ***Contributions***

The Plan permits participants to contribute, on a before-tax or Roth basis, up to 90% of annual compensation as defined in the Plan, up to the maximum amount allowed for deferral annually by the IRC. The deferral limit for 2024 was \$23,000. Participants who have reached 50 years of age before the end of the Plan year are eligible to make catch-up contributions up maximum amount allowed annually by the IRC, which was \$7,500 for 2024. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollover”).

The Employer may make discretionary matching contributions, as determined by the Employer. For the year ended December 31, 2024, the Company made matching contributions to the Plan on behalf of participants in an amount equal to 25% of the first 10% of the participant’s eligible compensation that the participant contributed to the Plan. Employer matching contributions are calculated and paid each payroll period. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

##### ***Participant Accounts***

Each participant’s account is credited with the participant’s contributions, the Company’s discretionary matching contributions, and an allocation of Plan earnings, and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### Note 1 – Plan Description (continued)

##### *Participant-Directed Investments*

All assets of the Plan are participant-directed investments. The Plan has selected various investment options, as more fully described in the Plan Document, to which participants may designate the allocation of their account balances. Participants may direct their account balances to one or more of the investment options offered, which vary in types of investments, rates of return, and investment risk.

##### *Vesting*

Participants are vested immediately in their contributions plus actual earnings thereon. Discretionary matching contributions and nonelective contributions, plus any income or loss thereon, are subject to the following vesting schedule:

##### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. A participant may only have one outstanding loan at a time. The loans must be repaid over a period no longer than five years. Loans are secured by the balance in the participant's account. The loan interest rate is set at commercially reasonable rate of interest, as defined. Principal and interest are paid ratably through payroll deductions at least quarterly.

##### *Payment of Benefits*

Upon separation of service due to death, disability, normal retirement, or termination of employment, a participant receives a distribution of the vested portion of their account balance. If the vested account balance is less than or equal to \$1,000, the Plan permits involuntary lump sum cash distributions. Distributions to a terminated employee with a vested account balance less than or equal to \$5,000 are made as a lump sum distribution as soon as administratively possible following the participant's termination of employment. The participant may elect whether to receive the distribution directly or to rollover the distribution into another retirement plan. If a terminated employee has an account balance exceeding \$5,000, the participant may elect to take a distribution of less than the entire vested account balance.

A participant may withdraw all or a portion of their vested account balance in the event of a financial hardship, as defined by the Plan. Additionally, in-service withdrawals are permitted upon attainment of age 59 ½.

##### *Forfeited Accounts*

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$14,087 and \$15,123, respectively. Amounts in these accounts will be used to reduce future Employer contributions or to pay administrative expenses. During the year ended December 31, 2024, the Company used \$37,905 in forfeitures to reduce its Employer contributions.

#### **Note 2 – Summary of Significant Accounting Policies**

##### ***Basis of Accounting***

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with the accounting principles generally accepted in the United States of America ("GAAP").

##### ***Use of Estimates***

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

##### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan Agreement.

##### ***Excess Contributions Payable***

Amounts payable to participants for contributions in excess of amounts allowed by the IRC are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024.

##### ***Payment of Benefits***

Benefit payments to participants are recorded when paid.

##### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain expenses specifically incurred by, or attributable to, a participant will be paid from that participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820 are described as follows:

- **Level 1** – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.
- **Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Inputs that are unobservable inputs for the assets or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- **Mutual Funds** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- **Common Collective Trust Stable Value Fund** – The Plan’s investment in the Putnam Fiduciary Trust Company Common Collective Trust Stable Value Fund is primarily comprised of fully benefit responsive investment contracts that are valued at the NAV of units of the collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily and there are no unfunded commitments. The redemption frequency is immediate. There are no significant restrictions on participant redemptions and there is no redemption notice period. Were the plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### **Note 5 – Related-Party and Party-in-Interest Transactions**

Certain Plan investments are managed by the Custodian; therefore, these transactions qualify as party-in-interest transactions as defined by ERISA. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. All investment fund earnings or losses posted to each participant's account are net of investment management fees charged by each investment fund under the Plan.

The Plan has notes receivable from participants as of December 31, 2024 and 2023. These receivables and all related transactions qualify as party-in-interest transactions and are exempt from being prohibited by ERISA.

#### **Note 6 – Plan Termination**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions. See Note 10.

#### **Note 7 – Tax Status**

The Plan operates under an adoption agreement in connection with a volume submitter profit sharing plan sponsored by the Fidelity Management and Research Company ("Prototype Plan"). This Prototype Plan document has been filed with the appropriate agency and has obtained a determination letter from the IRS, dated June 30, 2020, stating that the Prototype Plan constitutes a qualified plan under Section 401 of the IRC, and that the related trust was tax exempt as of the financial statement date. The Plan has not filed individually with the IRS for a letter regarding the Plan's qualified tax status.

The Prototype Plan has been amended since receiving the opinion letter; however, the Plan Administrator and the Plan Trustee believe that the Prototype Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. The Plan and related trust continue to be tax-exempt, and accordingly, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 8 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
