In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's responsibilities for the audit of the financial statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **NOTE 1 - PLAN DESCRIPTION**

The following description of the Sustana Fiber LLC Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan adoption agreement for a more complete description of the Plan's provisions.

##### ***General***

The Plan is a defined contribution plan covering substantially all employees of Sustana Fiber LLC (the "Company" or "Plan Sponsor") and its related employers, Rolland USA Holdings, Inc., Hanna Paper Recycling (Buffalo), Inc., Hanna Paper Recycling (Boston), Inc., Hanna Paper Recycling (Mid-Atlantic), Inc., and Hanna Paper Recycling (Midwest), Inc., as defined in the adoption agreement. The Plan was effective January 1, 1994 and was most recently restated and amended effective January 13, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Effective October 18, 2024, the Plan became a participating employer in the SuccessWise Pooled Employer Plan (PEP Plan) and merged the assets of the Plan into the PEP Plan. The merged amounts included \$14,977,250 of participant balances and \$85,389 of notes receivable from participants, and the total transfer is included within Transfers Out of Plan on the statement of changes in net assets available for benefits.

##### ***Eligibility***

Employees are eligible to participate in the Plan on the date of hire. Eligible employees are eligible to make participant contributions and receive discretionary matching contributions from the Plan Sponsor if and to the extent specified in the applicable adoption agreement or otherwise provided by the Plan. The exceptions to eligible employees are non-resident aliens who receive no compensation from the employer from a U.S. source, residents of Puerto Rico and those covered by a collective bargaining agreement. Participants are eligible to participate in the Plan after reaching the age of 18.

##### ***Contributions***

Participants may elect to defer a pre-tax or Roth percentage of their eligible compensation into the Plan. The percentage of eligible compensation the participant elects will be withheld from each payroll and contributed to an account in the Plan on the participant's behalf. For 2024, the maximum deferral limit for participant's pre-tax and/or Roth after tax contributions was \$23,000. Participants who have attained age 50 before the end of a Plan year are eligible to make catch up contributions. For 2024, the maximum pre-tax and/or Roth catch up contribution was \$7,500. Participants may also make rollover contributions to the Plan from other qualified plans, individual retirement accounts and annuities. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make discretionary matching contributions equal to a uniform percentage or dollar amount of the participants' elective deferrals each payroll period. For the plan year ended October 18, 2024, the Company did not elect to make a discretionary matching contribution.

The Company provides a safe harbor matching contribution equal to 100% of salary deferrals up to the first 3% of plan compensation, plus 50% of salary deferrals up to the next 2% of plan compensation.

##### ***Investment Options***

Each participant has the right to direct the investment of his or her account into the various investment options offered by the Plan. Participants may change their investments daily.

#### ***Participant Accounts***

A separate account is maintained for each participant. Each participant's account is credited with the participant's contributions and the Company's contributions, and an allocation of (1) Plan earnings (losses) and (2) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Vesting***

Participant contributions, rollover contributions and safe harbor employer contributions, including earnings thereon, are always fully vested.

A participant's portion of the Company discretionary match contribution, including earnings thereon, becomes 100% vested after five years of service, with vesting increasing by 20% each year.

#### ***Notes Receivable from Participants***

Participants may borrow from the vested portion of the pre-tax portion of their account balance. The maximum loan available is limited to 50% of such participants' vested accounts, but in no event shall the loan be less than \$1,000 or more than \$50,000. Participants can only have one loan outstanding. The loans are secured by the balance of the participant's account. The interest rate of the loan is set by the Company using the prime rate plus 1%. The interest rate is fixed throughout the duration of the loan. Interest income is recorded on the accrual basis. Loans are repaid in equal installments through payroll withholding over a period not to exceed five years.

#### ***Payment of Benefits***

Upon termination of service, retirement, death or total permanent disability, a participant may elect to receive a distribution of their entire accumulated Plan balance, subject to the terms of the Plan. Distribution options include lump-sum payments, partial payments, annuities, or installments. Participants may elect in-service withdrawals of their elective deferral account balance for hardship purposes. Participants may request an in-service distribution from all vested accounts at age 59½, or from certain other accounts after meeting certain criteria. Minimum distributions are required for participants who have reached the required age per Internal Revenue Service ("IRS") regulations. In the case of participant death, payment(s) of the vested value of the participants' account will be made to a beneficiary as designated by the participant.

A Participant who terminates employment with a vested account balance that does not exceed \$5,000 may receive a lump sum distribution of their vested account balance. A terminated participant will receive an involuntary cash-out distribution only if their vested account balance is less than or equal to \$1,000.

#### ***Forfeitures***

Forfeitures result from non-vested Company contributions remaining in the Plan from terminated employees in accordance with the Plan adoption agreement and are used to reduce the Company contributions. Forfeitures in the amount of \$0 and \$629 were available as of October 18, 2024, and December 31, 2023, respectively, to reduce future Company contributions. In 2024, there were no forfeitures used to fund Company safe harbor matching contributions. The forfeiture balance was transferred to the SuccessWise Pooled Employer Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Refer to Note 3 for fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is accrued as earned. Net realized and unrealized appreciation of investments is recorded in the accompanying statement of changes in net assets available for benefits as net appreciation in fair value of investments and includes gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent loans are reclassified as distributions based upon the terms of the Plan adoption agreement.

***Payment of Benefits***

Benefits are recorded when paid.

***Administrative Expenses***

Administrative expenses relating to processing loans and distributions are paid by the participants. All other administrative expenses are paid by the Plan Sponsor and are excluded from these financial statements.

***Investment Expenses***

Investment expenses charged by mutual funds at the individual participant level are included in the net appreciation in fair value of investments.

***Risks and Uncertainties***

The Plan provides for various investment options. These investment options are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment options of the Plan, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the Plan's financial statements.

#### NOTE 3 - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board ("FASB") has issued guidance that establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the FASB guidance are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 18, 2024 and December 31, 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset values ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trust:* Valued at the NAV of the collective trust as reported by the collective trust managers. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. These funds seek to maximize total return through capital appreciation and current income.

There have been no changes in the methodologies used at December 31, 2023 and there were no transfers made between levels for the period from January 1, 2024 through October 18, 2024 and year ended December 31, 2023. There are no investments at October 18, 2024. See Note 1.

**NOTE 4 - TAX STATUS**

The Plan adopted a standardized prototype plan document which received an opinion letter from the IRS on June 30, 2020, which stated that the standardized prototype plan document is designed in accordance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan administrator has determined that the Plan is eligible and has chosen to rely on the current IRS opinion letter. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC. The Plan administrator believes the Plan is currently designed and is being operated in compliance with the applicable provisions of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by applicable taxing authorities. The Plan administrator has analyzed tax positions taken by the Plan and has concluded that, as of October 18, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant's Company contribution account balance will become fully vested.

**NOTE 6 - INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company has certified that the following data included in the accompanying financial statements is complete and accurate:

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of October 18, 2024 and December 31, 2023;

**NOTE 7 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan assets are in investment funds managed by Ascensus Trust Company, the trustee of the Plan, or its affiliate, The Vanguard Group, Inc. These transactions qualify as party-in-interest transactions as defined under ERISA. Notes receivable from participants also qualify as party-in-interest transactions.

**NOTE 8 - SUBSEQUENT EVENTS**

The Company has evaluated subsequent events from October 18, 2024 through May 15, 2025, the date these financial statements were available to be issued. There are no subsequent events that require recognition or additional disclosure in these financial statements.
