Independent Auditors' Report

To the Retirement Committee and Plan Administrator of Sundance Holdings Group, LLC 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Sundance Holdings Group, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of assets available for benefits as of July 16, 2024 (liquidation) and December 31, 2023 (ongoing), and the related statement of changes in assets available for benefits for the period from January 1, 2024 through July 16, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of July 16, 2024, and December 31, 2023, and for the period ended July 16, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section—

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Adoption of Liquidation Basis of Accounting

As discussed in Note 2 to the financial statements, the plan sponsor of Sundance Holdings Group, LLC 401(k) Plan approved a plan of liquidation in July 2024 as management determined liquidation is imminent. As a result, Sundance Holdings Group, LLC 401(k) Plan has changed its basis of accounting of the period ended end July 16, 2024, from ongoing basis to liquidation basis. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements, as a whole, are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Notes to Financial Statements

1. Description of the Plan

The following description of the Sundance Holdings Group, LLC 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document and adoption agreement for a more complete description of the Plan's provisions.

General

The Plan was established August 1, 2004, and is a defined contribution plan covering all eligible employees of Sundance Holdings Group, LLC (the Company or Employer). Employees, other than individuals not otherwise classified by the Company as common law employees, residents of Puerto Rico, and leased employees, are eligible to participate in the Plan upon reaching age 18 and are eligible to participate the first month following their hire date. The Plan is intended to be a qualified plan under the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Effective July 16, 2024, the Company transferred all net assets of the Plan to a pooled employer plan administered by NestEggs Retirement Plan Services, Inc., a Florida corporation. Subject to the provisions of ERISA, all participants' accrued benefits under the Plan were fully vested prior to the transfer. As of the transfer date, the net assets of the Plan, totaling \$16,456,907, were transferred to the NestEggs Master Pooled 401(k) Plan (the PEP). The Company will no longer make contributions to the Plan, and all future contributions will be directed to the PEP.

Recent Pronouncements

On December 29, 2023, the Setting Every Community Up for Retirement Enhancement Act 2.0 (the "SECURE Act 2.0") was signed into law. It includes mandatory and optional provisions impacting defined contribution plans. Applicable provisions outlined in the SECURE 2.0 Act will be adopted if elected and/or required. Plan amendments for these changes are not yet required.

Contributions

Eligible employees automatically become participants and are enrolled into the Plan with a 6% deferral rate, unless they elect otherwise. Participant contributions are subject to an annual limit of the lesser of 60 percent of eligible compensation or \$23,00 (100% and \$30,500 for participants age 50 or older) for the period ended July 16, 2024. Eligible employees may also make contributions by rollover of distributions from other qualified retirement plans. The Plan allows participant contributions to be designated as Roth contributions and accepts rollovers of Roth designated contributions.

The Company may elect to make discretionary matching contributions to each participant's account. Effective April 16, 2023, the Company paused all discretionary matching contributions. Discretionary matching contributions were then resumed effective March 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions, and an allocation of earnings, and is charged with withdrawals, and an allocation of losses and expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant-Directed Options for Investments

Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contributions is based on years of continuous service. A participant is 34% vested after one year of service, 67% after two years of service, and 100% vested after three years of service.

Notes Receivable from Participants

Participants may choose to borrow from their Plan accounts up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less, with a minimum amount of \$1,000. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates at the time funds are borrowed. The interest rate remains fixed throughout the duration of the loan. Principal and interest are paid ratably through payroll deductions or a lump sum for the outstanding balance. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installment payments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Participants qualifying under hardship rules may elect to receive all or a portion of their deferral contributions account balance prior to termination or retirement, subject to a \$500 minimum. Additionally, the Plan requires that involuntary cash outs greater than \$1,000 made before the participant's retirement be rolled over to an individual retirement plan designated by the Plan Administrator.

2. Summary of Significant Accounting Policies

Forfeitures

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account as defined by the Plan, represents a forfeiture. The Plan permits the use of forfeitures to either reduce future Company contributions or pay administrative expenses. However, if a participant is reemployed and fulfills certain requirements, as defined in the Plan Document, the account will be reinstated. As of July 16, 2024 (liquidation) and 2023 (ongoing), forfeited nonvested accounts totaled \$0 and \$33,990, respectively.

Basis of Accounting

As a result of the decision to terminate the plan effective July 16, 2024, and in accordance with accounting principles generally accepted in the United States of America (US GAAP), the Plan's financial statements as of and for the period ended July 16, 2024, are presented using the liquidation basis of accounting. For periods before the decision to terminate the Plan was made, the financial statements were prepared using the ongoing basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides mutual fund and stable value fund investment options to its participants. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the financial statements.

Investment Valuations and Income Recognition

The Plan's investments are stated at fair value. Shares of mutual funds are stated at quoted market prices. The stable value fund is stated at fair value using net asset value (NAV) as a practical expedient. NAV is based on the fair value of the underlying investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold during the period as well as held as of the end of the period.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest, and are secured by the participants' account balances. Interest income is recognized over the terms of the notes at the rate specified in the loan documents. Fees related to the notes are recorded as administrative expenses when they are incurred. If a participant defaults, the carrying amount of the note receivable from the participant is eliminated and a benefit payment is recorded at the time the participant has a distributable event.

Administrative Expenses

Plan administrative expenses may be charged directly to the Plan (either allocated to the participants or using forfeiture funds) or paid by the Company. During the period ended July 16, 2024, the Plan paid \$49,820 of administrative expenses. Certain administrative expenses are paid by the Company. Investment related expenses are included in net appreciation in the fair value of investments.

Payment of Benefits

Benefit payments are recorded when paid by the Plan.

Subsequent Events

Plan management has evaluated events occurring subsequent to period-end through May 15, 2025, which is the date the financial statements were available to be issued.

3. Fair Value Measurement

US GAAP requires investments to be classified into a three-level hierarchy. The levels in the hierarchy have been established according to the types of inputs to valuation techniques used to measure fair value. Investments are classified in the hierarchy in their entirety based upon the lowest level of the input that was significant to their fair value measurement. Descriptions of the inputs that define the three levels of the hierarchy are as follows:

- Level 1: Quoted prices in active markets for identical assets or liabilities.
- Level 2: Observable inputs other than Level 1 including quoted prices for similar assets or liabilities, quoted prices in less active markets, or other observable inputs that can be corroborated by observable market data.
- Level 3: Unobservable inputs supported by little or no market activity for financial instruments whose value is determined using pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant management judgment or estimation.

4. Exempt Party In-Interest Transactions

Plan investments include shares of mutual funds managed by Fidelity Management Trust Company or affiliates and shares of a stable value fund that is managed by Wilmington Trust Retirement and Institutional Services Company. Fidelity Management Trust Company is the trustee of the Plan's investments, and therefore, certain of the Plan's mutual fund transactions qualify as party-in-interest transactions. Wilmington Trust Retirement and Institutional Services Company contracts directly with the Plan to offer the stable value fund, and therefore, stable value fund transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Notes receivable from participants are also considered to be party-in-interest transactions. The party-in-interest transactions described above are exempt from the prohibited transaction rules of ERISA.

5. Federal Income Tax Status

The Plan uses a prototype plan document sponsored by the trustee of the Plan. The trustee obtained an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. Plan management has concluded that as of July 16, 2024, there are no uncertain tax positions that require either recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Information Certified by The Trustee

The following sets forth the unaudited information of the Plan as of July 16, 2024 and December 31, and 2023, and for the period from January 1, 2024 through July 16, 2024, included in the Plan's financial statements and supplemental schedule, that was prepared by or derived from information prepared by Fidelity Management Trust Company, the trustee of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained a certification from the trustee that such information is complete and accurate.
