We have performed audits of the financial statements of Heartland Center for Behavioral Change 401(k) Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**Note 1. Description of the Plan**

***General***

The following description of Heartland Center for Behavioral Change 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Heartland Center for Behavioral Change (Organization) for the benefit of its employees who have at least one month of service and are age 18 or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Alerus Financial, N.A. serves as plan custodian and recordkeeper.

***Contributions***

The Plan permits eligible employees to have the Organization contribute, through a salary deferral, a percentage of their eligible annual compensation, not to exceed the maximum limits established by the Internal Revenue Code. Employees may elect to contribute pre-tax deferrals of compensation or after-tax Roth deferrals, as well as rollover contributions, as defined by the Plan. Participants are automatically enrolled in the Plan on the entry date immediately following eligibility in the Plan, with a default elective deferral of 3% of employee compensation unless the participant makes an affirmative election otherwise. The automatic deferral percentage increases by 1% per year up to a maximum of 10% of employee compensation.

Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Organization makes matching contributions of 100% of employees' salary deferral amounts on the first 5% of employees' compensation. Employees must have one year of service and be age 18 or older to be eligible for matching contributions. The Organization may make annual discretionary contributions to the Plan subject to the discretion of the board of directions. There were no additional discretionary contributions by the Organization for the years ended June 30, 2024 and 2023. Contributions are subject to certain limitations.

***Participant Investment Account Options***

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Organization's contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Organization's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after four years of continuous service. The nonvested balance is forfeited upon termination of service. Forfeitures are used to reduce Organization contributions and offset administrative fees.

***Payment of Benefits***

Upon termination of service due to death, disability or retirement, a participant or beneficiary may elect to receive (1) a lump sum amount equal to the value of the participant's account; (2) installments over a specified period not exceeding the participants life expectancy or the joint life expectancy of the participant and the designated beneficiary. For terminations of employment, or any other reason, a participant may receive the value of vested interest in their account as a lump sum distribution. However, the Plan requires a lump sum distribution of a terminated participant's account if the balance is less than \$5,000.

***Forfeited Accounts***

At June 30, 2024 and 2023, forfeited nonvested accounts totaled \$6,279 and \$3,665, respectively. These accounts will be used to offset administrative fees and reduce future employer contributions. Employer contributions were reduced by \$3,269 and \$4,278 in 2024 and 2023, respectively, from forfeited nonvested accounts.

***Reclassification***

A reclassification has been made to the 2023 financial statements to conform to the 2024 financial statement presentation. This reclassification had no effect on change to net assets available for benefits.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds and exchange-traded funds are valued at the net asset value (NAV) of shares held by the Plan at year end. The Plan invests in collective investment trusts with underlying benefit-responsive group annuity contracts. Since the Plan is indirectly invested in the benefit-responsive contracts, the investments are measured at fair value. Fair value is determined using the NAV reported by the funds, which is calculated by dividing the total value of the underlying contracts, less there liabilities, by the total number of units outstanding.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Organization or the Plan, at the Organization's discretion. Distribution, recordkeeping and asset management fees are charged to the participants by Alerus Financial, N.A. and are included in administrative expenses.

**Note 3. Certification of Plan Custodian**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Alerus Financial, N.A., a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of June 30, 2024 and 2023.
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended June 30, 2024 and 2023.
- Investment information included in the accompanying schedule of assets (held at end of year) as of June 30, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan paid \$26,693 and \$26,662 of recordkeeping, transaction and asset management fees to the custodian during the years ended June 30, 2024 and 2023, respectively. The Organization provides certain administrative services at no cost to the Plan.

**Note 5. Plan Amendments**

Effective July 1, 2022, the Plan was amended in accordance with pension-related provisions of the *Further Consolidated Appropriations Act of 2019* (FCAA) in general, and Division O of that Act, and the *Setting Every Community Up for Retirement Enhancement Act of 2019* (SECURE). It also addresses a provision of the *Bipartisan American Miners Act* (BAMA), which is also part of FCCA, as well as a section of the *Coronavirus Aid, Relief, and Economic Security Act* (CARES). The provisions of this amendment shall be interpreted and applied to be consistent with FCAA and CARES and IRS guidance issued in connection therewith, whether such guidance is issued before or after the date of the amendment.

**Note 6. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

**Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

**Note 8. Tax Status**

The Plan operates under an adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Alerus Financial, N.A. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

**Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 10. Subsequent Events**

On October 1, 2024, the Plan was restated. After restatement, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$1,000. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 1% above the prime rate, as defined. Principal and interest is paid ratably through monthly payroll deductions.

During 2024, ADP Retirement Services, a qualified institution, began to serve as the Plan's recordkeeper. During the Plan transition, there was a blackout period where participants were not able to change investments, obtain a loan from the Plan, or obtain a distribution from the Plan. The blackout period began on November 1, 2024 and ended on December 27, 2024.
