Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Murata Electronics North America, Inc. Employees' Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

Basis for Opinion

1. DESCRIPTION OF PLAN

General

The following description of the Murata Electronics North America, Inc. Employees' Retirement Savings Plan (the Plan) is a defined contribution employee benefit plan that provides for tax-deferred savings contributions from participants as well as matching and discretionary contributions from Murata Electronics North America, Inc. (the Company or Employer). All employees of the Company are eligible to participate, except employees subject to collective bargaining, nonresident alien employees, independent contractors, any employee of Murata Power Solutions, Inc. and individuals who work for a related employer, as defined, primarily outside of the United States and who are on a temporary work assignment with a related employer within the United States.

The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

Effective January 1, 2010, the SyChip, Inc. 401(k) Retirement Plan (SyChip Plan) was merged into the Plan. In addition, effective January 1, 2010, any employee of SyChip, Inc. who satisfies the eligibility requirements of the Plan are eligible to participate. Effective July 2, 2012, RF Monolithics, Inc. (RFM) merged as an affiliate of the Company and became a wholly owned subsidiary of the Company. Effective January 1, 2013, employees of RFM became participants in the Plan and all of the employees of SyChip, Inc. became employees of RFM. Effective August 1, 2013, RF Monolithics, Inc. 401(k) Savings Plan (RFM Plan) and VTI Technologies, Inc. 401(k) Plan (VTI Plan) both merged into the Plan. In July 2018, the Vios Medical, Inc. 401(k) Plan merged into the Plan. In addition, in November 2022, the Resonant Inc. 401(k) Plan was merged into the Plan.

Eligibility

Once eligible, employees can immediately participate in the savings features of the Plan. Employer matching contributions begin concurrently with employee contributions. Employees are eligible to receive a discretionary allocation upon completion of 1,000 hours of service in a Plan year. If an employee is employed by the Company and continues to receive benefit accruals under a retirement plan sponsored by an affiliate, these employees are not eligible to participate in the Plan.

Administration

The Plan is administered by the Retirement Committee. The members of the Retirement Committee are approved by the Board of Directors (the Board) of the Company. The duties of the Retirement Committee include interpretation of the Plan agreement, determination of benefits due to participants, and authorization of disbursements from the net assets available for benefits.

Trustee

Fidelity Management Trust Company (Fidelity) is the trustee for the Plan.

Contributions

Participants may elect to make contributions of 1% to 50% of their eligible earnings under the savings feature of the Plan, subject to the Internal Revenue Code (the IRC) limitations. The Company has adopted a safe harbor formula, whereby the Company matches 100% of each \$1 contributed up to 6% of each employee's annual compensation.

The Plan also includes a Roth 401(k) feature whereby participants may direct their contributions to accounts under pre-existing plan terms or the Roth 401(k) terms or both.

In addition, unless employees elect otherwise, they are automatically enrolled in the Plan and shall be deemed to enter into a salary reduction agreement in an amount equal to 6%. The auto enroll percentage will increase 1% per year capped at 12%.

This agreement will remain in effect until it is revoked by the participant or Plan administrator.

Participant Accounts

Individual accounts are maintained for each participant. Participants direct the investment of their contributions into various investment options offered by the Plan, which include an individual brokerage account that allows participant-directed investments in individual stocks and mutual funds. Each participant's account is credited with the participant's contribution, the Company's matching and discretionary contributions and Plan earnings, and charged with withdrawals and an allocation of Plan losses and administrative expenses. Investment income (loss) is allocated to participants based upon relative balances of the individual accounts at the prior valuation date. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$380 and \$6,276, respectively. There were approximately \$50,854 in forfeitures used in 2024 to reduce Company contributions.

Forfeitures are allocated among the accounts of participants as Employer safe harbor match or discretionary contributions.

Employer-Nonelective Discretionary Contribution

Subject to certain limitations, the Employer's discretionary contribution is allocated based on the annual wages of participants who complete at least 1,000 hours of service during the Plan year.

Vesting

A participant's interest in discretionary contributions to his or her account is 20% vested after 1,000 hours in one completed year of service, with subsequent vesting at 20% per 1,000-hour service year until fully vested. Each participant's interest in all other accounts is at all times fully vested and nonforfeitable. In order to preserve prior vesting schedules for former Plan participants, the following outlines the different vesting schedules for affected participants.

A former RFM Plan participant's vesting in his or her discretionary contributions to his or her account is 20% vested upon completion of one year of service, as defined, 50% after year two, 75% after year three and fully vested upon completion of year four. A former VTI Plan participant's vesting in his or her discretionary contributions to his or her account is 20% vested upon

completion of one year of service, as defined, 40% after year two and fully vested upon completion of year three. Former participants in the SyChip Plan are immediately vested in discretionary contributions to his or her account.

Notes Receivable from Participants

The Plan allows participants to borrow from their vested account amounts not to exceed the lesser of 50% of the participant's balance or \$50,000. The maximum term of such loans is five years, except for a loan for the purchase of a primary residence, which has a ten-year maximum term. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates at the time the funds are borrowed. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Generally, a participant's vested account balance is payable by lump-sum distribution, between ages 59½ and 70½, upon his or her retirement or disability. Upon termination of employment, the vested portion of the participant's account may be withdrawn in a lump sum or left in the Plan. If the vested amount is \$1,000 or less, a lump-sum distribution is required.

Plan Amendment or Reduction in Contributions

The Company reserves the right to amend any provisions of the Plan or reduce or discontinue contributions to the Plan; such amendment or change in Employer contributions, however, may not deprive any participant of his or her vested amounts. In the event of an amendment to the vesting schedule with respect to discretionary amounts, any active participant with at least three years of service may elect to remain under the pre-amendment vesting schedule.

Administrative Expenses

Expenses incurred in the reasonable administration of the Plan shall be paid from the Plan unless otherwise paid by the Employer. Effective August 2013, the Plan entered into a revenue sharing agreement with Fidelity. Under the terms of the revenue sharing agreement, Fidelity shall fund and allocate to eligible participants, as defined, the participant revenue credit calculated for each quarter. Participant revenue credits shall be allocated to Eligible Participant accounts as soon as administratively feasible (generally within 15 business days) after a quarterly recordkeeping invoice has been prepared and sent. For the year ended December 31, 2024, the participant revenue credits exceeded the Fidelity recordkeeping expenses, as such, there was a credit totaling approximately \$59,000. This amount is reflected as other income on the statement of changes in assets available for benefits for the year ended December 31, 2024.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates and Risks and Uncertainties

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the fully benefit-responsive guaranteed income fund, which is reported at contract value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 4.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

3. GUARANTEED INCOME FUND

The Plan invests in the Empower Guaranteed Income Fund which is a group annuity product issued by Empower Annuity Insurance Company (Empower), formerly Prudential Retirement Insurance and Annuity Company. Under the group annuity contract, participants may ordinarily permit withdrawals or transfers of all or a portion of their account balance at contract value. This contract is fully benefit-responsive; therefore, it is reported at contract value. The Plan owns a promise from Empower to pay interest at crediting rates which are guaranteed for a specified period of time, as outlined within the group annuity contract. The contract value of the investment is based upon contributions made to the fund, plus earnings at guaranteed crediting rates, less

participant withdrawals. Upon discontinuance of the contract, contract value would be paid no later than 90 days from the date the Company provides notice to discontinue.

When establishing interest crediting rates for this product, Empower considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account. These rates are established without the use of a specific formula. The minimum crediting rate under the contract is 1.50%.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or in certain rate-based circumstances, paid over time.

There are no events that allow the issuer to terminate the contract, and which require the Company to settle at an amount different than Contract Value paid either within 90 days or over time.

4. FAIR VALUE MEASUREMENT

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023.

Mutual funds and common stock (held in the self-directed account): Valued based on quoted market prices.

Common collective trust (CCT) fund: Valued at net asset value (NAV) provided by the fund's trustee as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments held by the respective fund less its liabilities. This practical expedient would not be used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

6. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Fidelity and units of the contract with Empower. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each fund. In addition, participant revenue credits totaling approximately \$59,000 is also a qualified party-in-interest transaction.

7. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company reserves the right to terminate the Plan. The Plan terminates if the Company is dissolved, adjudicated bankrupt or insolvent, or is merged with another company, except that any successor may elect to continue this Plan.

Upon termination of the Plan or permanent discontinuance of contributions to the Plan, all amounts credited to the accounts of the participants will become fully vested. After payment of all properly chargeable expenses, the Plan's assets are distributable to the participants in accordance with the value of their accounts.

8. TAX STATUS

The Company adopted a Fidelity-sponsored prototype plan. The underlying prototype plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the Plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualified status. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing jurisdictions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits of any tax periods in progress.

9. SUBSEQUENT EVENTS

Management has evaluated subsequent events through May 13, 2025 which is the date the financial statements were available to be issued, and has determined there are no subsequent events that require disclosure under FASB ASC Topic 855, *Subsequent Events*.
