Management has obtained certifications from the qualified institution as of December 13, 2024 and December 31, 2023, and for the period from January 1, 2024 to December 13, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Cogito Corporation, Inc. 401(K) Retirement Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Termination and Use of Liquidation Basis of Accounting

As further discussed in Note 1a of the financial statements, Cogito Corporation, Inc. (the Plan Sponsor) sold its assets to Verint Systems Inc. Cogito Corporation, Inc. voted to terminate Cogito Corporation, Inc. 401(K) Retirement Plan effective October 24, 2024. As a result, the plan changed its basis of accounting from the ongoing basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. All plan assets have been distributed as of December 13, 2024. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

1. DESCRIPTION OF PLAN

The following description of Cogito Corporation, Inc. 401(K) Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

a. General

The Plan was a defined contribution 401(k) plan covering all eligible employees of Cogito Corporation, Inc. (the Plan Sponsor). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator determined the appropriateness of the Plan's investment offerings and monitors investment performance.

During 2024, the Plan Sponsor sold its assets to Verint Systems Inc. As a part of the sale of its assets, the Plan Sponsor elected to terminate the plan as part of the evaluation of the retirement plan structure post sale to Verint Systems Inc. The Plan Sponsor instructed the third-party administrator to amend the Plan to provide for such termination and be liquidated in accordance with the terms and conditions of the Plan, including any rules or regulations promulgated by the Internal Revenue Service (IRS). Liquidation of the assets in the Plan occurred on December 13, 2024.

b. Eligibility

All employees were eligible to participate in the Plan and receive Plan Sponsor discretionary matching contributions immediately once they attained the age of 21, except for union employees and non-resident aliens. In order to receive the discretionary profit-sharing contributions, participants must have completed one year of service, completed 1,000 hours of service during the plan year, and have been employed on the last day of the plan year.

c. Contributions

Each year, prior to plan termination, participants could contribute up to 100% of pre-tax annual compensation, as defined in the Plan, up to the maximum allowed by the IRS. The Plan allowed for catch-up contributions for participants who had attained age fifty by the end of the plan year. The Plan allowed for participants to make post-tax (Roth) contributions. Participants may have also contributed amounts representing distributions from other qualified retirement plans (rollover contributions). Participants directed the investment of their contributions into various investment options offered by the Plan.

The Plan Sponsor made discretionary matching contributions not to exceed 2.5% of participant compensation or \$5,000, totaling \$189,776 during the 2024 plan year. The Plan Sponsor did not make a discretionary profit-sharing contribution for the year ended December 13, 2024.

d. Participant Accounts

Each participant's account was credited with the participant's contributions, allocations of the Plan Sponsor's contributions and plan earnings or losses and charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant's earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled to was the benefit that could have been provided from the participant's vested account.

e. Vesting

Participants were fully vested in their own contributions, rollover balances, and actual earnings thereon. Participants vested in the Plan Sponsor discretionary matching and profit-sharing contributions based on years of service as follows:

Less than 1 year	0%
1 year but less than 2 years	25%
2 years but less than 3 years	50%
3 years but less than 4 years	75%
4 years or more	100%

Participants became fully vested upon attainment of normal retirement age, death or disability. As a result of the Plan Sponsor approving to terminate the Plan, all participants became fully vested.

f. Notes Receivable from Participants

Participants may have borrowed from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000, or one-half of their vested account balance. Participants were only allowed one loan outstanding at any time. Loan terms ranged from one to five years, except for the purchase of a primary residence, which was to be no longer than fifteen years. The interest rate was a commercially reasonable rate of interest determined by the Plan Administrator. Principal and interest were paid ratably through payroll deductions. There were no outstanding notes receivable from participants as of December 13, 2024.

g. Payment of Benefits

Upon normal retirement at age 65, with no option for early retirement, or termination of services, a participant may have elected to receive a lump-sum equal to the value of the participant's vested account balance, partial withdrawals, or leave their balance in the Plan if the balance is over \$5,000. The Plan required balances up to \$1,000 be paid out to participants upon termination and required balances from \$1,000 to \$5,000 be rolled over to an individual retirement account (IRA). There were also retirement benefits available upon disability or death.

The Plan allowed in-service withdrawals upon attainment of age 59½. A participant may have also requested a withdrawal upon demonstration to the Plan Administrator that they were suffering a "hardship". Hardship is defined in applicable regulations promulgated or to be promulgated pursuant to the applicable section of the Internal Revenue Code (IRC) or standards established by the Secretary of the Treasury or their delegate. As a result of the plan termination, all participant accounts were distributed as of December 13, 2024.

h. Forfeitures

Forfeitures represented non-vested Plan Sponsor contributions forfeited by participants who terminated their employment or who withdrew from the Plan. The Plan had no unallocated forfeitures as of December 13, 2024. The Plan had \$16,390 of unallocated forfeitures as of December 31, 2023. Forfeitures were retained by the Plan and \$30,708 were used to reduce Plan Sponsor contributions and plan expenses during the period January 1, 2024 to December 13, 2024.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

The 2024 financial statements are presented on the liquidation basis of accounting, due to the Plan Sponsor voting to terminate the Plan, management determining liquidation was imminent, and the Plan's assets being fully distributed as of December 13, 2024 (see Note 1a). The 2023 financial statements are presented on the ongoing basis of accounting.

Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process and liabilities are measured using the accrual basis of accounting and would include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process. The difference between assets measured under the liquidation basis of accounting and fair value is immaterial to the financial statements, references to fair value are synonymous with liquidation basis.

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investments and Income Recognition

The Plan's mutual funds and common collective trust were reported at fair value. Mutual funds were stated at quoted market prices on public exchanges, which represented the net asset value (NAV) of shares held by the Plan. The Plan's interest in the common collective trust was stated at NAV based on information reported by the investment advisor using the audited financial statements of the collective trust at year-end. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determined the Plan's valuation utilizing information provided by the qualified institutions of the Plan. See Note 4 for disclosure of fair value measurement.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when incurred. No allowances for credit losses had been recorded as of December 13, 2024 and December 31, 2023. If a participant ceased to make loan repayments and the Plan Administrator deemed the participant loan to be in default, the participant loan balance was reduced, and a benefit payment was recorded.

Payment of Benefits

Benefits were recorded when paid.

Contributions

Contributions from plan participants and the discretionary matching contributions from the Plan Sponsor were recorded in the year in which the participant contributions were withheld from compensation. The Plan Sponsor's discretionary profit-sharing contribution was recorded when the contribution was authorized by the Plan Sponsor.

Administrative Expenses

Certain expenses of maintaining the Plan were paid directly by the Plan Sponsor and were excluded from these financial statements. Asset management and fees related to the administration of participant loans and processing of distributions were charged directly to the participant's account and were included in administrative expenses. Investment-related expenses were included in net appreciation of investments.

Subsequent Events

Subsequent events have been evaluated through May 8, 2025, which is the date the financial statements were available to be issued. There were no events that met the criteria for recognition or disclosure in the financial statements.

3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTION

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 13, 2024 and December 31, 2023, and the related investment transactions and investment income and interest income on notes receivable from participants reported in the accompanying statement of changes in net assets available for benefits for the period from January 1, 2024 to December 13, 2023.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements.

4. FAIR VALUE MEASUREMENT

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. *Fair Value Measurement* establishes a hierarchy of the valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs).

The fair value hierarchy is as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: Valued at the NAV of units of a collective trust. The NAV, as provided by the qualified institution, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. As of December 31, 2023, the Plan had no plans to sell the common collective trust at amounts different from NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

There have been no changes in the methodologies used at December 13, 2024 and December 31, 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

All plan assets were distributed as part of the Plan termination. Accordingly, there are no investments held as of December 13, 2024.

5. COMMON COLLECTIVE TRUST

The Plan's investment in the Common Collective Trust (CCT) was represented by the CCT's underlying investment in the Federated Hermes Capital Preservation Fund which invests in fully-benefit-responsive investment contracts, commonly referred to as guaranteed investment contracts (GICs), synthetic investment contracts, and similarly designed contracts issued by insurance companies, banks and other financial institutions. The Plan's investment in the CCT was not considered a fully-benefit-responsive investment contract and was reported at fair value (see Note 4).

6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, transactions with investment funds managed and held by the qualified institution and expenses paid to the Plan's third-party administrator out of Plan assets are considered party-in-interest transactions. During 2024, the Plan paid administrative expenses of \$48,523.

7. TAX STATUS

The Plan Sponsor has obtained an opinion letter dated June 30, 2020, in which the IRS stated that the restated prototype plan document was in compliance with applicable requirements of the IRC. The Plan Administrator timely adopted the restated prototype plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan was operated in accordance with the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant balances, and the amounts reported in the accompanying statements of net assets available for benefits.

9. PLAN TERMINATION

As discussed in Note 1a of the financial statements, the Plan was terminated during 2024. At the effective date of the termination, all participants were 100% vested. All assets of the Plan were distributed on or before December 13, 2024.
