### ***Basis for Opinion***

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



**NOTE 1 – DESCRIPTION OF PLAN**

Wilson Fire Equipment & Service Co., Inc. 401(k) Employee Savings Plan (the Plan) is a qualified retirement plan adopted by Wilson Fire Equipment and Service Company, Inc. (the Company) to provide employees with the opportunity to save for retirement on a tax-advantaged basis. The Plan was originally effective on July 1, 1978 and was amended effective January 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Significant provisions of the Plan in effect as of December 31, 2024 are summarized below. Participants should refer to the legal plan document for a more complete description of the Plan's provisions.

Eligibility: All non-excluded employees who have attained age 21 are eligible to participate in the Plan. The entry date will be the first day of the month coinciding with or next following the date an employee satisfies the eligibility requirements.

Contributions: Participants may elect to reduce their compensation by a specific percentage or dollar amount, up to 90% of their compensation each year, and have that amount contributed to the Plan on pre-tax basis as a salary deferral. Total deferrals may not exceed a dollar limit which is set by law. The Company has an automatic contribution arrangement which applies to all newly eligible employees entering the Plan and existing employees who previously did not make an affirmative election otherwise. Automatically enrolled employees have deferral contributions deducted from their eligible pay at a rate of 2%. Participants who are at least age 50 or will attain age 50 before the end of a calendar year may elect to defer additional amounts as catch-up contributions. Participants are permitted to revoke their salary deferral election at any time during the Plan year and may make any other modification on the first day of each month.

The Company may make a discretionary matching contribution equal to a uniform percentage of participants' salary deferrals. Prior to April 1, 2024, the Company made a matching contribution equal to 40% of a participant's salary deferrals, up to 6% of eligible compensation. Effective April 1, 2024, the Company made a matching contribution equal to 60% of a participant's salary deferrals, up to 6% of eligible compensation.

Participants are also permitted to deposit into the Plan distributions received from other retirement plans or certain IRAs as rollover contributions.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings and losses, and (c) forfeitures of matching contributions, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Vesting: Participants are always 100% vested in their salary deferrals including catch-up contributions, rollovers, and any earnings thereon. Company matching contributions are subject to a six-year graded vesting schedule in which participants earn 20% vesting each year after two years of service. Participants will become 100% vested in all of their accounts under the Plan upon death, disability, or normal retirement while still employed by the Company.

Payment of Benefits: Upon termination of employment, normal retirement, disability, or death, a participant may receive a distribution of the vested portion of their accounts in the Plan. If a participant's vested account balance does not exceed \$5,000, the Company will distribute their vested account balance in a single lump-sum payment. If a participant's vested account balance exceeds \$5,000, they may elect to receive a distribution in a single lump-sum payment, partial withdrawals, or installments.

**NOTE 1 – DESCRIPTION OF PLAN (Continued)**

Participants who have attained age 59½ may receive an in-service distribution from certain accounts. Hardship distributions may also be made to satisfy certain immediate and heavy financial needs that a participant may have.

Notes Receivable From Participants: Loans are available to participants on a reasonably equivalent basis. The minimum loan amount is \$1,000 and the maximum amount is the lesser of ½ of the participant's vested interest in the Plan, or \$50,000 reduced by the highest outstanding loan balance during the prior one-year period. Loans are adequately secured and charged a commercially reasonable rate of interest. The term of the loan may not exceed five years unless the loan is for the purchase of a principal residence.

Forfeited Accounts: If a participant terminates employment before being fully vested, then the non-vested portion of the terminated participant's account remains in the Plan and is called a forfeiture. Forfeitures may be used to pay administrative expenses and reduce any employer contribution. Forfeited non-vested accounts totaled \$68,722 and \$42,293 at December 31, 2024 and 2023, respectively.

Administrative Expenses: The Plan permits the payment of Plan expenses to be made from the Plan's assets. If expenses are paid using the Plan's assets, then the expenses will generally be allocated among the accounts of all participants in the Plan. There are certain other expenses that may be paid just from a participant's account. These are expenses that are specifically incurred by, or attributable to, a participant.

Plan Termination: Although the Company intends to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. Upon termination, no further contributions will be made to the Plan and all amounts credited to participants' accounts will become 100% vested.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through May 15, 2025, which is the date the financial statements were available to be issued.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments other than fully benefit responsive investment contracts are reported at fair value as further described in Notes 4 and 5. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES (Continued)**

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Benefits Paid to Participants: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit and the risks related to global events. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 3 – CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Talcott Resolution Life Insurance Company.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

**NOTE 4 – FAIR VALUE MEASUREMENTS (Continued)**

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Pooled Separate Accounts: The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund’s net asset value per unit.

\*Investments measured at fair value using net asset value per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the hierarchy tables for such investments are intended to permit reconciliation of the fair value hierarchy to the investments at fair value line item presented in the statement of net assets available for benefits.

**NOTE 5 – INVESTMENT CONTRACT WITH INSURANCE COMPANY**

During 2024 and 2023, the Plan held a fully benefit-responsive group annuity contract, the Fixed Account, with Talcott Resolution Life Insurance Company (“Talcott”, formerly named Hartford Life Insurance Company). The Fixed Account is a general account product of Talcott. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, and prevailing market conditions. The interest crediting rate is reset quarterly.

As described in Note 2, contract value is the relevant measurement attribute for this fund. The contract value of the group annuity contract was \$2,484,723 and \$2,583,120 at December 31, 2024 and 2023, respectively. The interest crediting rate is updated quarterly based upon contract provisions, and it may not be less than 3.00%.

Certain events limit the ability of the Plan to transact at contract value with Talcott. Such events include premature termination of the contracts by the Plan, layoffs, Plan termination, bankruptcy, mergers and early retirement incentives. The Plan does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable. There are no reserves against contract value for credit risk of Talcott or otherwise.

**NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under the Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan held an investment managed by Talcott. Talcott is a service provider to the Plan and, therefore, these transactions and the Plan's payment of fees to Talcott qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

**NOTE 7 – TAX STATUS**

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the non-standardized pre-approved profit sharing plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended from the original non-standardized pre-approved profit sharing plan document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
