The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Lamps Plus 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Lamps Plus 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2 and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule (modified cash basis), we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule (modified cash basis), other than the information in the supplemental schedule, that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA.
- the information in the supplemental schedule (modified cash basis) related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements (Modified Cash Basis)

Note 1 – Description of Plan

The following description of the Lamps Plus 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of plan provisions.

General – The Plan was established on June 1, 1998, and has been subsequently amended to comply with certain Internal Revenue Code (IRC) revisions. The Plan is a qualified defined contribution plan covering full-time regular employees of the Lamps Plus Group (the “”) who have at least one year of service and are at least 21 years of age. One thousand hours of service shall be required to constitute a year of eligibility. Fidelity Management Trust Company serves as the trustee of the Plan and Fidelity Investments Institutional Operations Company, Inc., serves as the record-keeper. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Effective September 1, 2024, the Plan’s eligibility service requirement was changed to three months of service and no minimum hours of service. Effective December 15, 2024, the Plan’s eligibility service requirement for employer matching contributions was changed to twelve months of service.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated fund until elected otherwise by the participant. Every participant who has a salary deferral election shall have that salary deferral automatically increase by 1% on their enrollment anniversary up to 6%.

Effective October 7, 2024, the automatic enrollment deferral rate was changed to 5% of eligible compensation.

Contributions – Each year, participants may contribute up to 20% of their pretax annual compensation, as defined in the Plan, subject to certain IRC limitations. The contributes 25% of the first 4% of base compensation that a participant contributes to the Plan. The may make additional discretionary contributions, which shall be allocated to each eligible employee in proportion to his or her compensation as a percentage of the compensation of all eligible employees. No such additional discretionary contributions were made during the year ended December 31, 2024. The Plan allows eligible participants to make catch-up contributions in accordance with and subject to the limitations of IRC Section 414(v). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Participant accounts – Individual accounts are maintained for each plan participant. Each participant’s account is credited with the participant’s contributions, the ’s matching and additional discretionary contributions, and allocations of plan earnings and losses. Participant accounts are charged with withdrawals and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investments – Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a money market fund, a commingled pooled fund, and various mutual funds as investment options for participants.

Vesting – Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the 's contributions is based on years of credited service. A participant is fully vested after three years of credited service, as follows:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than two years	0%
Two years	50%
Three or more years	100%

Vesting credit for employees of the is determined using the elapsed time method. Under the elapsed time method, hours of service are not counted and instead periods of service are computed. A period of service is determined based on the time a participant works for the . Only whole years of service are counted towards computing years of service for vesting purposes.

Notes receivable from participants – Participants may borrow from their fund accounts in increments of \$1,000, up to a maximum amount equal to the lesser of \$50,000 or 50% of the participant's vested account balance. The term of participant loans generally may not exceed five years, unless used for a home loan. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest that approximates the prime rate on the date of the loan as specified in *The Wall Street Journal*, plus 1%. Principal and interest are paid through payroll deductions. Upon termination of employment, the outstanding loan balance is deemed as a taxable distribution to the participant. As of December 31, 2024, participant loans have maturities through June 2032 at interest rates ranging from 4.25% to 9.50%. Loans in default as of December 31, 2024 and 2023, were \$207,133 and \$208,987, respectively.

Payment of benefits – A participant's vested plan benefits will be distributed at retirement, death, disability, or termination of employment. For termination due to retirement, death, or disability, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum. A participant may withdraw all or a portion of his or her contributions (plus earnings) and matching and discretionary contributions (plus earnings) for any reason after reaching age 59 ½ or prior to reaching age 59 ½ in the case of hardship (as described in the Plan Document).

Forfeited accounts – Forfeitures are the non-vested portion of a participant's account that is lost upon termination of employment. Forfeitures are retained in the Plan and will first be used to pay plan administrative expenses, with any remaining amount used to reduce future contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$57,350 and \$57,690, respectively. For the year ended December 31, 2024, \$33,483 of forfeitures were used to pay for administrative plan expenses.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The accompanying financial statements of the Plan have been prepared using a modified cash basis of accounting. Under the modified cash basis of accounting, contributions, distributions and expenses are recognized when received or paid rather than when earned.

Purchases and sales are recorded on the trade date. Interest income and dividends are recorded on a cash basis. Net appreciation in fair value of investments includes realized and unrealized gains and losses on investments sold or held during the year. See Note 3 for further information regarding the fair value measurement of the Plan's investments.

Use of estimates – The preparation of financial statements (modified cash basis) requires plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation – The Plan's investments are stated at fair value.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan Document.

Payment of benefits – Benefit payments to participants are recorded upon distribution. As of December 31, 2024 and 2023, there were no amounts allocated to accounts of persons who have elected to withdraw from the Plan but have not yet been paid.

Administrative expenses – Administrative expenses incurred by the Plan may be paid by the Plan Sponsor directly or from forfeited participant accounts or funds held as assets of the Plan at the discretion of the Plan's management.

Subsequent events – Subsequent events were evaluated through May 20, 2025, the date the financial statements (modified cash basis) were available to be issued.

Note 3 – Fair Value Measurements

Accounting Standards Codification (ASC) 820 provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices for identical assets and liabilities the Plan has the ability to access; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. For a description of the specific inputs and valuation techniques used to measure the fair value of the Fidelity Managed Income Portfolio, refer to Note 4.

Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Money market funds are managed to maintain a constant value of \$1 per share. Underlying investments are valued at amortized cost, which approximates fair value due to the short-term maturity of those investments. Shares of mutual funds are valued at quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year end. The commingled pooled fund is valued at the NAV of units of a bank collective trust. The NAV as provided by the trustee is used as a practical expedient to estimate fair value. The NAV of the commingled pooled fund is based on the fair value of the underlying investments held by the fund less its liabilities.

Management fees and operating expenses charged to the Plan for investments in the money market fund, mutual funds, and the commingled pooled fund are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Commingled Pooled Fund

The Fidelity Managed Income Portfolio (the “Fund”) is a commingled pooled fund sponsored by Fidelity Management Trust Company that invests in guaranteed investment contracts. The beneficial interest of each participant is represented by units. Units are issued and redeemed daily at the Fund’s constant NAV of \$1 per unit. Distribution to the Fund’s unit-holders is declared daily from the net investment income and automatically reinvested in the Fund on a monthly basis, when paid. It is the policy of the Fund to use its best efforts to maintain a stable NAV of \$1 per unit; although, there is no guarantee that the Fund will be able to maintain this value.

There are no restrictions within the Fund related to frequency or notice periods for redemptions out of the Fund; however, the Fund may take up to 12 months to fulfill a payout in the event that withdrawals are directed by the plan sponsor. Any transfers out of the Fund must be held in a noncompeting investment option for 90 days before subsequent transfers to a competing fund can occur.

Note 5 – Information Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends and interest, and interest income from notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year).

Note 6 – Party-in-Interest Transactions

Certain plan investments are shares of money market funds, mutual funds, and commingled pooled funds that are managed by Fidelity Investments Institutional Operations Company, Inc. Fidelity Investments Institutional Operations Company, Inc., is owned by the same party that owns Fidelity Management Trust Company, and therefore, these transactions qualify as exempt party-in-interest transactions. However, such transactions are exempt from the prohibited transaction rules of ERISA and the IRC. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right to discontinue its contributions at any time and terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

Note 8 – Tax Status

The Plan uses a volume submitter profit-sharing Plan Document sponsored by Fidelity Management & Research Co. Fidelity Management & Research Co. received an advisory letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the Plan satisfies the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements (modified cash basis).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize an income tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements (modified cash basis). The Plan is subject to routine audits by taxing jurisdictions.

Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statement of net assets available for benefits.
