### ***Opinion***

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Independent Auditors' Responsibilities for the Audit of the Financial Statements***

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Supplemental Schedule Required by ERISA***

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The December 31, 2024 supplemental schedule of assets (held at end of year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. DESCRIPTION OF THE PLAN

The following description of the *EXTOL, Inc. Employee Stock Ownership Plan* (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Company established the Plan effective as of January 1, 2019. The Plan operates as an employee stock ownership plan ("ESOP") and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended ("IRC"), and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan is a defined contribution plan covering substantially all employees of *EXTOL, Inc.* (the "Company" or "Plan Sponsor") who are age eighteen or older. Enrollment in the plan is limited to the first day of the Plan year subsequent to the date the employee attains age 18. Participants are eligible for Plan contributions and earnings upon entry into the Plan.

The Plan is governed and operated by the EXTOL, Inc. ESOP Committee and a Plan administrator, respectively, appointed by the Board of Directors of the Company.

#### **Contributions**

The Plan is funded by contributions of the Company, in cash or shares of the Company's common stock, in amounts determined by the Company's Board of Directors. Employee contributions are not permitted. Contributions are subject to certain Internal Revenue Service ("IRS") limitations. Participants are eligible for a share of the contribution or Plan Sponsor common stock allocated as a result of contributions if the participant is employed on the last day of the Plan year. Employer contributions are determined quarterly by Plan management based on a formula of 5% of earnings before interest, depreciation, taxes, and amortization, which is then allocated among all eligible participants.

#### **Participant Accounts and Forfeitures**

Each participant's account is credited with the Company's contributions (when made), and an allocation of Plan earnings and forfeitures of terminated participants' nonvested accounts and charged with an allocation of administrative expenses, if any. Only those participants who are eligible employees of the Company as of the last day of the Plan year receive the allocation of common stock and forfeitures. Company common stock and forfeitures are allocated in proportion to each participant's compensation compared with the total compensation of all participants. During 2024, cash and common stock from forfeited nonvested accounts reallocated to participants in the same manner as Company contributions amounted to \$516 in cash and 3.65 in shares. There were no forfeited nonvested accounts at December 31, 2024 and 2023. Plan investment income is distributed as of the last day of each Plan year and is allocated based on the ratio of each participant's account balance to total participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### *Vesting*

Vesting in the Company contributions is based on years of continuous service. A participant is 100% vested after five years of credited service, with gradual vesting beginning at 25% after two years of service, or when they reach the normal retirement date (65 years of age). Participants terminating from the Plan receive no allocation of employer contributions or forfeitures in the year they terminate from the Plan; however, they do receive an allocation of interest and other Plan income in accordance with normal Plan provisions.

### *Payment of Benefits*

Upon termination of service due to death, disability, retirement or any other distributive event, as defined in the Plan agreement, participants or their beneficiaries may receive an amount equal to the value of the participant's vested interest in their account in a lump sum or in various installment annuities.

### *Voting Rights*

Each participant is entitled to direct the trustee to exercise voting rights attributable to the shares of the common stock allocated to his or her account on issues involving mergers or consolidations, recapitalization, reclassification, liquidation, dissolution, sale of substantially all assets of the Company, or any other similar transaction that may be specified in regulations. If the participant fails to direct the trustee on any issue, the shares will be voted by the trustee. In accordance with instructions from the EXTOL, Inc. ESOP Committee, the trustee is required, to vote any unallocated shares on the behalf of the collective best interest of Plan participants and beneficiaries.

### *Put Option*

Under Federal income tax regulations, employer common stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its common stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of up to five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash for the value of their shares.

### *Diversification*

Diversification is offered to participants who have attained the age of 55 and have completed at least 10 years of participation in the Plan so that they may have the opportunity in the first 90 days of a Plan year to move part of the value of their investment in the Company's common stock into investments which are more diversified. In each of the first five years, a participant may diversify up to 25% of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution.

### *Administration of Plan Assets*

The Plan's assets, which consist principally of the Company's common stock, are held by the trustee of the Plan.

Company contributions are held and managed by the trustee, which invests cash received, interest, and dividend income and makes distributions to participants.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain administrative expenses are paid directly by the Company.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. The fair value of EXTOL, Inc. common stock is one such significant estimate. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

Investment in EXTOL, Inc. common stock is reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the recordkeeper. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. The net change in fair value includes the Plan's aggregate gains and losses on investments bought and sold as well as held during the year.

### *Contributions*

Employer contributions are recorded in the period in which they become the obligation of the Company.

### *Benefits Paid to Participants*

Benefit payments to participants are recorded when paid.

### *Administrative Expenses*

The Plan's administrative expenses are paid either by the Plan or the Company, as provided by the Plan agreement. Certain administrative expenses, including an allocation of salaries related to Plan administration, audit and legal costs, are paid by the Company. Expenses that are paid directly by the Company are excluded from these financial statements. Fees for certain recordkeeping are paid by the Plan. These expenses qualify as party-in-interest transactions which are exempt from prohibited transaction rules.

### *Subsequent Events*

In preparing these financial statements, Plan management has evaluated, for potential recognition or disclosure, significant events or transactions that occurred during the period subsequent to the most recent statement of net assets available for benefits presented herein, through the date these financial statements were available to be issued.

## 3. INVESTMENT

At the end of each Plan year, the Company hires an independent third party to value the Company common stock. The value of the stock as of December 31, 2024 was \$320.40 per share or \$1,464,228 (cost of \$980,983) for the 4,570 shares held by the Plan. The value of the common stock as of December 31, 2023 was \$368.36 per share or \$1,683,405 (cost of \$980,983) for the 4,570 shares held by the Plan. All shares held by the Plan have been allocated to the participants of the Plan. No shares of EXTOL, Inc. common stock were purchased by the Plan from the Plan Sponsor during 2024.

## 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of fair value hierarchy under Accounting Standards Codification 820 are described as follows:

Level 1: Input to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurements. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 or 2023.

*EXTOL, Inc. common stock:* The fair value of the EXTOL, Inc. common stock held by the Plan is valued at estimated fair value based upon an independent appraisal. This appraisal is based upon a combination of several different approaches for valuation of the common stock, specifically, income based and market based approaches. The appraiser considered historical and projected cash flow and net income, return on assets, return on equity, market comparable, cost of equity to debt, and estimated fair value of Company assets and liabilities. The valuation process involves Plan management's selection of an independent appraiser. Plan management accumulates the data for the appraiser from the reviewed financial statements of the Company. The appraiser prepares a preliminary report which Plan management reviews in detail, discusses and approves.

*Interest-bearing cash:* Valued at amortized cost, which approximates fair value.

*U.S. government securities:* Valued by using pricing models maximizing the use of observable inputs for similar securities.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the EXTOL, Inc. ESOP Committee believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. Plan management evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. There were no purchases, issuances, or transfers of assets into or out of Level 3 during the year ended December 31, 2024.

#### 5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest is defined under Department of Labor ("DOL") regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The Plan's investment in EXTOL, Inc. common stock represents a party-in-interest transaction. Refer to Note 3 for further disclosures related to the Company's common stock. The Plan was allocated cash dividends of the Company's common stock of \$58,432 during 2024.

Principal Trust Company ("Principal") is the recordkeeper of the Plan and therefore transactions with Principal qualify as party-in-interest transactions. Fees paid by the Plan to Principal for recordkeeping services amounted to \$365 in 2024.

#### 6. TAX STATUS

The Plan has received a favorable determination letter dated August 23, 2023 from the IRS, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan Administrator and the Plan's legal counsel believe that the Plan is designed in compliance with the applicable requirements of the IRC. Additionally, the Plan Administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. While the Plan may be subject to routine audits by taxing jurisdictions, there are currently no audits for any tax periods in progress.

### 7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan agreement and the IRC. Upon termination of the Plan, the Trustees will pay all liabilities and expenses of the trust fund.

### 8. RISKS AND ECONOMIC UNCERTAINTIES

The Plan invests in common stock of the Plan Sponsor, interest-bearing cash, and a U.S. government security. Investment securities are exposed to various risks, such as interest rate, market and credit risks as well as valuation assumptions based on earnings, cash flows, recent transactions, and other such techniques. Market risks include global events which could impact the value of the Plan's investment, such as a pandemic or international conflict. Due to the level of interest rate, market, and credit risks inherent with the Plan's investment, including uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the fair value of investment will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and changes in net assets available for benefits.
