## Independent Auditor's Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the Little John Transportation Services 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## **NOTE A – PLAN DESCRIPTION**

The following description of the Little John Transportation Services 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

### *GENERAL*

The Plan is a defined contribution 401(k) safe-harbor plan sponsored by Little John Transportation Services, Inc. with a plan year end of December 31st. The original Plan became effective January 1, 2010, with the most recent amendment of the Plan being effective January 1, 2024. This amendment updated language related to part time employees having the ability to join the Plan. The Plan covers substantially all employees of the Little John Transportation Services, Inc., Jack Kellerstrass Agency, Inc., and Kellerway Logistics, collectively hereto referred to as the “Company” and “Employer.”

The provisions of the Plan are included in the official Plan document, which legally governs the operations of the Plan and is available for more detailed information. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

### *ELIGIBILITY*

The Plan covers substantially all employees of the Company who are age 21 or older and have completed 12 consecutive months of service. In general, covered employees may enter the Plan immediately after satisfying the eligibility requirements.

### *PARTICIPANT AND COMPANY CONTRIBUTIONS*

Each year, participants may elect to contribute a percentage of their eligible compensation, up to 90 percent of their eligible wages, to the Plan in pre-tax or Roth contributions up to the maximum allowed under the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also rollover funds from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan incorporates a safe-harbor matching contribution of 100 percent of the first 3 percent and 50 percent on the next 2 percent that a participant contributes to the Plan. The matching contribution is invested as directed by the participant.

The Company may make a discretionary profit-sharing contribution to the Plan. Participants of the Plan must have worked at least 500 hours and be employed on the last day of the Plan year to be eligible for the discretionary profit-sharing contribution. Allocation of these contributions to participants will be made in accordance with the formula selected by the Company as defined in the Plan document. The discretionary profit-sharing contribution is invested as directed by the participant. For the plan years ended December 31, 2024 and 2023, there were no discretionary, profit-sharing contributions made to participant accounts. Contributions are subject to Internal Revenue Service (“IRS”) limitations.

### *PARTICIPANT ACCOUNTS*

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contributions, and (b) Plan earnings or losses, and is charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### NOTE A – PLAN DESCRIPTION – CONT.

#### *VESTING*

Participants are immediately vested in their elective (voluntary) contributions, safe harbor contributions, and any income or loss thereon. Vesting in the Company's discretionary profit-sharing contribution portions of their account, and any income or loss thereon, is based on years of continuous service as follows:

#### *FORFEITED ACCOUNTS*

On December 31, 2024 and 2023, there were \$0 forfeited non-vested accounts. Any forfeiture amounts can be used to pay plan expenses or to reduce future employer contributions. No forfeiture amounts were utilized during 2024.

#### *PAYMENT OF BENEFITS*

Distributions of benefits are defined in the Plan document. Generally, upon termination of employment, death, disability, or normal retirement, a participant (or designated beneficiary) may elect to receive 100% of his or her vested account balance in either a lump sum cash payment or a direct rollover to another qualified plan, or partial payouts. Participants who have attained age 59 1/2 may also withdraw all or a portion of their vested account balances. Required Minimum Distributions (RMDs) are required once the participant reaches age 73. Participants may also elect to receive a distribution from their deferral account balance and vested Employer account balances (beginning July 5, 2023) in the case of a financial hardship as outlined in the Plan document.

#### *NOTES RECEIVABLE FROM PARTICIPANTS*

The Plan provides that participants can borrow funds of at least \$1,000 up to a maximum equal to the lesser of 50 percent of their vested account balance, or \$50,000. The loans are secured by the balance in the participant's account and bear interest at prime plus 2 percent. The term of the loan cannot exceed five years, except if the loan proceeds are used to finance the purchase of a primary residence, in which case the loan term may not exceed 30 years. Principal and interest is paid ratably through payroll deductions. A participant may only have two loans outstanding at a time.

### NOTE B – SUMMARY OF ACCOUNTING POLICIES

#### *BASIS OF ACCOUNTING*

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

#### *USE OF ESTIMATES*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could vary from these estimates.

## **NOTE B – SUMMARY OF ACCOUNTING POLICIES – CONT.**

### *INVESTMENT VALUATION AND INCOME RECOGNITION*

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note D for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *PAYMENT OF BENEFITS*

Benefit payments to participants and their beneficiaries are recorded when paid.

### *OPERATING EXPENSES*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in the net appreciation of the fair value of the investments.

### *DATE OF MANAGEMENT REVIEW*

Subsequent events were evaluated through May 13, 2025, which is the date the financial statements were available to be issued. Management is not required to and has not evaluated events or transactions that occurred after May 13, 2025.

## **NOTE C – UNAUDITED INVESTMENT INFORMATION CERTIFIED BY TRUSTEE**

The Plan Administrator has elected the method of compliance permitted by 29 CFR Section 2520.103-8 of the Department of Labor Rules and Regulations and disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by the trustees, Empower Trust Company, LLC / Empower Annuity Insurance Company of America and was not subjected to any auditing procedures performed by the independent public accountants.

- a. All investments and notes receivable from participants shown in the accompanying statements of net assets available for benefits.
- b. Net investment income from the investments, as shown in the accompanying statement of changes in net assets available for benefits, including dividends and interest income and net realized and unrealized appreciation (depreciation) in the fair value of assets.

## NOTE D – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB (Financial Accounting Standards Board) ASC (Accounting Standards Codification) 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no transfers between levels in 2024 or 2023.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

**Mutual Funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan’s management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

### NOTE E – INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan entered into a traditional fully benefit-responsive investment contract with Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than the amount outlined in the contract. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date. The average interest rate for 2024 and 2023 was 1.41% and 1.23%, respectively.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

## **NOTE E – INVESTMENT CONTRACT WITH INSURANCE COMPANY – CONT.**

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include:

- 1) The Plan's failure to qualify under Section 401 of the Internal Revenue Code.
- 2) Premature termination of the contracts.
- 3) Plan termination or merger.
- 4) Changes to the Plan's prohibition on competing investment options.
- 5) Bankruptcy of the plan sponsor or other plan sponsor events that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants. In addition, certain events allow the issuer to terminate the contracts with the plan and settle at an amount different from contract value. Such events include the following:

- 1) An uncured violation of the Plan's investment guidelines.
- 2) A breach of material obligation under the contract,
- 3) A material misrepresentation.
- 4) A material amendment to the agreement without the consent of the issuer.

## **NOTE F – RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Empower Trust Company, LLC / Empower Annuity Insurance Company of America are the custodians of the Plan assets. Nova 401(k) Associates provide third party administrative services. Empower Retirement, LLC provides recordkeeping services. Stephens, Inc. provides investment advisory services to the Plan. Shawn Pooler, CPA is the Plan auditor. Therefore, these transactions qualify as party-in interest transactions.

Audit fees and certain other administrative expenses are rendered by parties in interest and are paid by the Company. The Company also provides certain administrative services for the Plan for which it receives no compensation.

## **NOTE G - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## **NOTE H – TAX STATUS**

The Plan, is a volume submitter 401(k) profit sharing plan sponsored by Nova 401(k) Associates, and received a favored opinion letter dated June 30, 2020, in which the Internal Revenue Service has stated that the Plan Document is acceptable under section 401 of the Internal Revenue Code and therefore not subject to tax.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

## **NOTE I – PLAN TERMINATION**

In the event of Plan termination, participants would become 100 percent vested in their employer contributions, if any.
