As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Also as described in Note 1, pursuant to the Plan's termination, the net assets of the Plan were fully distributed as of November 22, 2024. Our opinion is not modified with respect to these matters.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Also as described in Note 1, pursuant to the Plan's termination, the net assets of the Plan were fully distributed as of November 22, 2024. Our opinion is not modified with respect to these matters.

## ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.



**NOTE 1 – DESCRIPTION OF PLAN**

Catapult Energy Services Group, LLC (Catapult or the Company) established The Employee Retirement Plan (the Plan) effective January 1, 2014. The Plan is a 401(k) salary deferral and profit sharing plan covering substantially all employees of Catapult. The Plan was amended and restated effective June 1, 2022, to conform with new tax laws and regulations. The Plan is designed to encourage and assist eligible employees in adopting a regular savings program and to provide additional security for their retirement and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Significant provisions of the Plan are summarized below. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions.

Plan Transfer: During 2023, Catapult executed a transaction in which Kingswood Capital Management acquired Covenant Testing Technologies, LLC (Covenant). Under the conditions of the transaction, Covenant had to elect to no longer be a participating employer for the benefit of its eligible employees in the Plan. Plan assets relating to participants employed by Covenant were transferred out of the Plan to the SuccessWise Pooled Employer Plan in February 2024.

Plan Termination: Effective May 31, 2024 (Termination Date), the Company made the decision to terminate the Plan. As of the Termination Date:

- No further contributions were made to the Plan.
- All active participants became 100% vested in their account balances.

Due to the Company's decision to terminate the Plan during 2024, Plan management determined that liquidation was imminent. Accordingly, the financial statements for the period from January 1, 2024 to November 22, 2024, were prepared on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

To facilitate the distribution of Plan assets:

- Participants and beneficiaries were provided with distribution options in accordance with the Plan provisions.
- Lump-sum distributions and rollovers were processed based on participant elections.
- For participants who did not make an election, an individual retirement account (IRA) was established in their name, and their account balance was automatically transferred to that IRA per Department of Labor (DOL) safe harbor regulations (29 CFR § 2550.404a-3).
- All Plan assets were fully liquidated as of November 22, 2024.
- A final Form 5500 filing will be completed with the DOL to officially report the Plan's termination and final asset distributions.

Eligibility: Prior to the Termination Date, employees of the Company were eligible to participate in the Plan upon reaching the age 18. To be eligible for any employer profit sharing contribution, participants had to complete at least 1,000 hours of service during the Plan year and be employed as of the last day of the Plan year.

Contributions: Prior to the Termination Date, participants could contribute from 1% to 100% of their earnings in any combination of before-tax and after-tax Roth contributions. Participants could separately specify the contribution percentages that applied to non-bonus earnings and to their bonus. In addition, participants who had attained age 50 as of the last day of the calendar year were eligible to contribute additional before-tax or Roth contributions during such year that could exceed normal Plan limits.

Prior to the Termination Date, the Company could make a matching contribution on participants' behalf in an amount and allocation formula as determined by the Company. The Company could also make a non-elective contribution (known as a profit sharing contribution) to the Plan on participants' behalf, as long as they met the eligibility requirements. The Company did not make any profit sharing contributions to the Plan for 2024.

Rollover contributions from qualified retirement plans and certain IRAs were also permitted by the Plan. All contributions were subject to certain limitations of the Internal Revenue Code (IRC).

Participant Accounts: Each participant's account was credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings and losses, and (c) forfeitures of employer profit sharing contributions and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations were based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account. Each participant directed the investment of his or her account to any of the investment options available under the Plan

Retirement, Death and Disability: A participant was entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Participants were fully vested in their elective deferral account, rollover contribution account, and matching contributions. Prior to the Termination Date, participants would vest in the Company's profit sharing contributions based on years of service. Participants became fully vested in Company profit sharing contributions after six years of service.

Payment of Benefits: On termination of service due to death, disability, or retirement, a participant could elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account. For termination of service for other reasons, a participant could receive the value of the vested interest in their account as a lump-sum distribution. If a participant died, their beneficiary received the distribution of the participant's account.

Notes Receivable from Participants: Participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance, or \$50,000 reduced by the highest outstanding loan balance in the last 12 months. The loans were secured by the balance in the participant's account. The loan interest rate was fixed and was the prime rate for the month in which a participant requested the loan plus 1%. Principal and interest were paid ratably through after-tax payroll deductions within a period of at least 12 months, but no more than 60 months, unless the loan was to be used to acquire a principal residence. If a participant terminated employment with the Company, he or she could continue to make loan payments through a pre-authorized check agreement. If the loan was not repaid, it would automatically be treated as a distribution to the participant.

Forfeitures: Forfeitures were the nonvested portion of a participant's account that was lost upon termination of employment. Forfeitures were retained in the Plan and could be used to restore forfeitures, reduce Company contributions, or pay Plan expenses. As of November 22, 2024 and December 31, 2023, there were no forfeited nonvested accounts.

Administrative Expenses: Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation in fair value of investments.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through May 5, 2025, which is the date the financial statements were available to be issued.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting: Due to Catapult terminating the Plan effective May 31, 2024; it was determined by Plan management that liquidation was imminent and therefore, the financial statements were prepared on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP) for the period from January 1, 2024 to November 22, 2024. The adoption of the liquidation basis of accounting did not have a material effect on the financial statements. For the year ended December 31, 2023, the financial statements of the Plan were prepared on the accrual basis of accounting in accordance with GAAP.

Estimates: The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein. Actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments were reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants were reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes were collateralized by the participants' account balances. Related fees were recorded as administrative expenses and were expensed when they were incurred.

Payment of Benefits: Benefits were recorded when paid.

Risks and Uncertainties: The Plan held various investments. Investments were exposed to various risks such as interest rate, market, liquidity, credit and risks related to global events. Due to the level of risk associated with certain investments, it was at least reasonably possible that changes in the fair values of investments would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets in liquidation as of November 22, 2024 and statement of net assets available for benefits as of December 31, 2023 (ongoing).

**NOTE 3 – CERTIFIED INFORMATION**

Although the Plan has been amended from the original non-standardized pre-approved plan document, Plan management believes that the Plan was currently being operated in accordance with the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of November 22, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 1 – DESCRIPTION OF PLAN**

Catapult Energy Services Group, LLC (Catapult or the Company) established The Employee Retirement Plan (the Plan) effective January 1, 2014. The Plan is a 401(k) salary deferral and profit sharing plan covering substantially all employees of Catapult. The Plan was amended and restated effective June 1, 2022, to conform with new tax laws and regulations. The Plan is designed to encourage and assist eligible employees in adopting a regular savings program and to provide additional security for their retirement and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Significant provisions of the Plan are summarized below. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions.

Plan Transfer: During 2023, Catapult executed a transaction in which Kingswood Capital Management acquired Covenant Testing Technologies, LLC (Covenant). Under the conditions of the transaction, Covenant had to elect to no longer be a participating employer for the benefit of its eligible employees in the Plan. Plan assets relating to participants employed by Covenant were transferred out of the Plan to the SuccessWise Pooled Employer Plan in February 2024.

Plan Termination: Effective May 31, 2024 (Termination Date), the Company made the decision to terminate the Plan. As of the Termination Date:

- No further contributions were made to the Plan.
- All active participants became 100% vested in their account balances.

Due to the Company's decision to terminate the Plan during 2024, Plan management determined that liquidation was imminent. Accordingly, the financial statements for the period from January 1, 2024 to November 22, 2024, were prepared on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

To facilitate the distribution of Plan assets:

- Participants and beneficiaries were provided with distribution options in accordance with the Plan provisions.
- Lump-sum distributions and rollovers were processed based on participant elections.
- For participants who did not make an election, an individual retirement account (IRA) was established in their name, and their account balance was automatically transferred to that IRA per Department of Labor (DOL) safe harbor regulations (29 CFR § 2550.404a-3).
- All Plan assets were fully liquidated as of November 22, 2024.
- A final Form 5500 filing will be completed with the DOL to officially report the Plan's termination and final asset distributions.

Eligibility: Prior to the Termination Date, employees of the Company were eligible to participate in the Plan upon reaching the age 18. To be eligible for any employer profit sharing contribution, participants had to complete at least 1,000 hours of service during the Plan year and be employed as of the last day of the Plan year.

Contributions: Prior to the Termination Date, participants could contribute from 1% to 100% of their earnings in any combination of before-tax and after-tax Roth contributions. Participants could separately specify the contribution percentages that applied to non-bonus earnings and to their bonus. In addition, participants who had attained age 50 as of the last day of the calendar year were eligible to contribute additional before-tax or Roth contributions during such year that could exceed normal Plan limits.

Prior to the Termination Date, the Company could make a matching contribution on participants' behalf in an amount and allocation formula as determined by the Company. The Company could also make a non-elective contribution (known as a profit sharing contribution) to the Plan on participants' behalf, as long as they met the eligibility requirements. The Company did not make any profit sharing contributions to the Plan for 2024.

Rollover contributions from qualified retirement plans and certain IRAs were also permitted by the Plan. All contributions were subject to certain limitations of the Internal Revenue Code (IRC).

Participant Accounts: Each participant's account was credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings and losses, and (c) forfeitures of employer profit sharing contributions and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations were based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account. Each participant directed the investment of his or her account to any of the investment options available under the Plan

Retirement, Death and Disability: A participant was entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Participants were fully vested in their elective deferral account, rollover contribution account, and matching contributions. Prior to the Termination Date, participants would vest in the Company's profit sharing contributions based on years of service. Participants became fully vested in Company profit sharing contributions after six years of service.

Payment of Benefits: On termination of service due to death, disability, or retirement, a participant could elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account. For termination of service for other reasons, a participant could receive the value of the vested interest in their account as a lump-sum distribution. If a participant died, their beneficiary received the distribution of the participant's account.

Notes Receivable from Participants: Participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance, or \$50,000 reduced by the highest outstanding loan balance in the last 12 months. The loans were secured by the balance in the participant's account. The loan interest rate was fixed and was the prime rate for the month in which a participant requested the loan plus 1%. Principal and interest were paid ratably through after-tax payroll deductions within a period of at least 12 months, but no more than 60 months, unless the loan was to be used to acquire a principal residence. If a participant terminated employment with the Company, he or she could continue to make loan payments through a pre-authorized check agreement. If the loan was not repaid, it would automatically be treated as a distribution to the participant.

Forfeitures: Forfeitures were the nonvested portion of a participant's account that was lost upon termination of employment. Forfeitures were retained in the Plan and could be used to restore forfeitures, reduce Company contributions, or pay Plan expenses. As of November 22, 2024 and December 31, 2023, there were no forfeited nonvested accounts.

Administrative Expenses: Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation in fair value of investments.
