This letter serves as a reasonable cause explanation to the IRS as to why Sam Levitz Furniture Company (the "Company") is not able to prepare and file its audit report associated with our 401(k) plan's Form 5500 for the year-ended December 31, 2024.

Unfortunately, the Company is facing significant financial challenges that have led us to initiate a liquidation and closure of the business and all operations after 71 years.

Background on Financial Distress:

Over the past two years, we have encountered severe financial difficulties due to declining sales, increased competition, and an economic downturn mostly tied to the depressed resale housing market driven by increased interest rates. The Company took action, selling two stores and closing another, but it was not enough to save the business. These challenges have forced us to prioritize immediate financial obligations with a focus on the payment of final payrolls and costs to effectuate the business closure. Such actions have made compliance with the 401(k) audit requirements not possible.

Given these circumstances, we respectfully request your understanding regarding the delay or absence of the audit report. We have always filed timely with audits when applicable, but due to our current situation, we kindly ask that the DOL and/or IRS accept our filing without the required audit under reasonable cause, as we are closing our doors before year-end.

We recognize the importance of these audits and assure you that it was never our intention to neglect our responsibilities. We are committed to resolving these issues and request that any penalties or enforcement actions be mitigated in light of the circumstances outlined above.
