**1. Description of Plan**

The following description of the Far Hills Country Day School Defined Contribution Retirement Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the plan provisions.

***General***

The Far Hills Country Day School Defined Contribution Retirement Plan was initially effective September 1, 1969 and has subsequently been restated. The Plan covers substantially all eligible employees of the Far Hills Country Day Hill (the “School” or “Employer”) as defined in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Full-time employees may enter the Plan upon employment with the School. To be eligible for Employer contributions an employee must complete 1,000 hours of service in a Plan year. Employees who normally work less than 20 hours per week, student employees, employees who are hired for a specific purpose for a limited period of less than one year and who are not subject to a contract, music conservatory teacher, substitute teachers, maternity leave replacements, nursing substitutes and leased employees are not eligible for the Plan.

***Contributions***

Participants may make tax-deferred or Roth contributions to the Plan after their date of eligibility, subject to the limitations of the Internal Revenue Code (“IRC”). Participants age 50 or older or who attain age 50 during the Plan year may make a “catch-up” contribution as defined by the IRC. Participants may also contribute amounts representing distributions from other qualified plans.

The Plan allows for discretionary matching contributions. Each year the Employer will determine the discretionary matching contribution. For the 2024 Plan year, the Employer contributed a matching contribution of 4% of eligible compensation.

The School may also make a discretionary non-elective contribution. For Plan year 2024, no discretionary matching contributions were made to the Plan. Contributions are subject to certain Internal Revenue Service limitations.

***Vesting***

A participant is 100% vested in their contributions including allocated earnings thereon at all times. Employees hired prior to January 1, 2019 are immediately vested in the School’s matching contributions. For employees hired on or after January 1, 2019, vesting in the School’s matching contribution portion of their accounts, plus actual earnings thereon are fully vested after three years of service.

***Participant Accounts***

Each participant’s account is credited with the participant’s contribution, the School’s contribution, and Plan earnings (losses), and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific transactions, as defined. All investments of the Plan are participant directed.

**1. Description of Plan (continued)**

***Payment of Benefits***

Upon termination of service due to death, disability, retirement, age 59 1/2, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account in either a lump sum distribution or annuity. Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

***Loans to Participants/Collateralized Assets***

Loans with Teachers Insurance and Annuity Association of America ("TIAA") and College Retirement Equities Fund ("CREF") are issued directly from funds owned by TIAA and CREF and not directly from a participant's account. Interest and principal are paid by the participant directly to TIAA and CREF. The loans are not considered assets of the Plan and, therefore, are not reported in the statements of net assets available for benefits. Adequate security is required and a portion of the participant's account is reserved, or held as collateral, to cover 110% of the outstanding loan in case of default. The collateral for the loan is maintained as part of the participant's TIAA Traditional Annuity account. The collateral securing the loan continues to earn interest. The collateralized balance is not available for transfer, withdrawal, retirement income benefits or survivor benefits. No new loans of this type are available for participants for issuance.

The loan interest rate for these loans may be fixed or variable and the initial rate is determined by the terms of the controlling contract, as are the rate adjustment details and frequency. Principal repayments are transferred to the investment options chosen under the terms of the Plan.

At December 31, 2024 and 2023, there were 0 and 2 collateralized loans outstanding with total principal balances due of \$0 and \$51,426 which also represents a collateralization of participant accounts. At December 31, 2023, interest rates on loans outstanding ranged from 4.27% to 5.05%.

***Notes Receivable from Participants***

The Plan offers a loan feature whereby a participant (borrower) enrolled in the Plan may borrow a minimum amount of \$1,000 up to a maximum amount of 50% of their vested account balance or \$50,000 (whichever is less). Participants may take a loan once in any 12 consecutive-month period, subject to the IRC limits on the total amount that can be borrowed. Participants may not have more than two outstanding loans at a time. The interest rate is based on the prime rate plus 1%. Loans must be repaid within five years, unless the loan is used to purchase a participant's principal residence or the participant is on authorized leave for military service for a period which extends the maturity date of the loan beyond five years.

***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$27 and \$712. These accounts will be used to reduce future Employer contributions. During 2024, forfeitures of \$13,326 were used to reduce Employer contributions.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accounts of the Plan are maintained, and the accompanying financial statements have been prepared, on the modified cash basis, which is a basis of accounting other than accounting principles generally accepted in the United States of America (“U.S. GAAP”). Under this basis, investment income is recognized when received and disbursements are recognized when made, except for investments which are reflected at fair value. Accordingly, the financial statements are not intended to be presented in conformity with U.S. GAAP.

***Use of Estimates***

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make certain estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the Net Asset Value (“NAV”) per share as a practical expedient are not categorized within the fair value hierarchy.

***Investment Valuation and Income Recognition***

The TIAA Traditional Annuity Account is an unallocated contract. The fully benefit responsive contracts are carried at contract value and the non-benefit responsive contracts are carried at fair value, which approximate their contract value. Contract value equals the accumulated cash contributions, interest credited to the Plan’s contracts, and transfers in (if any), less any withdrawals and transfers out (if any). The contract value, which is derived from a discounted cash flow analysis and other factors approximates fair value. Investments in registered investment companies are stated at fair value as determined by quoted market prices, which represents the net asset value of shares held by the Plan at year end. The pooled separate account is valued at the NAV of units held by the Plan. The NAV, as provided by TIAA and CREF, is used as a practical expedient to estimate fair value. The NAV based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Purchase and sales of securities are recorded on a trade-date basis. Interest and dividends are recorded when received. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

**2. Summary of Significant Accounting Policies (*continued*)**

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. Until a distributable event occurs, the loan will continue to have a balance.

***Payment of Benefits***

Benefits are recorded when paid.

***Expenses***

Certain expenses of maintaining the Plan are paid directly by the School and are excluded from these financial statements. Investment related expenses are included in net appreciation in value of investments.

***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is May 20, 2025.

**3. Information Certified (Unaudited)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements (modified cash basis) and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) (modified cash basis) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and CREF and TIAA Trust, N.A., qualified institutions.

TIAA and CREF has been authorized by TIAA Trust, N.A., to certify the investments and investment information for which TIAA Trust, N.A. is the directed trustee and custodian.

***TIAA Traditional Annuity Account***

The TIAA Traditional Annuity is comprised of six types of contracts. The fully benefit responsive contracts are: the Group Supplemental Retirement Annuity, the Supplemental Retirement Annuity, and the Retirement Choice Plus (“RCP”) contracts. The non benefit responsive contracts are: the Group Retirement Annuity, Retirement Annuity (“RA”) and Retirement Choice (“RC”) contracts. The Plan utilizes the RCP contracts, which are reported at contract value, and the RA and RC contracts, which are reported at fair value. Contract value equals the accumulated cash contributions, interest credited to the Plan’s contracts, and transfers in (if any), less any withdrawals and transfers out (if any). Contract value approximates a discounted cash flow value calculated using a risk-adjusted market discount rate which correlates closely with the TIAA Traditional Annuity’s historical crediting rates. Unobservable inputs include the risk-adjusted discount rate applied and the range of significant input values are as follows: RCP – 4.75%-5.00%; RA – 4.75%-6.00%; and RC – 5.00%-6.25%

Under RCP contracts, lump sum withdrawals and transfers are allowed at any time without any surrender charges. Certain RCP contracts impose a 90-day equity wash rule. Under RA contracts, lump sum withdrawals are not permitted and all withdrawals and transfers must be paid in 10 annual installments. Under RC contracts, lump sum withdrawals are available only within 120 days after termination of employment and are subject to a 2.5% surrender charge. All other withdrawals and transfers must be paid in 84 monthly installments.

The contracts use the vintage method to credit interest to the TIAA Traditional Annuity Account. Vintages are time periods that represent when money was initially invested in the TIAA Traditional Annuity Account and corresponding interest rate during that distinct time period. The Vintage method recognizes the fact that the level of prevailing interest rates available on new long-term investments will vary over time and that as the long-term investments in a specific vintage mature, they will be reinvested at different rates. When funds flow into the TIAA Traditional Annuity Account, they are immediately invested at the prevailing pay-in rate for new money. The funds earn interest at the prevailing vintage rates. The vintage will always consist of two parts: the guaranteed portion and the discretionary portion. The guaranteed portion represents the minimum amount of interest that will be credited to an account, regardless of the economic environment. The discretionary portion represents interest earned over and above the guaranteed rate.

The TIAA Traditional Annuity represents approximately 32% and 33% of the Plan’s net assets available for benefits as of December 31, 2024 and 2023, and represents an obligation from TIAA to repay as amounts come due. The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: Moody’s Investors Service (Aa1 as of October 2024), Standard and Poor’s (AA+ as of May 2024), A.M. Best (A++ as of July 2024), and Fitch (AAA as of August 2024). The plan administrator does not believe that any events would limit the Plan’s ability to transact at contract value.

***TIAA Real Estate***

The TIAA Real Estate Account generally invests in real estate properties and real estate-related investments. The TIAA Real Estate Account's value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion. The TIAA Real Estate Account sometimes holds securities as well. These are generally priced using values obtained from independent pricing sources. While redemptions from the TIAA Real Estate Account may occur daily, transfers out are limited to one per calendar quarter. There are no unfunded commitments on the Plan's investments.

**5. Plan Termination**

Although it has not expressed any intent to do so, the School has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the School contributions.

**6. Tax Status**

The School has adopted a restated prototype plan document effective December 1, 2023 which is intended to satisfy the Internal Revenue Service's final 403(b) regulations. The prototype plan document preparer received an opinion letter dated March 31, 2017 from the Internal Revenue Service. Although the Plan has been amended, the School believes that the Plan is designed and currently being operated in accordance with applicable sections of the Internal Revenue Code.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

**7. Party-In-Interest Transactions**

Certain investments of the Plan are managed by TIAA, the record-keeper and a custodian, and CREF, a custodian. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

The Plan and TIAA and CREF entered into a revenue sharing arrangement whereby a portion of the revenue earned from certain funds is passed through to the Plan for payment of permitted plan expenses. In order for the Plan to receive credits as a result of this revenue sharing arrangement, and to use this credit to pay plan expenses, the Plan created the Revenue Credit Account under the Plan. The Revenue Credit Account is a cash account within the Plan, similar in design to forfeiture accounts, and is used to record the redistribution of plan-generated fund revenue that exceeds the costs associated with plan administration. The Revenue Credit Account balance was \$39 and \$2,082 at December 31, 2024 and 2023. In 2024 and 2023, the Plan received servicing credits of \$58,099 and \$17,728. During 2024, \$38,813 of these funds were used to pay Plan expenses and \$21,850 was allocated to participants from the Revenue Credit Account.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements.
