## Notes to Financial Statements

### March 31, 2022 and December 31, 2021

#### **Note 1: Description of the Plan**

The following description of ams Sensors 401K Savings Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan sponsored by ams Sensors USA Inc. for the benefit of its employees. Related employers who also participate in the Plan include Princeton Optronics Inc. and RF Digital Corporation. All participating entities are collectively, the Company. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity Management Trust Company (Fidelity) is the trustee of the Plan.

Effective March 31, 2022, the Company elected to merge the Plan and transfer the assets and participants into the ams OSRAM Savings Plan. All balances in the Plan became 100 percent vested.

#### **Contributions**

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 90% of their eligible compensation. Employees may also defer from 1% to 100% of any bonus compensation by special election. The total combined amount of the bonus and regular deferrals may not exceed 90% of eligible compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Company may contribute discretionary contributions (both matching and nonelective) to participants. For the period ended March 31, 2022 and the year December 31, 2021, the Company made contributions of 100% of employee deferrals up to \$4,000 in the amount of \$198,488 and \$855,152, respectively. Contributions are subject to certain limitations.

#### **Participant Investment Account Options**

Investment account options available include various funds. Each participant has the option of directing their contributions into any of the separate investment accounts and may change the allocation daily.

The plan document also includes an automatic deferral feature whereby a participant is treated as electing to defer 3% of eligible compensation unless the participant made an affirmative election otherwise.

### **March 31, 2022 and December 31, 2021**

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's discretionary contributions and plan earnings and losses, and is charged with an allocation of administrative expenses. Allocations are based upon participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Vesting***

Participants are immediately fully vested in their voluntary contributions plus earnings thereon. Participants become fully vested in their Company's discretionary matching contributions upon completion of one year of service. A participant becomes vested 20% per year of service starting with year two for the Company's discretionary nonelective contributions and becomes fully vested after six years of service. The nonvested balance is forfeited upon termination of service.

#### ***Forfeited Accounts***

At March 31, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$57,917, respectively. Forfeitures may be used to reduce the Company's future contributions. No employer contributions were paid using forfeitures during the period ended March 31, 2022 or the year ended December 31, 2021.

#### ***Notes Receivable from Participants***

The plan document includes provisions authorizing loans to eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. Participant loans are limited to a minimum of \$1,000 up to a maximum of \$50,000 or 50% of the participant's vested account balance and are secured by the balance in the participant's account. The loans bear interest at a rate based on local prevailing rates as determined by the plan administrator. Principal and interest are repaid ratably through payroll deductions over a period not to exceed five years (except for loans for the purchase of a principal residence).

#### ***Payment of Benefits***

Upon termination of service, retirement or permanent disability, participants may elect to receive a lump-sum payment equal to the value of their vested account balance. Participants who have reached the age of 59½ may withdraw some or all of their vested account balance. Participants who are active employees can request a hardship withdrawal up to their vested account balance, subject to certain conditions and restrictions.

**Note 2: Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared using the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. The investment held in the common collective trust is valued at NAV value per share utilizing the practical expedient at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net (depreciation) appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefit payments to participants are recorded when paid.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion. Participants only pay fees associated with their individual loan administration, if applicable.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans may be reclassified as distributions based upon the terms of the plan document.

**Note 3: Certification of Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule are complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of March 31, 2022 and December 31, 2021.
- Investment (loss) income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the period ended March 31, 2022 and the year ended December 31, 2021.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4: Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities.

If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

**Note 5: Related Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan invests in certain funds of the Plan trustee. The Company provides certain administrative services at no cost to the Plan.

Certain plan investments are shares of mutual funds managed by Fidelity, who is the trustee as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in net (depreciation) appreciation in fair value of investments.

During the period ended March 31, 2022 and the year ended December 31, 2021, the Plan paid consulting fees of \$7,500 and \$30,000, respectively, to MCF Advisors, LLC. The Plan also paid record-keeper fees to Fidelity Investments Institutional totaling \$15,855 and \$51,905 during the period ended March 31, 2022 and the year ended December 31, 2021, respectively.

**Note 7: Transfer of Plan Assets**

On March 31, 2022, the Plan was merged into the ams OSRAM Savings Plan and all net assets were distributed out of the Plan and into the ams OSRAM Savings Plan. An aggregate of \$39,013,438 was transferred out of the Plan on April 1, 2022 and is included as a transfer on the statements of changes in net assets available for benefits.

**Note 8: Tax Status**

The Plan operates under a standardized adoption agreement in connection with a prototype volume submitter plan and trust document sponsored by Fidelity Management & Research Company. This prototype plan document has been filed with the appropriate agency and has obtained a determination letter from the Internal Revenue Service stating that the prototype constitutes a qualified plan under Section 401 of the Internal Revenue Code and that the related trust was tax-exempt as of the financial statement date.

**Note 9: Nonexempt Transactions**

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. While the Company remitted all employee contributions to the Plan, contributions of \$139,103 and loan payments of \$6,605 were not remitted within the required time period during the year ended December 31, 2020.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

**Note 11: Subsequent Events**

Subsequent events have been evaluated through January 13, 2022, which is the date the financial statements were available to be issued.

## Notes to Financial Statements

### March 31, 2022 and December 31, 2021

#### **Note 1: Description of the Plan**

The following description of ams Sensors 401K Savings Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan sponsored by ams Sensors USA Inc. for the benefit of its employees. Related employers who also participate in the Plan include Princeton Optronics Inc. and RF Digital Corporation. All participating entities are collectively, the Company. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity Management Trust Company (Fidelity) is the trustee of the Plan.

Effective March 31, 2022, the Company elected to merge the Plan and transfer the assets and participants into the ams OSRAM Savings Plan. All balances in the Plan became 100 percent vested.

#### **Contributions**

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 90% of their eligible compensation. Employees may also defer from 1% to 100% of any bonus compensation by special election. The total combined amount of the bonus and regular deferrals may not exceed 90% of eligible compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Company may contribute discretionary contributions (both matching and nonelective) to participants. For the period ended March 31, 2022 and the year December 31, 2021, the Company made contributions of 100% of employee deferrals up to \$4,000 in the amount of \$198,488 and \$855,152, respectively. Contributions are subject to certain limitations.

#### **Participant Investment Account Options**

Investment account options available include various funds. Each participant has the option of directing their contributions into any of the separate investment accounts and may change the allocation daily.

The plan document also includes an automatic deferral feature whereby a participant is treated as electing to defer 3% of eligible compensation unless the participant made an affirmative election otherwise.

### **March 31, 2022 and December 31, 2021**

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's discretionary contributions and plan earnings and losses, and is charged with an allocation of administrative expenses. Allocations are based upon participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Vesting***

Participants are immediately fully vested in their voluntary contributions plus earnings thereon. Participants become fully vested in their Company's discretionary matching contributions upon completion of one year of service. A participant becomes vested 20% per year of service starting with year two for the Company's discretionary nonelective contributions and becomes fully vested after six years of service. The nonvested balance is forfeited upon termination of service.

#### ***Forfeited Accounts***

At March 31, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$57,917, respectively. Forfeitures may be used to reduce the Company's future contributions. No employer contributions were paid using forfeitures during the period ended March 31, 2022 or the year ended December 31, 2021.

#### ***Notes Receivable from Participants***

The plan document includes provisions authorizing loans to eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. Participant loans are limited to a minimum of \$1,000 up to a maximum of \$50,000 or 50% of the participant's vested account balance and are secured by the balance in the participant's account. The loans bear interest at a rate based on local prevailing rates as determined by the plan administrator. Principal and interest are repaid ratably through payroll deductions over a period not to exceed five years (except for loans for the purchase of a principal residence).

#### ***Payment of Benefits***

Upon termination of service, retirement or permanent disability, participants may elect to receive a lump-sum payment equal to the value of their vested account balance. Participants who have reached the age of 59½ may withdraw some or all of their vested account balance. Participants who are active employees can request a hardship withdrawal up to their vested account balance, subject to certain conditions and restrictions.

**Note 2: Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared using the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. The investment held in the common collective trust is valued at NAV value per share utilizing the practical expedient at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net (depreciation) appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefit payments to participants are recorded when paid.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion. Participants only pay fees associated with their individual loan administration, if applicable.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans may be reclassified as distributions based upon the terms of the plan document.

**Note 3: Certification of Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule are complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of March 31, 2022 and December 31, 2021.
- Investment (loss) income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the period ended March 31, 2022 and the year ended December 31, 2021.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4: Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities.

Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

**Note 5: Related Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan invests in certain funds of the Plan trustee. The Company provides certain administrative services at no cost to the Plan.

Certain plan investments are shares of mutual funds managed by Fidelity, who is the trustee as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in net (depreciation) appreciation in fair value of investments.

During the period ended March 31, 2022 and the year ended December 31, 2021, the Plan paid consulting fees of \$7,500 and \$30,000, respectively, to MCF Advisors, LLC. The Plan also paid record-keeper fees to Fidelity Investments Institutional totaling \$15,855 and \$51,905 during the period ended March 31, 2022 and the year ended December 31, 2021, respectively.

**Note 7: Transfer of Plan Assets**

On March 31, 2022, the Plan was merged into the ams OSRAM Savings Plan and all net assets were distributed out of the Plan and into the ams OSRAM Savings Plan. An aggregate of \$39,013,438 was transferred out of the Plan on April 1, 2022 and is included as a transfer on the statements of changes in net assets available for benefits.

**Note 8: Tax Status**

The Plan operates under a standardized adoption agreement in connection with a prototype volume submitter plan and trust document sponsored by Fidelity Management & Research Company. This prototype plan document has been filed with the appropriate agency and has obtained a determination letter from the Internal Revenue Service stating that the prototype constitutes a qualified plan under Section 401 of the Internal Revenue Code and that the related trust was tax-exempt as of the financial statement date.

**Note 9: Nonexempt Transactions**

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. While the Company remitted all employee contributions to the Plan, contributions of \$139,103 and loan payments of \$6,605 were not remitted within the required time period during the year ended December 31, 2020.
