Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of AAFCPAs, Inc. 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4i - schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of the Plan

The following brief description of the AAFCPAs, Inc. 401(k) Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan is a defined contribution plan and was originally adopted by AAFCPAs, Inc. (the Company) effective November 10, 1985. The Plan was subsequently amended on January 1, 2023, where the Plan became a Safe Harbor QACA Plan effective January 1, 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The trustees of the Plan are responsible for oversight of the Plan and determine the appropriateness of the Plan's investment offerings and monitor investment performance.

Eligibility

The Plan covers all employees, including employees of AAFCPAs Wealth Management, LLC, a related employer, except for employees covered by a collective bargaining agreement, leased employees, nonresident aliens and temporary employees, who have completed one month of service and are at least 21 years of age. Enrollment in the Plan is allowed immediately after the eligibility requirements have been met.

Contributions

- (a) Participants may contribute a percentage up to 85% of annual compensation, subject to annual Internal Revenue Service (IRS) limitations. Contributions may be on a pre-tax basis, an after-tax basis (Roth deferral contributions) or a combination of the two. All employees who are eligible to make salary deferrals under this Plan and who are age 50 or older before the close of the Plan year, are eligible to make catch-up contributions, subject to IRS limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).
- (b) 401(k) Safe harbor matching contributions will be computed based on eligible compensation deferred into the Plan each Plan year. The Company makes a matching contribution equal to 100% of the first 1% and 50% of the next 5% of the participants' salary deferrals. The Company will limit this matching contribution for amounts in excess of the first 6.0% of compensation as elective contributions. The contribution period for purposes of calculating the amount this type of contribution is each Plan year (true-up provision).
- (c) The Company may make a discretionary nonelective contribution to the Plan each year. To be eligible to receive an allocation of the discretionary nonelective contributions participants must complete 1,000 hours of service during the Plan year. There were no discretionary nonelective contributions for the year ended December 31, 2024.
- (d) Qualified matching contributions may be designated by the Company to use all or a portion of any matching contributions (other than safe harbor matching contributions) to help the Plan pass one or more annually required Internal Revenue Code (IRC) nondiscrimination testing.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at a deferral rate for participants of 6%, with no additional annual increases unless the participant requests either to increase or decrease the percentage or if they affirmatively elect not to participate in the Plan. Participant contributions are invested in a designated balanced fund until changed by the participant.

Notes to Financial Statements

1. Description of the Plan (cont.)

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of any Company discretionary contributions and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and qualified matching contributions and actual earnings thereon. Company matching and discretionary nonelective contributions, if any, and actual earnings thereon become vested based on the following schedule:

Payment of Benefits

The Plan provides for a normal retirement benefit to be paid to participants who have reached the age of 65. Upon termination of service, a participant receives a lump-sum amount equal to the vested value of his or her account. Participants may also receive distributions in installments. There are also retirement benefits available upon late retirement, disability and death. If the vested benefit is \$1,000 or less, a lump sum distribution may be made without consent. Account balances greater than \$1,000, but less than \$5,000, are distributed as a lump-sum payment or rolled over to an individual retirement plan, unless otherwise directed by the participant.

The Plan allows in-service withdrawals upon attainment of age 59½. A participant may also request a withdrawal, subject to a \$500 minimum, upon demonstration to the Plan administrator that they are suffering a "hardship". Hardship is defined in applicable regulations promulgated or to be promulgated pursuant to Section 401(k) of the IRC or standards established by the Secretary of the Treasury or his delegate. Only employee deferral contributions, including both pre-tax and Roth contributions, are available for hardship distributions.

1. Description of the Plan (cont.)

Notes Receivable from Participants

All actively employed participants may borrow up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance and are limited to one loan at a time. The minimum loan allowed is \$1,000. The loans are secured by the balance in the participant's account. Interest is due on the outstanding principal balance at the prime rate published by the Wall Street Journal plus 1%. The loans bear interest at rates ranging from 4.25% to 9.50%, payable at various maturity dates through 2032. Principal and interest are paid ratably through bi-weekly payroll deductions.

Forfeitures

Forfeitures from non-vested participants' accounts can be used to pay Plan administrative expenses, reduce employer matching contributions, and/or then shall be allocated among the accounts of eligible participants otherwise eligible to receive an allocation of non-elective employer contributions (eligible participants). Forfeited accounts totaled \$103,929 and \$70,092 as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, forfeited funds in the amount of \$68,761 were used to offset Company contributions. Forfeitures in the amount of \$111,618 were used to fund the 2024 Company safe harbor match true-up in February 2025.

Revenue Sharing

The Plan received revenue credits from the funds managed by Fidelity Management Trust Company. The revenue credit account can be used to pay Plan expenses or can be allocated to eligible Plan participants as defined in the agreement. During the year ended December 31, 2024, \$19,172 of funds were used to pay Plan expenses and none were reallocated to Plan participants. The revenue sharing account totaled \$23,449 and \$9,324 as of December 31, 2024 and 2023, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan were prepared using the accrual basis of accounting. The Plan follows accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income (Loss) Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

2. Summary of Significant Accounting Policies (cont.)

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and processing of distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

3. Information Prepared and Certified by the Plan's Qualified Institution

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Fidelity Management Trust Company (Fidelity) held the Plan's investment assets, notes receivables to participants and executed investment transactions as of December 31, 2024 and 2023, and for the year ended December 31, 2024. Accordingly, Fidelity has provided a certification that the financial information included in the financial statements and supplemental schedule as of December 31, 2024 and 2023, and for the year ended December 31, 2024, as provided to the Plan, is complete and accurate. The information as to investment assets, notes receivable and transactions therein, and investment income included in the accompanying financial statements and supplemental schedule as of December 31, 2024 and 2023, and for the year ended December 31, 2024, is covered by such certification.

The Plan's independent certified public accountants did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedule.

4. Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs in which little or no market data exists (Level 3 measurements) The three levels of the fair value hierarchy under ASC 820 are described below:

Notes to Financial Statements

4. Fair Value Measurements (cont.)*Basis of Fair Value Measurements*

Level 1 – Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 – Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3 – Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds and Self-Directed Brokerage Accounts - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Self-directed brokerage accounts primarily consist of mutual funds that are valued on the basis of readily determinable market prices.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Plan is based on the Fidelity Non-Standardized Pre-Approved Profit Sharing Plan with CODA (pre-approved plan) which received an opinion letter from the IRS dated June 30, 2020, that stated the pre-approved plan constituted a qualified plan under the Code. Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code, and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their company contributions.

7. Related Party and Party-In-Interest Transactions

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, notes receivable to participants and transactions with investment funds managed and held by Fidelity Investments, which is related to Fidelity, are also defined by ERISA as party-in-interest transactions. Such transactions are exempt from the prohibited transaction rules.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

9. Subsequent Events

The Plan has evaluated subsequent events through April 28, 2025, which is the date the financial statements were available to be issued and has determined that no significant events occurred after December 31, 2024, but prior to issuance of these financial statements, that would have a material impact on its financial statements.
