## Independent Auditor's Report

To the Trustee and Participants of  
Nielsen & Bainbridge, LLC Retirement Savings Plan

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of Nielsen & Bainbridge, LLC Retirement Savings Plan (the "Plan") an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of February 27, 2024 and December 31, 2023 (in liquidation), and the related statement of changes in net assets available for benefits for the period from January 1, 2024 to February 27, 2024 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of February 27, 2024 and December 31, 2023, and for the period from January 1, 2024 to February 27, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter – Plan Termination and Use of Liquidation Basis of Accounting***

As discussed in Note 1 of the financial statements, the plan sponsor filed for Chapter 11 bankruptcy petition in the United States Bankruptcy Court for the Southern District of Texas on February 8, 2023. The termination of the plan occurred in October 2023 and assets of participant accounts were fully distributed as of February 27, 2024. As a result, the Plan has changed its basis of accounting from going concern basis to liquidation basis of accounting, starting with the 2023 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### 1. **Plan Termination and Description of the Plan Prior to Plan Termination**

The following description of the Nielsen & Bainbridge, LLC Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***Plan Termination***

On February 8, 2023, Nielsen & Bainbridge, LLC (the “Company” or “Plan Sponsor”) filed a Chapter 11 bankruptcy petition in the United States Bankruptcy Court for the Southern District of Texas. When the Plan Sponsor emerged from bankruptcy in July 2023, Bradley Scher of Ocean Ridge Capital Advisors, LLC, was appointed solely as Bankruptcy Plan Administrator of the Plan. Following the termination of employment of all participants in the Plan, the Plan was terminated in October 2023 and assets of participant accounts were fully distributed by the end of February 2024.

#### ***General and Eligibility***

The Plan was a defined contribution plan that covers certain employees of the Company upon completion of 90 days of service. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Certain administrative functions were performed by officers and employees of the Company. The assets of the Plan were held in a trust by Principal Life Insurance Company (“Trustee”), who also served as the Plan's record-keeper.

#### ***Contributions***

Participants were able to elect to contribute up to 100% of eligible compensation to the Plan, however, this was limited to the maximum contribution permitted by the Internal Revenue Service (“IRS”), which was \$23,000 for 2024. Participants who have attained age 50 before the end of the Plan year were eligible to make catch-up contributions. The catch-up provision was \$7,500 for 2024. Participants were also able to contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company contributed 100% of the first 3% of participant contributed compensation and 50% of the next 2% of participant contributed compensation, as defined in the Plan. Contributions were subject to certain limitations.

#### ***Investment Options***

Upon enrollment in the Plan, a participant was able to direct all contributions to selected investments, as made available and determined by the Plan Administrator, in 1% increments. Participants were able to change their investment options daily. All investments varied in type, rates of return and investment risk, as more fully described in the Plan document.

#### ***Participant Accounts***

Each participant's account was credited with the participant's contributions, rollovers, and allocations of Company's contributions and the Plan's earnings or losses. The Plan's earnings or losses were allocated based upon each participant's account balance. Certain fees were charged to the fund investments and were offset against the Plan's investment income and loss as presented on the statement of changes in net assets available for benefits. Participants should refer to the prospectuses of these funds for details on the various types and amounts of investment fees charged to the Plan and their individual accounts.

#### *Vesting*

Participants were immediately vested in their voluntary and Company contributions plus actual earnings thereon.

#### *Notes Receivable from Participants*

Participants were able to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms ranged up to five years or over a reasonable period of time for the purchase of a participant's primary residence, as established by the Plan Administrator at the time of the loan. The loans were collateralized by the balance in the participant's account and carried an interest at a rate commensurate with local prevailing rates, as determined quarterly by the Plan Administrator. There were no loans outstanding at December 31, 2024. Loans outstanding at December 31, 2023 had interest rates ranging from 5.25% to 7.00% respectively. Principal and interest were paid ratably through payroll deductions. Upon distribution, the unpaid balance was applied against the participant investment balance to satisfy the note receivable.

#### *Payment of Benefits*

On termination of service, a participant was able to elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. Any balance under \$1,000 was automatically paid out as soon as administratively possible. In-service withdrawals were permitted for certain financial hardships, as defined, or when a participant attained age 59½, subject to certain limitations.

### 2. Summary of Significant Accounting Policies

#### *Basis of Accounting*

As a result of the decision to terminate the Plan, the Plan changed its basis of accounting from the accrual basis to the liquidation basis in the Plan's 2023 financial statements. Under the liquidation basis of accounting, assets and liabilities are stated at their estimated net realizable value and estimated costs through the liquidation period and are provided to the extent reasonably determinable. There were no material changes to the financial statements as a result of the change under the liquidation of accounting. The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America. Prior to the termination, the financial statements of the Plan were prepared using the accrual basis of accounting.

#### *Use of Estimates*

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be recognized to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for disclosure of the fair value measurements.

#### *Investment Valuation and Income Recognition (Continued)*

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### *Payment of Benefits*

Benefits are recorded when paid.

#### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable that are charged directly to the participant's account and certain recordkeeping fees paid by the Plan. Investment-related expenses are included as an offset to net appreciation in fair value of investments.

### 3. Information Certified by the Trustee

The Plan Sponsor has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Accordingly, the Plan Sponsor has obtained certification from the Trustee that the following information included in the Plan's financial statements is complete and accurate:

- Investments and notes receivable from participants as of February 27, 2024 and December 31, 2023
- Investment income and investment transactions for the period from January 1, 2024 to February 27, 2024

### 4. Fair Value Measurements

Fair value is defined as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance.

The Plan maximizes the use of observable inputs and minimizes the use of unobservable inputs when measuring fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the following fair value measurement.

- Level 1: The fair value is based on quoted market value of the shares held by the plan at year end
- Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at February 27, 2024 and December 31, 2023:

- *Mutual funds* were valued at the daily closing price, as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Pooled separate accounts* were valued at the net asset value (NAV) of shares held by the Plan. The NAV, as provided by the trustees, was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient was not used when it was determined to be probable that the fund would sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) were able to occur daily. When the Plan was terminated, management initiated a full redemption of the pooled separate accounts, the investment adviser reserved the right to temporarily delay withdrawal from the fund in order to ensure that securities liquidations were carried out in an orderly business manner.
- *Stable value fund* was valued at the NAV of units of a bank's stable value fund. The NAV, as provided by the trustees, was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient was not used when it was determined to be probable that the fund would sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) were able to occur daily. When the Plan was terminated, management initiated a full redemption of the stable value fund, the investment adviser reserved the right to temporarily delay withdrawal from the fund in order to ensure that securities liquidations were carried out in an orderly business manner.

As a result of the plan termination, as of February 27, 2024, no investments were held by the Plan as the distribution of assets was fully completed.

Participants were not allowed to transfer back into these categories until the 30-day period expired. New contributions were allowed during this time period.

### 5. Party-in-Interest Transactions

The Plan allowed participants to borrow from their vested balances. Part of the Plan's investments were offered by the Plan's recordkeeper and Trustee. These transactions qualified as party-in-interest transactions. All of these transactions were exempt from the prohibited transaction rules under ERISA.

### 6. Tax Status

The Plan used a prototype plan document sponsored by the Trustee, who received an opinion letter from the IRS dated June 30, 2020, which stated that the prototype document satisfied the applicable provisions of the IRS. The Plan itself had not received a determination letter from the IRS. Although the plan had been amended since receiving the opinion letter, the Plan's administrator believed that the Plan was designed and operated in compliance with the applicable requirements of the IRS. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability or (asset) if the plan takes a position that is more likely than not to be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

### 7. Risks and Uncertainties

The Plan provided for various investment securities. Investment securities were exposed to various risks, such as interest rate, market fluctuations, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

### 8. Subsequent Events

The Plan evaluated subsequent events until March 27, 2025, the date the financial statements were available to be issued. No events have occurred subsequent to February 27, 2024 requiring recording or disclosure in these financial statements.
