INDEPENDENT AUDITOR'S REPORT

To the Independent Fiduciary/Trustee of the

Opinion

We have audited the financial statements of the Retirement Fund of the Fur Manufacturing Industry (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits (in liquidation) as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits (in liquidation) for the years then ended, and the related notes to the financial statements.

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1. DESCRIPTION OF PLAN

The following brief description of the Retirement Fund of the Fur Manufacturing Industry (the Plan) is provided for general information purposes only. Participants should refer to the Summary Plan Description for more complete information.

The Plan was established on February 7, 1950 pursuant to collective bargaining agreements with contributing employers under an Agreement and Declaration of Trust. It has been restated several times to comply with the requirements of law. The Plan is a multiemployer defined benefit pension plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. As discussed in Note 3, the employers' obligation to continue to contribute under the collective bargaining agreements ceased for periods after December 31, 1984. As of February 1, 1991, the Plan began receiving quarterly contributions from the Pension Benefit Guarantee Corporation (PBGC).

As of December 31, 1984, the Plan was frozen. Benefits earned prior to that date are payable to pensioners and survivors currently eligible to receive benefits and to vested participants who will be eligible to receive a benefit upon reaching retirement age. The Plan provides for normal retirement benefits at age 65, early retirement at age 62 and disability benefits to eligible participants who became disabled prior to December 31, 1984. Pre-retirement, post-retirement joint and survivor death benefit are also paid. Generally, twenty five (25) years of service will be required for vesting for normal retirement and at least 25 for other types of retirement options. The pension amount varies depending on units of pension credit and the benefit rates per unit. Reference should be made to the summary plan description for specific details as to vesting, benefits and eligibility.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting - The financial statements are prepared using the liquidation basis of accounting. PBGC contributions are accounted for as exchange transactions.

Payment of Benefits - Benefit payments to participants are recorded upon distribution.

Actuarial Present Value of Accumulated Plan Benefits - Accumulated plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to the service which employees have earned through the date of termination. Accumulated plan benefits include benefits expected to be paid to (a) participants and beneficiaries receiving benefits and (b) terminated vested participants and beneficiaries with rights to future benefits.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

NOTE 3. TERMINATION

On December 31, 1984, the Plan was terminated by mass withdrawal as defined by ERISA Section 4041A (a)(2). The Trustees have exercised their right to terminate the Plan. Termination shall not permit any part of the Plan assets to be used for, or diverted to, purposes other than the exclusive benefit of the pensioners, beneficiaries and participants. The net assets of the Plan will be allocated to pay benefits in priorities as prescribed by ERISA and its related regulations. Whether or not a particular participant will receive full benefits at some future time will depend on the sufficiency of the Plan's net assets at the time and the priority of those benefits.

In addition, certain benefits under the Plan are insured by the Pension Benefit Guaranty Corporation (PBGC). Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. The PBGC does not guarantee all types of benefits and the amount of any individual participant's benefit protection is subject to certain limitations. Some benefits may be fully or partially provided for while other benefits may not be provided at all.

Effective February 1, 1991, the Plan began receiving quarterly contributions from the PBGC so that the Plan could continue to operate and pay benefits. Based on the present PBGC regulations, the Plan expects each participant's pension benefits to be guaranteed by the PBGC.

NOTE 4. TAX STATUS

The Plan obtained a favorable tax determination letter from the Internal Revenue Service that stated the Plan, as then designed, was in compliance with the applicable requirements under Section 401(a) and was, therefore, exempt from Federal income taxes under the provisions of Section 501(a). The Plan Trustees believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe the Plan and related trust was exempt as of December 31, 2024.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the U.S. Federal, state, or local taxing authorities.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Typically, Plan tax years will remain open for three years; however, this may differ depending upon the circumstances of the Plan.

NOTE 5. ACTUARIAL INFORMATION

An actuarial valuation of the Plan was made by the consulting actuary as of December 31, 2021. Information shown in the report included the following:

The Plan's present value of accumulated plan benefits as of December 31, 2021 totaled \$1,652,933. The net assets available for benefits as of the same date amounted to \$62,318. The value of non-forfeitable benefits exceeds the value of Plan assets by \$1,590,615 at December 31, 2021.

The actuarial valuation was made using actuarial assumptions determined in accordance with the Pension Benefit Guaranty Corporation (PBGC) regulations for valuing plan benefits for a terminated multiemployer plan. For the valuation at December 31, 2021, the interest rate used was 2.40% for the first 20 years and 2.11% thereafter. For the valuation at December 31, 2016, the interest rate used was 1.98% for the first 25 years and 2.67% thereafter. The mortality table used for healthy lives is the UP-94 Mortality Table with projected improvement to 2031 at Scale AA (with projected improvement to 2026 at Scale AA for the valuation at December 31, 2016).

The Plan became insolvent in January 1991 and began receiving financial assistance from the PBGC effective February 1, 1991. Per PBGC ruling, the next actuarial valuation to be performed will be the year ending December 31, 2026.

NOTE 5. ACTUARIAL INFORMATION (continued)

At December 31, 1984 (date of termination), any participant retiring on or after February 1, 1983 with 25 years of service had a monthly benefit of \$158.08, which was gradually increased per year until it reached a maximum of \$190 per month for 30 or more years of service. No benefits are accrued after December 31, 1984. Since the Plan became insolvent in January 1991 the monthly benefit is limited to the PBGC maximum guaranteed benefit.

NOTE 6. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through May 20, 2025, the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant account accounting standards.
